## FISCAL ANALYSIS

### ASSUMPTION

Officials from the **Department of Economic Development** and **St. Louis County** assume there will be no impact to their respective agencies.

Officials from the **Metropolitan St. Louis Sewer District (MSD)** assume this proposal will prohibit MSD from assessing a fee, charge, or tax for storm water management services unless a person's property line is within fifty feet of a pipe, improved waterway, or an improved surface that conveys stormwater to a sewer maintained by MSD. This change to MSD's stormwater rate structure will necessitate immediate programming costs, bill processing costs and manual property review totaling \$122,068 in FY 2010 and an on-going cost of \$483,308 for FY 2011 through FY 2014, resulting in \$605,377 in total additional costs.

The estimated revenue losses to MSD for the fiscal years 2011-2014 equals \$1,441,700. The recovery of this revenue will be shifted to ratepayers unaffected by this proposed legislation. The estimated total financial impact to MDS is \$2,047,076.

**Oversight** assumes this proposal as written is providing clarifying language of properties that would be affected. Oversight assumes no state or local fiscal impact.

The proposed legislation appears to have no fiscal impact.


This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
