#### FISCAL ANALYSIS

#### **ASSUMPTION**

Officials from the Office of State Courts Administrator, Department of Insurance, Financial Institutions, and Professional Registration, and Department of Health and Senior Services assume the proposal will have no fiscal impact on their organizations.

Officials from the **Office of Attorney General (AGO)** state the proposal grants the AGO two new powers: to issue cease and desist orders along with the Division of Finance, and to file enforcement actions in circuit court. The AGO assumes that there is a potential for a small increase in caseload, and therefore, requests 0.5 FTE Assistant Attorney General I and 0.5 FTE Investigator. The AGO estimates FY 11 expenses of \$66,516; FY 12 expenses of \$80,561; and FY 13 expenses of \$82,975.

**Oversight** assumes the AGO would not hire two part-time individuals, but would instead assign the additional duties to existing staff. If, in the future, the AGO's caseload increases sufficiently to warrant hiring personnel, additional funding could be requested through the appropriations process.

The proposal would directly impact small business payday loan lenders that may have already established locations on the premises of a nursing home property, residential care facility, assisted living facility, intermediate care facility, or skilled nursing facility.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
