FISCAL ANALYSIS

ASSUMPTION

The **Joint Committee on Public Employee Retirement (JCPER)** has reviewed this proposal and has determined an actuarial study is not needed under the provisions of section 105.660, subdivision (5).

Officials from the **Kansas City Police Retirement System** assume all of these changes are expected to have a positive financial impact on the System's funding as they either result in less money being paid out of or more money coming into the System, there is no way to estimate the cost savings in a traditional cost study. The valuation process and the assumptions used are not specific and detailed with respect to these factors. Therefore, if these changes are enacting into law, they will not change any of the assumptions or methods used in the current actuarial valuation process. As a result, the cost savings cannot be quantified by the traditional actuarial methodologies.

The initial fiscal impact of this proposal is \$0.

No direct fiscal impact to small businesses would be expected as a result of this proposal.


FISCAL DESCRIPTION
