AN ACT

To amend chapter 42, RSMo, by adding thereto four new sections relating to the Gulf War medallion program.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Chapter 42, RSMo, is amended by adding thereto four new sections, to be
2 known as sections 42.230, 42.232, 42.234, and 42.236, to read as follows:

**42.230. 1. There is hereby created within the state adjutant general's office the
2 "Gulf War Medallion Program". Every veteran who honorably served on active duty in
3 the United States military service at any time beginning August 2, 1990, and ending
4 November 30, 1995, shall be entitled to receive a Gulf War medallion, medal, and a
5 certificate of appreciation under sections 42.230 to 42.236, provided that:**

**6 (1) Such veteran is a legal resident of this state or was a legal resident of this state
7 at the time he or she entered or was discharged from military service or at the time of his
8 or her death; and**

**9 (2) Such veteran was honorably separated or discharged from military service or
10 is still in active service in an honorable status, or was in active service in an honorable
11 status at the time of his or her death.**

**12 2. The Gulf War medallion, medal, and a certificate shall be awarded regardless
13 of whether or not such veteran served within the United States or in a foreign country. The
14 medallion, medal, and the certificate shall be awarded regardless of whether or not such
15 veteran was under eighteen years of age at the time of enlistment. For purposes of sections**

16 42.230 to 42.236, "veteran" means any person defined as a veteran by the United States
17 Department of Veterans' Affairs or its successor agency.

42.232. 1. Except as otherwise provided in sections 42.230 to 42.236, the adjutant
2 general of the state of Missouri shall administer the provisions of sections 42.230 to 42.236,
3 and may adopt all rules and regulations necessary to administer the provisions of sections
4 42.230 to 42.236. Any rule or portion of a rule, as that term is defined in section 536.010,
5 that is created under the authority delegated in sections 42.230 to 42.236 shall become
6 effective only if it complies with and is subject to all of the provisions of chapter 536 and,
7 if applicable, section 536.028. Sections 42.230 to 42.236 and chapter 536 are nonseverable
8 and if any of the powers vested with the general assembly pursuant to chapter 536 to
9 review, to delay the effective date or to disapprove and annul a rule are subsequently held
10 unconstitutional, then the grant of rulemaking authority and any rule proposed or adopted
11 after August 28, 2010, shall be invalid and void.

2. The adjutant general shall determine as expeditiously as possible the persons
13 who are entitled to a Gulf War medallion, medal, and a certificate under sections 42.230
14 to 42.236 and distribute the medallions, medals, and the certificates as provided in sections
15 42.230 to 42.236. Applications for the Gulf War medallion, medal, and the certificate shall
16 be filed with the office of the adjutant general at any time after January 1, 2011, on forms
17 prescribed and furnished by the adjutant general's office. The adjutant general shall
18 approve all applications that are in order, and shall cause a Gulf War medallion, medal,
19 and a certificate to be prepared for each approved veteran in the form created by the
20 veterans' commission under section 42.234. The medallions, medals, and certificates shall
21 be awarded until the supply of medallions, medals, and certificates is exhausted. The
22 adjutant general shall notify the general assembly when such supply totals less than one
23 hundred.

3. The following persons may apply for a Gulf War medallion, medal, and a
25 certificate under sections 42.230 to 42.236:

(1) Any veteran who is entitled to a Gulf War medallion, medal, and a certificate
27 under sections 42.230 to 42.236;

(2) Any spouse or eldest living survivor of a deceased veteran who would be entitled
29 to a Gulf War medallion, medal, and a certificate under sections 42.230 to 42.236 but who
30 died prior to having made application for such medallion, medal, and certificate.

4. If any spouse or eldest living survivor applies for the Gulf War medallion, medal,
32 and certificate under subsection 3 of this section or if any veteran dies after applying for
33 a Gulf War medallion, medal, and a certificate under sections 42.230 to 42.236 and such
34 veteran would have been entitled to the Gulf War medallion, medal, and the certificate, the

35 adjutant general shall give the Gulf War medallion, medal, and the certificate to the spouse
36 or eldest living survivor of the deceased veteran.

37 5. If the adjutant general disallows any veteran's claim to a Gulf War medallion,
38 medal, and a certificate under sections 42.230 to 42.236, a statement of the reason for the
39 disallowance shall be filed with the application and notice of this disallowance shall be
40 mailed to the applicant at the applicant's last known address.

 42.234. The veterans' commission shall design the form of the Gulf War medallion,
2 medal, and the certificate and forward the approved designs to the adjutant general for
3 distribution under sections 42.230 to 42.236. It is the intent of the general assembly to
4 create statewide involvement in the design of these symbols in recognition of this historic
5 endeavor. Therefore, in designing the forms, the veterans' commission may solicit
6 potential designs from elementary and secondary schools, veterans' groups, civic
7 organizations, or any other interested party, and may select the best design from among
8 such solicited designs, or may select another design.

 42.236. 1. The "Gulf War Veterans' Recognition Award Fund" is hereby created
2 in the state treasury, and shall consist of all gifts, donations, and bequests to the fund and
3 all funds transferred to the veterans' commission capital improvement trust fund from any
4 remaining balances in the World War II veterans' recognition award fund, the Korean
5 Conflict veterans' recognition award fund, and the Vietnam War veterans' recognition
6 award fund. The fund shall be administered by the adjutant general. Notwithstanding the
7 provisions of section 33.080 to the contrary, moneys in the Gulf War veterans' recognition
8 award fund shall not be transferred to the credit of the general revenue fund at the end of
9 the biennium. Interest and moneys earned on the fund shall be credited to the fund.

10 2. Moneys in the fund shall be used solely to promote the solicitation for designs
11 for, aid in the manufacture of, and aid in the distribution of the medallion, medal, and the
12 certificate.

13 3. When all allowed Gulf War medallions, medals, and certificates have been
14 distributed, the fund shall automatically be terminated. Any balance remaining in the
15 fund after all such distributions shall be transferred to the veterans' commission capital
16 improvement trust fund created in section 313.835.
