AN ACT

To amend chapter 21, RSMo, by adding thereto one new section relating to the Missouri firearms freedom act.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Chapter 21, RSMo, is amended by adding thereto one new section, to be 2 known as section 21.757, to read as follows:

21.757. 1. This section shall be called and may be cited as the "Missouri Firearms 2 Freedom Act".

2. The general assembly declares that the authority for this section is the following:

4 (1) Amendment X of the Constitution of the United States guarantees to the states 5 and their people all powers not granted to the federal government elsewhere in the 6 Constitution and reserves to the state and people of Missouri certain powers as they were 7 understood at the time that Missouri was admitted to statehood. The guarantee of those 8 powers is a matter of contract between the state and people of Missouri and the United 9 States as of the time that the compact with the United States was agreed upon and adopted 10 by Missouri and the United States;

(2) Amendment IX of the Constitution of the United States guarantees to the people
 rights not granted in the Constitution and reserves to the people of Missouri certain rights
 as they were understood at the time that Missouri was admitted to statehood. The
 guarantee of those rights is a matter of contract between the state and people of Missouri

and the United States as of the time that the compact with the United States was agreed
 upon and adopted by Missouri and the United States;

17 (3) The regulation of intrastate commerce is vested in the states under Amendments
18 IX and X of the Constitution of the United States;

(4) Amendment II of the Constitution of the United States reserves to the people the right to keep and bear arms as that right was understood at the time that Missouri was admitted to statehood, and the guarantee of the right is a matter of contract between the state and people of Missouri and the United States as of the time that the compact with the United States was agreed upon and adopted by Missouri and the United States; and

(5) Article I, section 23, Constitution of Missouri clearly secures to Missouri
 citizens, and prohibits government interference with, the right of individual Missouri
 citizens to keep and bear arms.

3. As used in this section, unless the context otherwise requires, the following terms
shall mean:

(1) "Firearms accessories", items that are used in conjunction with or mounted upon a firearm but are not essential to the basic function of a firearm, including but not limited to telescopic or laser sights, magazines, flash or sound suppressors, folding or aftermarket stocks and grips, speedloaders, ammunition carriers, and lights for target illumination;

(2) "Generic and insignificant parts", includes but is not limited to springs, screws,
 nuts, and pins;

36 (3) "Manufactured", creating a firearm, a firearm accessory, or ammunition from
 37 basic materials for functional usefulness, including but not limited to forging, casting,
 38 machining, or other processes for working materials.

39 4. A personal firearm, a firearm accessory, or ammunition that is manufactured commercially or privately in Missouri and that remains within the borders of Missouri is 40 41 not subject to federal law or federal regulation, including registration, under the authority of congress to regulate interstate commerce. It is declared by the legislature that those 42 43 items have not traveled in interstate commerce. This section applies to a firearm, a firearm accessory, or ammunition that is manufactured in Missouri from basic materials and that 44 45 can be manufactured without the inclusion of any significant parts imported into this state. Generic and insignificant parts that have other manufacturing or consumer product 46 47 applications are not firearms, firearms accessories, or ammunition, and their importation into Missouri and incorporation into a firearm, a firearm accessory, or ammunition 48 49 manufactured in Missouri does not subject the firearm, firearm accessory, or ammunition 50 to federal regulation. It is declared by the legislature that basic materials, such as

unmachined steel and unshaped wood, are not firearms, firearms accessories, or 51 ammunition and are not subject to congressional authority to regulate firearms, firearms 52 accessories, or ammunition under interstate commerce as if they were actually firearms, 53 firearms accessories, or ammunition. The authority of congress to regulate interstate 54 55 commerce in basic materials does not include the authority to regulate firearms, firearms accessories, or ammunition made in Missouri from those materials. Firearms accessories 56 that are imported into Missouri from another state and that are subject to federal 57 58 regulation as being in interstate commerce do not subject a firearm to federal regulation 59 under interstate commerce because they are attached to or used in conjunction with a 60 firearm in Missouri.

5. The provisions of this section shall not apply to:

62

(1) A firearm that cannot be carried and used by one person;

(2) A firearm that has a bore diameter greater than one half inches and that uses
 smokeless powder, not black powder, as a propellant;

65 (3) Ammunition with a projectile that explodes using an explosion of chemical
 66 energy after the projectile leaves the firearm; or

67 (4) Other than shotguns, a firearm that discharges two or more projectiles with one
 68 activation of the trigger or other firing device.

69 **6.** A firearm manufactured or sold in Missouri under the provisions of this section 70 shall have the words ''Made in Missouri'' clearly stamped on a central metallic part, such 71 as the receiver or frame.
