### AN ACT

To repeal sections 2.030, 3.130, 3.140, and 3.142, RSMo, and to enact in lieu thereof three new sections relating to the revised statutes of Missouri.

---

*Be it enacted by the General Assembly of the state of Missouri, as follows:*

Section A. Sections 2.030, 3.130, 3.140, and 3.142, RSMo, are repealed and three new  
2 sections enacted in lieu thereof, to be known as sections 2.030, 3.130, and 3.140, to read as  
3 follows:

2.030. The joint committee on legislative research shall annually collate[,] **and** index,  
2 **and may** print[,] and bind **and/or produce in a web-based electronic format** all laws and  
3 resolutions passed or adopted by the general assembly and all measures approved by the people  
4 since the last publication of the session laws. Any edition of the session laws published pursuant  
5 to this section is a part of the official laws and resolutions of the general assembly at which the  
6 laws and resolutions were passed.

3.130. [1.] Such number of copies of each volume of each edition of the revised statutes  
2 of Missouri and annotations thereto and such number of the supplements or pocket parts thereto  
3 as may be necessary to meet the demand as determined by the committee shall be printed and  
4 bound, and also produced in an electronic format, and delivered to the revisor of statutes, who  
5 shall execute and file a receipt therefor with the director of revenue. The revisor of statutes shall  
6 distribute the copies, in either version or combination, [without charge as follows:

7 (1) To each state department, and each division and bureau thereof, one copy as  
8 requested in writing specifying the version;

EXPLANATION — Matter enclosed in bold-faced brackets [thus] in the above bill is not enacted and is intended to be omitted from the law. Matter in **bold-face** type in the above bill is proposed language.

- 9           (2) To each member of the general assembly when first elected, one bound version and,  
10 if requested, one copy in the electronic version; and at each general assembly thereafter, one  
11 printed version and one copy in the electronic version if so requested in writing; each member  
12 to receive one printed version and, if requested, one copy in the electronic version of each  
13 supplement and of each new edition of the revised statutes when published;
- 14           (3) To each judge of the supreme court, the court of appeals and to each judge of the  
15 circuit courts, except municipal judges, one copy in either version;
- 16           (4) To the probate divisions of the circuit courts of Jackson County, St. Louis County  
17 and the city of St. Louis, four additional copies each in either version or combination, and to the  
18 probate divisions of the circuit courts of those counties where the judge of the probate division  
19 sits in more than one city, one additional copy each in either version;
- 20           (5) To the law library of the supreme court, ten copies in either version or combination;
- 21           (6) To the law libraries of each district of the court of appeals, six copies each in either  
22 version or combination;
- 23           (7) To the library of the United States Supreme Court, one copy in either version;
- 24           (8) To the United States district courts and circuit court of appeals for Missouri, two  
25 copies each in either version or combination;
- 26           (9) To the state historical society, two copies in either version or combination;
- 27           (10) To the libraries of the state university at Columbia, at St. Louis, at Kansas City and  
28 at Rolla, one bound version and one electronic version each;
- 29           (11) To the state colleges, Lincoln University, the community colleges, Missouri  
30 Western State College, Linn State Technical College, and Missouri Southern State College, one  
31 bound version and one electronic version each;
- 32           (12) To the public school library of St. Louis, two copies in either version or  
33 combination;
- 34           (13) To the Library of Congress, one copy in either version;
- 35           (14) To the Mercantile Library of St. Louis, one bound version and one electronic  
36 version;
- 37           (15) To each public library in the state, if requested, one copy in either version;
- 38           (16) To the law libraries of St. Louis, St. Louis County, Kansas City and St. Joseph, one  
39 bound version and one electronic version each;
- 40           (17) To the law schools of the state university, St. Louis University, and Washington  
41 University, one bound version and one electronic version each;
- 42           (18) To the circuit clerk of each county of the state for distribution to each county  
43 officer, to be by him or her delivered to his or her successor in office, one copy in either version  
44 as requested in writing;

45 (19) To the director of the committee on legislative research, such number of copies in  
46 either version or combination as may be required by such committee for the performance of its  
47 duties;

48 (20) To any county law library, when requested by the circuit clerk, one bound version  
49 and one electronic version;

50 (21) To each county library, one copy of either version, when requested in writing;

51 (22) To any committee of the senate or house of representatives, as designated and  
52 requested by the accounts committee of the respective house] **at the price determined by the**  
53 **committee under section 3.140.**

54 [2. The revisor of statutes shall also provide the librarians of the supreme court library  
55 and the committee on legislative research such copies in either version or combination as may  
56 be necessary, not exceeding fifty-one each, to enable them to exchange the copies for like  
57 compilations or revisions of the statute laws of other states and territories.]

3.140. [1.] The committee on legislative research may, through the revisor of statutes,  
2 sell copies of the revised statutes of Missouri, and any supplement or edition of pocket parts  
3 thereto, [not required by this chapter to be distributed without charge,] **in print and/or in a web-**  
4 **based electronic format** at a price to be determined by the committee, taking into account the  
5 cost of printing and binding, **producing the statutes and maintaining the website**, including  
6 the cost of delivery, and the money received therefor shall be paid to the director of revenue and  
7 deposited in the state treasury to the credit of the general revenue fund.

8 [2. The revisor of statutes shall also supply to the clerk of the circuit court of each county  
9 order blanks in a number sufficient to meet the public demand. The blanks may be used by the  
10 public to order copies which shall be sold by the committee as provided in subsection 1.]

[3.142. 1. There is hereby established in the state treasury a revolving  
2 fund known as the "Statutory Revision Fund", and which shall receive funds paid  
3 to the revisor of statutes for sales of the revised statutes of Missouri or any  
4 supplement thereto, whether in printed, electronic, magnetic, or other form and  
5 funds received for any other service for which there is a fee charged by the  
6 committee on legislative research. The committee on legislative research shall  
7 determine the form and any fees or charges for the statutes or services. The state  
8 treasurer shall be custodian of the fund and shall make disbursements from the  
9 fund for enhancing or producing the electronic form of the revised statutes in a  
10 computer readable form, enhancing the electronic processing of computerized  
11 legislative drafting and such other purposes authorized by the joint committee on  
12 legislative research upon appropriation by the general assembly. Moneys in the  
13 fund may also be used at the direction of the committee on legislative research  
14 to provide the revised statutes of Missouri and any supplement thereto to public  
15 libraries of this state in a computer readable format for use by patrons of the  
16 libraries.

17                    2. Any unexpended balance in the fund at the end of any biennium not  
18                    to exceed twice the cost of providing the annual supplement to the revised  
19                    statutes of Missouri is exempt from the provisions of section 33.080, RSMo,  
20                    relating to transfer of unexpended balances to the ordinary revenue fund.]
