- Whereas, recently in the Senate version of the Patient Protection and Affordable
- 2 Care Act (HR 3590), a special deal was reportedly made by Nebraska Senator Ben Nelson
- 3 whereby the state of Nebraska is permanently exempted from bearing the costs of newly eligible
- 4 Nebraska Medicaid enrollees; and
- Whereas, such exemption has not been afforded to Missouri or any of the other
- 6 48 states; and
- 7 **Whereas**, all other states except Nebraska will be required to allocate substantial
- 8 sums to accommodate the federal health care bill's new Medicaid mandates; and
- Whereas, it has also been reported that Senator Nelson's vote for passage of the
- 10 bill was secured only after the deal was made; and
- Whereas, this "Nebraska Compromise" strikes a blow to the nation's collective
- 12 confidence in elected officials in Washington, D.C. and violates basic notions of fundamental
- 13 fairness:
- Now, therefore, be it resolved that the members of the Missouri House
- 15 of Representatives, Ninety-fifth General Assembly, Second Regular Session, the Senate
- 16 concurring therein, hereby call on Missouri Attorney General Chris Koster to join the 13 other
- 17 state attorneys general from across the nation in challenging the special deal; and
- Be it further resolved that Attorney General Koster thoroughly and
- 19 immediately review the constitutionality and legality of this suspect provision in HR 3590 and
- 20 stand up for Missouri taxpayers; and
- Be it further resolved that, in order to ensure that the dollars of Missouri
- 22 taxpayers are wisely spent, and in order to ensure that the Attorney General's resources are
- 23 properly used on criminal prosecutions, enforcement of undocumented worker laws, protection

- 24 of Missouri consumers, protection of Missouri's natural resources, and other vital duties, the
- 25 General Assembly urges Attorney General Koster to refrain from any litigation regarding the
- 26 constitutionality and legality of HR 3590 until such time as HR 3590 actually becomes law; and
- Be it further resolved that the Chief Clerk of the Missouri House of
- 28 Representatives be instructed to prepare a properly inscribed copy of this resolution for Attorney
- 29 General Koster, the Governor, and each member of the Missouri congressional delegation.
