This bill exempts a financial institution as defined in Section 381.410, RSMo, from the mortgage broker licensure requirements until the Nationwide Mortgage Licensing System and Registry under the Secure and Fair Enforcement (SAFE) for Mortgage Licensing Act provisions of the federal Housing and Economic Recovery Act of 2008 is operational.
