1 AMEND House Committee Substitute No. 2 for Senate Bill No. 3, Page 1, Section A, Line 2, by  
2 inserting after all of said section and line, the following:

4 "115.162. 1. A voter registration application shall be provided by the secretary of state in  
5 all offices of the state that provide public assistance, all offices that provide state-funded programs  
6 primarily engaged in providing services to persons with disabilities, and other offices as directed  
7 by the governor. In addition all armed forces recruitment offices shall be considered a voter  
8 registration agency.

9 2. At each voter registration agency, the following services shall be made available:

10 (1) Assistance to applicants in completing voter registration application forms, unless the  
11 applicant refuses such assistance;

12 (2) Acceptance of completed voter registration application forms for transmittal to the  
13 election authority located in the same county or any city not within a county, or if there is more  
14 than one election authority within the county, to the election authority nearest to the office of the  
15 agency. The election authority receiving the application forms shall review the applications and  
16 forward any applications pertaining to a different election authority to that election authority;

17 (3) Voter registration sites shall transmit voter registration application forms to the  
18 appropriate election authority not later than five business days after the form is completed by the  
19 applicant;

20 (4) If a voter registration agency provides services to a person with a disability at the  
21 person's home, the agency shall provide the services provided in this section at the person's home.

22 3. An applicant declining to register in any agency shall be noted in a declination section  
23 incorporated into the voter registration form used by the agency. No information relating to a  
24 declination to register to vote in connection with an application made at a voter registration  
25 agency may be used for any purpose other than voter registration.

26 4. The secretary of state's office shall provide voter registration application forms to the  
27 department of conservation for distribution to local offices and permit vendors. All department of  
28 conservation offices and local permit vendors authorized by the department to issue resident  
29 hunting and fishing permits shall make voter registration application forms available to all

1 applicants who apply for resident hunting and fishing permits at the department office or local  
2 permit vendor. Such applicants may mail the completed voter registration application to the  
3 appropriate election authority. All department of conservation offices and local permit vendors  
4 authorized by the department to issue resident hunting and fishing permits may inform any  
5 applicant for a resident hunting or fishing permit who applies by telephone that the applicant may  
6 request that a voter registration application be mailed to the applicant. Such applicants may mail  
7 the completed voter registration application to the appropriate election authority.”; and

8  
9 Further amend said bill by amending the title, enacting clause, and intersectional references  
10 accordingly.
