1 AMEND House Committee Substitute for Senate Bill No. 145, Page 5,
 2 Section 67.319, Line 53, by inserting after all of said line the
 3 following:

4 "67.1956. 1. In each tourism community enhancement
 5 district established pursuant to section 67.1953, there shall be
 6 a board of directors, to consist of seven members. Three members
 7 shall be selected by the governing body of the city, town or
 8 village located within the district that collected the largest
 9 amount of retail sales tax within the district in the year
 10 preceding the establishment of the district. Two members shall
 11 be selected by the governing body of the city, town or village,
 12 located within the district, that collected the second largest
 13 amount of retail sales tax within the district in the year
 14 preceding the establishment of the district, if such a city, town
 15 or village exists in the district. If no such city, town or
 16 village exists in the district then two additional members shall
 17 be selected by the governing body of the city, town, or village
 18 located within the district that collected the largest amount of
 19 retail sales tax within the district in the year preceding the
 20 establishment of the district. One member shall be selected by
 21 the governing body of the county located within the district that
 22 collected the largest amount of retail sales tax within the
 23 district in the year preceding the establishment of the district.
 24 One member shall be selected by the governing body of the county
 25 located within the district that collected the second largest
 26 amount of retail sales tax within the district in the year
 27 preceding the establishment of the district.

28 2. Of the members first selected, the three members [from]
 29 selected by the city, town or village located within the district

1 that collected the largest amount of retail sales tax within the
2 district in the year preceding the establishment of the district
3 shall be selected for a term of three years, the two members
4 [from] selected by the city, town, or village located within the
5 district that collected the second largest amount of retail sales
6 tax within the district in the year preceding the establishment
7 of the district shall be selected for a term of two years, and
8 the remaining members shall be selected for a term of one year.
9 Thereafter, each member selected shall serve a three-year term.
10 Except in any city of the fourth classification with more than
11 two thousand nine hundred but fewer than three thousand
12 inhabitants and located in any county of the first classification
13 with more than seventy-three thousand seven hundred but fewer
14 than seventy-three thousand eight hundred inhabitants, every
15 member shall be either a resident of the district, own real
16 property within the district, be employed by a business within
17 the district, or operate a business within the district. All
18 members shall serve without compensation. The board shall elect
19 its own treasurer, secretary and such other officers as it deems
20 necessary and expedient, and it may make such rules, regulations,
21 and bylaws to carry out its duties pursuant to sections 67.1950
22 to 67.1977.

23 3. Any vacancy within the board shall be filled in the same
24 manner as the person who vacated the position was selected within
25 sixty days of the vacancy occurring, with the new person serving
26 the remainder of the term of the person who vacated the position.
27 In the event that a person is not so selected within sixty days
28 of the vacancy occurring, the remaining members of the board
29 shall select a person to serve the remainder of the term of the
30 person who vacated the position.

31 4. If a tourism community enhancement district is already
32 in existence on August 28, 2005, the one additional board member
33 shall be appointed by the governing body of the city, town, or
34 village located within the district that collected the largest
35 amount of retail sales tax within the district in the year
36 preceding the establishment of the district for a one-year term
37 and the other additional board member shall be appointed by the

1 governing body of the county located within the district that
2 collected the second largest amount of retail sales tax within
3 the district in the year preceding the establishment of the
4 district for a two-year term, thereafter all board members shall
5 serve three-year terms. The existing board members shall serve
6 out their terms with the provisions of this section controlling
7 the appointment of successor board members, with first and second
8 existing board [existing] positions to expire to be appointed by
9 the governing body of the city, town, or village located within
10 the district that collected the largest amount of retail sales
11 tax within the district in the year preceding the establishment
12 of the district, the third and fourth existing board positions to
13 expire to be appointed by the governing body of the city, town,
14 or village located within the district that collected the second
15 largest amount of retail sales tax within the district in the
16 year preceding the establishment of the district and the fifth
17 existing board position to expire to be appointed by the
18 governing body of the county located within the district that
19 collected the largest amount of retail sales tax within the
20 district in the year preceding the establishment of the district.

21 5. The board, on behalf of the district, may:

22 (1) Cooperate with public agencies and with any industry or
23 business in the implementation of any project;

24 (2) Enter into any agreement with any public agency,
25 person, firm, or corporation to implement any of the provisions
26 of sections 67.1950 to 67.1977;

27 (3) Contract and be contracted with, and sue and be sued;
28 and

29 (4) Accept gifts, grants, loans, or contributions from the
30 United States of America, the state, any political subdivision,
31 foundation, other public or private agency, individual,
32 partnership or corporation on behalf of the tourism enhancement
33 district community."; and

34 Further amend said title, enacting clause and intersectional
35 references accordingly.
