1 AMEND House Committee Substitute for Senate Committee Substitute
 2 for Senate Bill No. 163, Page 1, In the Title, Line 2, by
 3 deleting all of said line and inserting in lieu thereof the
 4 following:

5 "To repeal sections 11.010, 172.030, 173.005, and 174.450,
 6 RSMo, and to enact in lieu thereof five new"; and

7 Further amend said bill, Page 1, Section A, Lines 1 to 3, by
 8 deleting all of said lines and inserting in lieu thereof the
 9 following:

10 "Section A. Sections 11.010, 172.030, 173.005, 174.450,
 11 RSMo, are repealed and five new sections enacted in lieu thereof,
 12 to be known as sections 11.010, 11.025, 172.030, 173.005, and
 13 174.450, to read as follows:

14 11.010. The official manual, commonly known as the "Blue
 15 Book", compiled and electronically published by the secretary of
 16 state on its official website is the official manual of this
 17 state, and it is unlawful for any officer or employee of this
 18 state except the secretary of state, or any board, or department
 19 or any officer or employee thereof, to cause to be printed, at
 20 state expense, any duplication or rearrangement of any part of
 21 the manual. It is also unlawful for the secretary of state to
 22 publish, or permit to be published in the manual any duplication,
 23 or rearrangement of any part of any report, or other document,
 24 required to be printed at the expense of the state which has been
 25 submitted to and rejected by him or her as not suitable for
 26 publication in the manual.

27 11.025. Notwithstanding any other provision of law, the
 28 secretary of state may enter into an agreement directly with a
 29 nonprofit organization for such nonprofit organization to print

1 and distribute copies of the official manual. The secretary of
2 state shall provide to the organization the electronic version of
3 the official manual prepared and published under this chapter.
4 The nonprofit organization shall not alter, add, or delete any
5 information provided by the secretary of state. Information
6 published about the organization in the official manual shall be
7 limited to the name of the organization and its contact
8 information. The official manual shall not contain advertising
9 or information promoting any entity or individual. The
10 organization shall charge a fee for a copy of the official manual
11 to cover the cost of production and distribution. The nonprofit
12 organization shall be subject to an independent audit, ordered by
13 the state and paid for by the nonprofit organization, to account
14 for income and expenses for the sale, production, and
15 distribution of the official manual. After such audit, any
16 surplus funds generated by the nonprofit organization through the
17 sale of the manual shall be transferred to the state treasurer
18 for deposit in the state's general revenue fund."; and

19 Further amend said title, enacting clause and intersectional
20 references accordingly.
