 2 In the Title, Line 2, by inserting after the word "sections" the
 3 number "11.010,"; and

4 Further amend said bill, Page 1, In the Title, Line 4, by
 5 deleting the word "twenty" and inserting in lieu thereof the word
 6 "twenty-two"; and

7 Further amend said bill, Page 1, Section A, Line 1, by
 8 inserting after the word "Sections" the number "11.010,"; and

9 Further amend said bill, Page 1, Section A, Line 3, by
 10 deleting the word "twenty" and inserting in lieu thereof the word
 11 "twenty-two"; and

12 Further amend said bill, Page 1, Section A, Line 4, by
 13 inserting after the word "sections" the numbers "11.010,
 14 11.025,"; and

15 Further amend said bill, Page 1, Section A, Line 6, by
 16 inserting after all of said line the following:

17 "11.010. The official manual, commonly known as the "Blue
 18 Book", compiled and electronically published by the secretary of
 19 state on its official website is the official manual of this
 20 state, and it is unlawful for any officer or employee of this
 21 state except the secretary of state, or any board, or department
 22 or any officer or employee thereof, to cause to be printed, at
 23 state expense, any duplication or rearrangement of any part of
 24 the manual. It is also unlawful for the secretary of state to
 25 publish, or permit to be published in the manual any duplication,
 26 or rearrangement of any part of any report, or other document,
 27 required to be printed at the expense of the state which has been
 28 submitted to and rejected by him or her as not suitable for
 29 publication in the manual.

1 11.025. Notwithstanding any other provision of law, the
2 secretary of state may enter into an agreement directly with a
3 nonprofit organization for such nonprofit organization to print
4 and distribute copies of the official manual. The secretary of
5 state shall provide to the organization the electronic version of
6 the official manual prepared and published under this chapter.
7 The nonprofit organization shall not alter, add, or delete any
8 information provided by the secretary of state. Information
9 published about the organization in the official manual shall be
10 limited to the name of the organization and its contact
11 information. The official manual shall not contain advertising
12 or information promoting any entity or individual. The
13 organization shall charge a fee for a copy of the official manual
14 to cover the cost of production and distribution. The nonprofit
15 organization shall be subject to an independent audit, ordered by
16 the state and paid for by the nonprofit organization, to account
17 for income and expenses for the sale, production, and
18 distribution of the official manual. After such audit, any
19 surplus funds generated by the nonprofit organization through the
20 sale of the manual shall be transferred to the state treasurer
21 for deposit in the state's general revenue fund."; and

22 Further amend said title, enacting clause and intersectional
23 references accordingly.
