1 AMEND House Committee Substitute for Senate Bill No. 325, Page 1,
 2 In the Title, Line 2, by inserting after the word "sections" the
 3 number "215.020,"; and

4 Further amend said bill, Page 1, In the Title, Line 5, by
 5 deleting the word "twenty-seven" and inserting in lieu thereof
 6 the word "twenty-eight"; and

7 Further amend said bill, Page 1, Section A, Line 1, by
 8 inserting after the word "Sections" the number "215.020,"; and

9 Further amend said bill, Page 1, Section A, Line 4, by
 10 deleting the word "twenty-seven" and inserting in lieu thereof
 11 the word "twenty-eight"; and

12 Further amend said bill, Page 1, Section A, Line 4, by
 13 inserting after the word "sections" the number "215.020,"; and

14 Further amend said bill, Page 1, Section A, Line 7, by
 15 inserting after all of said line the following:

16 "215.020. 1. There is hereby created and established as a
 17 governmental instrumentality of the state of Missouri the
 18 "Missouri Housing Development Commission" which shall constitute
 19 a body corporate and politic.

20 2. The commission shall consist of the governor, lieutenant
 21 governor, the state treasurer, the state attorney general, and
 22 six members to be selected by the governor, with the advice and
 23 consent of the senate. The persons to be selected by the
 24 governor shall be individuals knowledgeable in the areas of
 25 housing, finance or construction. Not more than four of the
 26 members appointed by the governor shall be from the same
 27 political party. The members of the commission appointed by the
 28 governor shall serve the following terms: Two shall serve two
 29 years, two shall serve three years, and two shall serve four

1 years, respectively. Thereafter, each appointment shall be for a
2 term of four years. If for any reason a vacancy occurs, the
3 governor, with the advice and consent of the senate, shall
4 appoint a new member to fill the unexpired term. Members are
5 eligible for reappointment.

6 3. Six members of the commission shall constitute a quorum.
7 No vacancy in the membership of the commission shall impair the
8 right of a quorum to exercise all the rights and perform all the
9 duties of the commission. No action shall be taken by the
10 commission except upon the affirmative vote of at least six of
11 the members of the commission.

12 4. Each member of the commission appointed by the governor
13 is entitled to compensation of fifty dollars per diem plus his
14 reasonable and necessary expenses actually incurred in
15 discharging his duties under sections 215.010 to 215.250.

16 5. The employment of an executive director or chief
17 executive officer by the commission shall be for a term of three
18 years and subject to reappointment for additional terms. Each
19 term shall be subject to the advice and consent of the senate in
20 the same manner as an appointment subject to the provisions of
21 Article IV, Section 51 of the Missouri Constitution. The term of
22 the executive director or chief executive officer serving in such
23 capacity on the effective date of this section shall expire on
24 December 31, 2011, and such person may be reappointed under the
25 provisions of this section."; and

26 Further amend said title, enacting clause and intersectional
27 references accordingly.
