AN ACT

To amend chapter 620, RSMo, by adding thereto one new section relating to economic incentives.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Chapter 620, RSMo, is amended by adding thereto one new section, to be
2 known as section 620.1930, to read as follows:

620.1930. 1. For every expenditure of one dollar by the state of Kansas for
2 **promoting economic development in the Kansas counties that are part of the Kansas City**
3 **metropolitan area, Missouri shall make an expenditure of one dollar and fifty cents for**
4 **promoting economic development in the Missouri counties that are part of the Kansas City**
5 **metropolitan area.**

6 **2. As used in this section:**

7 **(1) "Expenditure" means appropriation, grant, financial award, loan, debt**
8 **authorization, tax authorization, or any reduction in revenue collected as a result of a tax**
9 **deduction, tax exemption, tax credit, tax abatement, or other tax preference, in connection**
10 **with any program administered by the department of economic development, or any other**
11 **applicable program;**

12 **(2) "Kansas City metropolitan area" means the multicounty metropolitan area**
13 **straddling the border between the states of Missouri and Kansas consisting of the Missouri**
14 **counties of Jackson, Platte, Clay, and Cass, and the Kansas counties of Johnson,**
15 **Leavenworth, and Wyandotte.**

EXPLANATION — Matter enclosed in bold-faced brackets [thus] in the above bill is not enacted and is intended to be omitted from the law. Matter in **bold-face** type in the above bill is proposed language.

- 16 **3. The department shall promulgate rules to implement the provisions of this**
17 **section. Any rule or portion of a rule, as that term is defined in section 536.010, that is**
18 **created under the authority delegated in this section shall become effective only if it**
19 **complies with and is subject to all of the provisions of chapter 536 and, if applicable,**
20 **section 536.028. This section and chapter 536 are nonseverable and if any of the powers**
21 **vested with the general assembly under chapter 536 to review, to delay the effective date,**
22 **or to disapprove and annul a rule are subsequently held unconstitutional, then the grant**
23 **of rulemaking authority and any rule proposed or adopted after August 28, 2011, shall be**
24 **invalid and void.**
- 25 **4. The provisions of this section shall become effective July 1, 2013.**
