### FISCAL ANALYSIS

#### **ASSUMPTION**

## Sections 115.123 & 115.755 Presidential Primary Date

Officials at the Johnson County, Platte County Board of Election Commission, St. Louis County Board of Election Commissions assume that there is no fiscal impact from this proposal.

Officials at the **Kansas City Board of Election Commission** assume that with a jurisdiction wide April election one month later the fiscal impact would be \$50,000. An increase in machine rental, memory cards, staff overtime and temporary expense would be needed to process two jurisdiction wide elections in a 30 day period.

Officials at the **Lawrence County** assume additional costs of \$10,800 for additional sets of memory packs for the election machines, absentee envelopes and educational materials.

Officials at the **Office of the Secretary of State** assume that there is no fiscal impact from this proposal.

**Oversight** assumes that changing the date of an election would not affect the cost of the election. The presidential primary election costs incurred by the local election authorities are reimbursed by the Secretary of State's Office. The Secretary of State is given in each fiscal year with a presidential primary an appropriation to cover all the costs of the local election authorities holding the primary election. Because of this appropriation, Oversight assumes no impact from this proposal.

#### **Section 115.761 Presidential Primary Candidates Fee**

**Oversight** assumes the fee to appear on the ballot is not paid to the State and therefor the State would have no fiscal impact from this proposal.

#### Bill as a Whole

Officials at the following board of election commissions: St. Louis City Board of Election Commission, Clay County Board of Election Commission and the Jackson County Board of Election Commission did not respond to **Oversight's** request for fiscal impact.
