8	military men and women are at the forefront of United States national air defense; and

10	WHEREAS, our military personnel and their families deserve the peace of mind that
11	they have an unparalleled multi-role fighter to keep them safe, protect our nation, and secure
12	peace around the world; and

14	WHEREAS, the F-35 is critical to the modernization of our military because it wil
15	replace aging and obsolete aircraft and secure United States air superiority for the nex
16	generation; and

18	WHEREAS, thousands of hard working, highly educated Missourians contribute to the
19	success of Whiteman Air Force Base and the Marine Corp Mobilization Command; and

21	WHEREAS, these Missourians depend on the economic impact of our military bases to
22	support their jobs and thriving communities; and

24	WHEREAS, the F-35 generates more than five hundred high technology, high paying
25	jobs for Missouri; and

40	curb the strategic security and economic benefits of the program:

42	NOW, THEREFORE, BE IT RESOLVED that we, the members of the Missouri
43	House of Representatives, Ninety-sixth General Assembly, hereby urge the United States
44	Congress to recognize the importance of the F-35 to the State of Missouri, our military, and our
45	national security, and support high production and full funding of the F-35 Joint Strike Fighter
46	program; and

48	BE IT FURTHER RESOLVED that the Chief Clerk of the Missouri House of
49	Representatives be instructed to prepare properly inscribed copies of this resolution for the
50	President of the United States, the President of the United States Senate, the Speaker of the
