15	WHEREAS, thousands of hard working, highly educated Missourians contribute to the
16	success of Whiteman Air Force Base and the Marine Corp Mobilization Command; and

19	support their jobs and thriving communities; and

21	WHEREAS, the F-35 generates more than five hundred high technology, high paying
22	jobs for Missouri; and

24	WHEREAS, the global F-35 Joint Strike Fighter program already provides sustained
25	economic impact to Missouri and its citizens of over thirty-five million dollars annually; and

27	WHEREAS, the United States Congress is currently reviewing its commitment to the
28	F-35 program and its full funding; and

30	WHEREAS the United States and its global partners have invested in the development

33	WHEREAS, our military is currently testing the aircraft and we are on the verge of
34	realizing the return on this long-term investment; and

36	WHEREAS, to slow production would increase the marginal cost of each aircraft and
37	curb the strategic security and economic benefits of the program:

39	WHEREAS that we, the members of the Missouri House of Representatives, Ninety
40	sixth General Assembly, hereby urge the United States Congress to recognize the importance of
41	the F-35 to the State of Missouri, our military, and our national security, and support high
42	production and full funding of the F-35 Joint Strike Fighter program; and

44	BE IT FURTHER RESOLVED that the Chief Clerk of the Missouri House of
45	Representatives be instructed to prepare properly inscribed copies of this resolution for the
46	President of the United States, the President of the United States Senate, the Speaker of the
