AMEND House Committee Substitute for Senate Bill No. 578, Page 1, Section A, Line 2, by inserting after all of said section and line the following:

“142.869. 1. The tax imposed by this chapter shall not apply to passenger motor vehicles, buses as defined in section 301.010, or commercial motor vehicles registered in this state which are powered by alternative fuel[, or hydrogen] and for which a valid alternative fuel decal has been acquired as provided in this section. The owners or operators of such motor vehicles shall, in lieu of the tax imposed by section 142.803, pay an annual alternative fuel decal fee as follows: [seventy-five] one hundred forty dollars on each passenger motor vehicle, school bus as defined in section 301.010, and commercial motor vehicle with a licensed gross vehicle weight of eighteen thousand pounds or less; one hundred eighty-five dollars on each motor vehicle with a licensed gross weight in excess of eighteen thousand pounds but not more than thirty-six thousand pounds used for farm or farming transportation operations and registered with a license plate designated with the letter "F"; [one] two hundred [fifty] eighty dollars on each motor vehicle with a licensed gross vehicle weight in excess of eighteen thousand pounds but less than or equal to thirty-six thousand pounds, and each passenger-carrying motor vehicle subject to the registration fee provided in sections 301.059, 301.061 and 301.063; [two] four hundred [fifty] seventy dollars on each motor vehicle with a licensed gross weight in excess of thirty-six thousand pounds used for farm or farming transportation operations and registered with a license plate designated with the letter "F"; and one thousand eight hundred eighty dollars on each motor vehicle with a licensed gross vehicle weight in excess of thirty-six thousand pounds. Notwithstanding provisions of this section to the contrary, motor vehicles licensed as historic under section 301.131 which are powered by alternative fuel shall be exempt from both the tax imposed by this chapter and the alternative fuel decal requirements of this section.

2. Except interstate fuel users and vehicles licensed under a reciprocity agreement as defined in section 142.617, the tax imposed by section 142.803 shall not apply to motor vehicles registered outside this state which are powered by alternative fuel, and for which a valid temporary alternative fuel decal has been acquired as provided in this section. The owners or

1 operators of such motor vehicles shall, in lieu of the tax imposed by section 142.803, pay a  
2 temporary alternative fuel decal fee of [eight] twelve dollars on each such vehicle. Such decals  
3 shall be valid for a period of fifteen days from the date of issuance and shall be attached to the  
4 lower right-hand corner of the front windshield on the motor vehicle for which it was issued.  
5 Such temporary decal and fee shall not be transferable. [All proceeds from such decal fees shall  
6 be deposited as specified in section 142.345.] Alternative fuel dealers selling such decals in  
7 accordance with rules and regulations prescribed by the director shall be allowed to retain fifty  
8 cents for each decal fee timely remitted to the director.

9 3. The director shall annually, on or before January thirty-first of each year, collect or  
10 cause to be collected from owners or operators of the motor vehicles specified in subsection 1 of  
11 this section the annual decal fee. Applications for such decals shall be created and supplied by the  
12 department of revenue. In the case of a motor vehicle which is not in operation by January  
13 thirty-first of any year, a decal may be purchased for a fractional period of such year, and the  
14 amount of the decal fee shall be reduced by one-twelfth for each complete month which shall have  
15 elapsed since the beginning of such year.

16 4. Upon the payment of the fee required by subsection 1 of this section, the director shall  
17 issue a decal, which shall be valid for the current calendar year and shall be attached to the lower  
18 right-hand corner of the front windshield on the motor vehicle for which it was issued.

19 5. The decal fee paid pursuant to subsection 1 of this section for each motor vehicle shall  
20 be transferable upon a change of ownership of the motor vehicle and, if the LP gas or natural gas  
21 equipment is removed from a motor vehicle upon a change of ownership and is reinstalled in  
22 another motor vehicle, upon such reinstallation. Such transfers shall be accomplished in  
23 accordance with rules and regulations promulgated by the director.

24 6. It shall be unlawful for any person to operate a motor vehicle required to have an  
25 alternative fuel decal upon the highways of this state without a valid decal.

26 7. No person shall cause to be put, or put, LP gas or natural gas into the fuel supply  
27 receptacle of a motor vehicle required to have an alternative fuel decal unless the motor vehicle  
28 has a valid decal attached to it. Sales of fuel placed in the supply receptacle of a motor vehicle  
29 displaying such decal shall be recorded upon an invoice, which invoice shall include the decal  
30 number, the motor vehicle license number and the number of gallons placed in such supply  
31 receptacle.

32 8. Any person violating any provision of this section is guilty of an infraction and shall,  
33 upon conviction thereof, be fined five hundred dollars.

34 9. Motor vehicles displaying a valid alternative fuel decal are exempt from the licensing  
35 and reporting requirements of this chapter.

36 10. For all new alternative fuel or hydrogen-powered vehicles assembled in Missouri, the

1 first year's decal fee shall be one-half of the fees as proposed in this section.”; and

3 Further amend said bill by amending the title, enacting clause, and intersectional references  
4 accordingly.
