1 AMEND House Committee Substitute for Senate Committee Substitute for Senate Bill No. 726,
2 Page 7, Section 34.057, Line 152, by inserting after all of said section and line the following:

4 “64.930. 1. The county sports complex authority shall consist of [five] six commissioners
5 who shall be qualified voters of the state of Missouri, and residents of such county. The
6 commissioners of the county commission by a majority vote thereof shall submit a panel of nine
7 names to the governor who shall select with the advice and consent of the senate five
8 commissioners from such panel, no more than three of which shall be of any one political party,
9 who shall [constitute the] be members of such authority]; provided, however, that] . The
10 remaining commissioner of the authority shall be the county executive, who shall serve as an ex
11 officio member. The ex officio member shall have no voting rights. Except as specifically
12 provided in this section, no elective or appointed official of any political subdivision of the state
13 of Missouri shall be a member of the county sports complex authority.

14 2. The [authority] appointed sports complex commissioners shall elect [from its number]
15 a chairman ,who shall not be the ex officio member, and may appoint such officers and employees
16 as it may require for the performance of its duties and fix and determine their qualifications,
17 duties and compensation. No action of the authority shall be binding unless taken at a meeting at
18 which at least three voting members are present and unless a majority of the members present at
19 such meeting shall vote in favor thereof.

20 3. [Such] The appointed sports complex commissioners shall serve in the following
21 manner:
22 one for two years, one for three years, one for four years, one for five years, and one for six years.
23 Successors shall hold office for terms of five years, or for the unexpired terms of their
24 predecessors.

25 4. In the event a vacancy exists among appointed commissioners, a new panel of three
26 names shall be submitted by majority vote of the county commission to the governor for
27 appointment. All such vacancies shall be filled within thirty days from the date thereof. If the
28 county commission has not submitted a panel of three names to the governor within thirty days of

1 the expiration of a commissioner's term, the governor shall immediately make an appointment to
2 the commission with the advice and consent of the senate. In the event the governor does not
3 appoint a replacement, no commissioner shall continue to serve beyond the expiration of that
4 commissioner's term.

5 5. The compensation of the appointed sports complex commissioners to be paid by the
6 authority shall be determined by the appointed sports complex commissioners, but in no event
7 shall exceed the sum of three thousand dollars per annum. In addition, the appointed sports
8 complex commissioners shall be reimbursed by the authority for the actual and necessary
9 expenses incurred in the performance of their duties. No commissioner shall continue to serve
10 beyond the expiration of that commissioner's term.”; and

12 Further amend said bill by amending the title, enacting clause, and intersectional references
13 accordingly.
