#### FISCAL ANALYSIS

#### **ASSUMPTION**

Officials from the **Department of Public Safety - Missouri Highway Patrol** and the **Department of Transportation** each assume the proposal would not fiscally impact their respective agencies.

Officials from the **Department of Revenue (DOR)** state the proposal would have the following impact:

- procedures will need to be revised by a Management Analyst Specialist I requiring 40 hours of overtime at a cost of \$1,182 in FY 2013;
- the abandoned vehicle titling manual will need to be updated. This will require 40 hours of overtime for a Management Analyst Specialist I, at a cost of \$1,182 in FY 2013;
- DOR's web site will need to be updated. This will require 10 hours of overtime for an Administrative Analyst III, at a cost of \$319 in FY 2013.

In summary, DOR anticipates a cost of 2,683 (1,182 + 1,182 + 319) in FY 2013 to implement this proposal.

**Oversight** assumes DOR is provided with core funding to handle a certain amount of activity each year. Oversight assumes DOR could absorb the costs related to this proposal. If multiple bills pass which require additional staffing and duties at substantial costs, DOR could request funding through the appropriation process.
