ASSUMPTION

Officials at the **Budget and Planning**, **Department of Economic Development** and the **Department of Labor and Industrial Relations** assume that there is no fiscal impact from this proposal.

Officials at the **Office of Administration** defer to Department of Labor and Industrial Relations for a response.

Officials at the **City of Kansas City** assume eliminating the prevailing wage requirements may or may not result in a savings. If bids include wages that meet or exceed the prevailing wage, no savings may be incurred. If bids are below the prevailing wage, savings of the difference between the prevailing wage and the reduced bid (if such a savings are passed onto the City) could be experienced.

Officials at the City of Joplin, Jasper County, Newton County and the City of St. Louis did not respond to **Oversight's** request for fiscal impact.
