FISCAL ANALYSIS

<u>ASSUMPTION</u>

Officials from the **Cities of Ashland**, **Lebanon**, **Poplar Bluff** and **Rolla** did not respond to Oversight's request for fiscal impact.

Officials from the **Counties of Barry**, **Holt** and **Jasper** did not respond to Oversight's request for fiscal impact.

Oversight assumes that upon agreement of the parties, current law allows payment to be made directly to county. This proposal would remove the other options of payment to the county officer, or to both the officer and the county. Oversight assumes that removing the option to pay the officer directly would have no fiscal impact to either the city or county. Oversight also assumes no state fiscal impact.
