FISCAL ANALYSIS

ASSUMPTION

Officials from the Office of the State Courts Administrator, Department of Public Safety - Missouri Highway Patrol, Office of the State Public Defender, and the Department of Corrections each assume the proposal would not fiscally impact their respective agencies.

Officials from **Office of Prosecution Services** assume no measurable fiscal impact to their agency. There would be a positive impact in those affected counties because prosecutors' offices in the affected counties would reduce the expenses relating to traveling for change of venue.

Officials from the **Attorney General's Office** did not respond to our request for fiscal impact.

Oversight assumes the proposal would not create an overall fiscal impact to the state.
