

HB 1866 -- Sales and Use Tax Exemption for Certain Motor Vehicles

This bill specifies that the state and local sales and use tax will not apply to the receipt of a motor vehicle as a fishing or golfing tournament prize if the winner of the vehicle transfers the vehicle title within seven days and the purchaser pays the sales tax.
