1 AMEND House Committee Substitute for Senate Bill No. 75, Page 1, The Title, by deleting the
2 word "firearms" and inserting in lieu thereof the words "public safety"; and
3

4 FURTHER amend said Substitute, Page 3, Section 57.010, Line 22, by inserting immediately after
5 said Line the following:

6 "57.100. 1. Every sheriff shall quell and suppress assaults and batteries, riots, routs, affrays
7 and insurrections; shall apprehend and commit to jail all felons and traitors, and execute all process
8 directed to him by legal authority, including writs of replevin, attachments and final process issued
9 by circuit and associate circuit judges.

10 2. Beginning January 1, 2014, every sheriff shall maintain, house, and issue concealed carry
11 permits as specified under chapter 571. "; and

13 FURTHER amend said Substitute, Pages 8-9, Section 302.065, Lines 1-29, by deleting said Section
14 and inserting in lieu thereof the following:

15 "302.065. 1. Notwithstanding section 32.090 or any other provision of the law to the
16 contrary, and except as provided in subsection 4 of this section, the department of revenue shall not
17 retain copies, in any format, of source documents presented by individuals applying for or holding
18 driver's licenses or nondriver's licenses. The department of revenue shall not use technology to
19 capture digital images of source documents so that the images are capable of being retained in
20 electronic storage in a transferable format.

21 2. By December 31, 2013, the department of revenue shall securely destroy so as to make
22 irretrievable any source documents that have been obtained from driver's license or nondriver's
23 license applicants after September 1, 2012.

24 3. As long as the department of revenue has the authority to issue a concealed carry
25 endorsement, the department shall not retain copies of any certificate of qualification for a concealed
26 carry endorsement presented to the department for an endorsement on a driver's license or
27 nondriver's license under section 571.101. The department of revenue shall not use technology to
28 capture digital images of a certificate of qualification nor shall the department retain digital or
29 electronic images of such certificates. The department of revenue shall merely verify whether the
30 applicant for a driver's license or nondriver's license has presented a certificate of qualification which
31 will allow the applicant to obtain a concealed carry endorsement. The department of revenue shall
32 not compile or retain a list of driver's license or nondriver's license applicants who have been issued
33 concealed carry endorsements. An applicant's status as a holder of a certificate of qualification or a
34 concealed carry endorsement shall not be retained in the department's computer information systems
35 nor shall the department of revenue implement or maintain a computer information system that
36 allows its employees, agents, or other computer users to cross-reference and review, using the name
37 of driver's license holder or nondriver's license holder, any driver's license holder or nondriver's

1 license holder's status as a holder of a certificate of qualification or a concealed carry endorsement.
 2 By December 31, 2013, the department of revenue shall securely destroy so as to make irretrievable
 3 any copies of certificates of qualification that have been obtained from driver's license or nondriver's
 4 license applicants.

5 4. The provisions of this section shall not apply to any document required to be retained
 6 under federal motor carrier regulations in Title 49, Code of Federal Regulations, including but not
 7 limited to documents required by federal law for the issuance of a commercial driver's license and a
 8 commercial driver instruction permit.

9 5. As used in this section, the term "source documents" means original or certified copies,
 10 where applicable, of documents presented by an applicant as required under 6 CFR Part 37 to the
 11 department of revenue to apply for a driver's license or nondriver's license. Source documents shall
 12 also include any documents required for the issuance, renewal, or replacement of driver's licenses or
 13 nondriver's licenses by the department of revenue under the provisions of this chapter or
 14 accompanying regulations."; and

43 records related to the issuance of a concealed carry permit to MoSMART for dissemination to the
44 sheriff of the county or city not within a county in which the applicant or permit holder resides."; and
