1 AMEND House Committee Substitute for Senate Bill No. 75, Page 8, Section 171.410, Line 15, by
2 inserting after all of said line the following:

4 "171.415. 1. The provisions of this section shall be known as the "Parent and Community
5 School Information Act" and shall apply to each public school attendance center in a school district
6 and to each charter school in the state except for any attendance center or charter school that includes
7 only grades lower than third grade.

8 2. The department of elementary and secondary education shall produce a simplified annual
9 school attendance center report card, separately from the information required by section 160.522.

10 3. The simplified attendance center report card shall not be construed to be part of the school
11 improvement program; the report card shall be for informational rather than evaluative purposes.

12 4. The department of elementary and secondary education shall provide a link between the
13 report card referred to in section 160.522 and the simplified attendance center report card. The
14 department shall make an annual report to the joint committee on education of its progress in
15 establishing the report card and in simplifying access to the information in the department's data
16 portal.

17 5. The first simplified annual report card shall be distributed before December 1, 2014. The
18 school shall notify parents and the community about the contents of the report and provide directions
19 for accessing the information. The department shall include a direct link from its home page to the
20 instructions for accessing the simplified attendance center report card.

21 6. The principal of each attendance center or charter school may include a statement not to
22 exceed two hundred fifty words that provides context or background information that he or she
23 deems necessary to a full understanding of the attendance center's or charter school's scores.

24 7. In order to implement the provisions of this section, the department of elementary and
25 secondary education shall promulgate rules establishing a report card that is easy for the general
26 public to understand and contains information from the school improvement program that accurately
27 reflects the performance level of individual attendance centers by indicating the standards applicable
28 to each attendance center, overall score for the standard and the corresponding letter grade for each
29 applicable standard and, where applicable, the scores on the components and the corresponding letter
30 grade for each applicable component that comprise the standard in a format that does not exceed an
31 eight and one-half by eleven inch one-sided sheet.

32 8. Any rule or portion of a rule, as that term is defined in section 536.010, that is
33 created under the authority delegated in this section shall become effective only if it complies with

1 and is subject to all of the provisions of chapter 536 and, if applicable, section 536.028. This section
2 and chapter 536 are nonseverable and if any of the powers vested with the general assembly pursuant
3 to chapter 536 to review, to delay the effective date, or to disapprove and annul a rule are
4 subsequently held unconstitutional, then the grant of rulemaking authority and any rule proposed or
5 adopted after August 28, 2013, shall be invalid and void.

6 9. Any attendance center or charter school that scores less than seventy percent overall shall
7 be required to submit an action plan to the department of elementary and secondary education for its
8 approval, describing the steps the attendance center or charter school will take to improve its grade
9 during the next academic year after the grade is assigned." ; and

11 Further amend said bill by amending the title, enacting clause, and intersectional references
12 accordingly.
