1 AMEND House Committee Substitute for Senate Bill No. 75, Page 1, The Title, by deleting the  
2 word "firearms" and inserting in lieu thereof the words "public safety"; and

4 FURTHER amend said Substitute, Page 3, Section 57.010, Line 22, by inserting immediately after  
5 said Line the following:

6 "57.100. 1. Every sheriff shall quell and suppress assaults and batteries, riots, routs, affrays  
7 and insurrections; shall apprehend and commit to jail all felons and traitors, and execute all process  
8 directed to him by legal authority, including writs of replevin, attachments and final process issued  
9 by circuit and associate circuit judges.

10 2. Beginning January 1, 2014, every sheriff shall maintain, house, and issue concealed carry  
11 permits as specified under chapter 571. "; and  
12

13 FURTHER amend said Substitute, Page 5, Section 57.280, Line 46, by inserting immediately after  
14 the period "." on said Line the following:

15 "The provisions of this subsection shall not apply to any county with a charter form of  
16 government and with more than nine hundred fifty thousand inhabitants or any county with a charter  
17 form of government and with more than three hundred thousand but fewer than four hundred fifty  
18 thousand inhabitants. "; and

20 FURTHER amend said Substitute, Pages 8-9, Section 302.065, Lines 1-29, by deleting said Section  
21 and inserting in lieu thereof the following:

22 "302.065. 1. Notwithstanding section 32.090 or any other provision of the law to the  
23 contrary, and except as provided in subsection 4 of this section, the department of revenue shall not  
24 retain copies, in any format, of source documents presented by individuals applying for or holding  
25 driver's licenses or nondriver's licenses. The department of revenue shall not use technology to  
26 capture digital images of source documents so that the images are capable of being retained in  
27 electronic storage in a transferable format.

28 2. By December 31, 2013, the department of revenue shall securely destroy so as to make  
29 irretrievable any source documents that have been obtained from driver's license or nondriver's  
30 license applicants after September 1, 2012.

31 3. As long as the department of revenue has the authority to issue a concealed carry  
32 endorsement, the department shall not retain copies of any certificate of qualification for a concealed  
33 carry endorsement presented to the department for an endorsement on a driver's license or  
34 nondriver's license under section 571.101. The department of revenue shall not use technology to  
35 capture digital images of a certificate of qualification nor shall the department retain digital or  
36 electronic images of such certificates. The department of revenue shall merely verify whether the  
37 applicant for a driver's license or nondriver's license has presented a certificate of qualification which

1 will allow the applicant to obtain a concealed carry endorsement. The department of revenue shall  
 2 not compile or retain a list of driver's license or nondriver's license applicants who have been issued  
 3 concealed carry endorsements. An applicant's status as a holder of a certificate of qualification or a  
 4 concealed carry endorsement shall not be retained in the department's computer information systems  
 5 nor shall the department of revenue implement or maintain a computer information system that  
 6 allows its employees, agents, or other computer users to cross-reference and review, using the name  
 7 of driver's license holder or nondriver's license holder, any driver's license holder or nondriver's  
 8 license holder's status as a holder of a certificate of qualification or a concealed carry endorsement.  
 9 By December 31, 2013, the department of revenue shall securely destroy so as to make irretrievable  
 10 any copies of certificates of qualification that have been obtained from driver's license or nondriver's  
 11 license applicants.

12 4. The provisions of this section shall not apply to any document required to be retained  
 13 under federal motor carrier regulations in Title 49, Code of Federal Regulations, including but not  
 14 limited to documents required by federal law for the issuance of a commercial driver's license and a  
 15 commercial driver instruction permit.

16 5. As used in this section, the term "source documents" means original or certified copies,  
 17 where applicable, of documents presented by an applicant as required under 6 CFR Part 37 to the  
 18 department of revenue to apply for a driver's license or nondriver's license. Source documents shall  
 19 also include any documents required for the issuance, renewal, or replacement of driver's licenses or  
 20 nondriver's licenses by the department of revenue under the provisions of this chapter or  
 21 accompanying regulations."; and

15 interest and moneys earned on such investments shall be credited to the fund."; and

19 "10. Beginning August 28, 2013, the department of revenue shall begin transferring any  
20 records related to the issuance of a concealed carry permit to MoSMART for dissemination to the  
21 sheriff of the county or city not within a county in which the applicant or permit holder resides."; and

23 Further amend said bill by amending the title, enacting clause, and intersectional references
