1 AMEND House Committee Substitute for Senate Substitute for Senate Committee Substitute for
2 Senate Bill No. 83, Page 3, Section 32.029, Line 17, by inserting after all of said section the
3 following:

4 "32.070. 1. This act shall be known and may be cited as the "Streamlined Sales and Use Tax
5 Agreement Act".

6 2. The director of the department of revenue shall enter into the streamlined sales and use tax
7 agreement with one or more states to simplify and modernize sales and use tax administration in
8 order to substantially reduce the burden of tax compliance for all sellers and for all types of
9 commerce. In furtherance of the streamlined sales and use tax agreement, the director of the
10 department of revenue may act jointly with other states that are members of the streamlined sales and
11 use tax agreement to establish standards for certification of a certified service provider and certified
12 automated system and establish performance standards for multistate sellers.

13 3. In the first year after any federal legislation requiring vendors to collect sales and use tax
14 uniformly on sales in all states has been adopted and in which the amount of state sales and use tax
15 revenue collected under such federal legislation exceeds the amount of such revenues collected in the
16 immediately preceding year by at least two hundred million dollars, the highest rate of the tax
17 imposed on the Missouri taxable income of residents under chapter 143 shall be decreased from six
18 percent to five and one half percent. The director of the department of revenue shall notify the
19 revisor of statutes when such federal legislation is adopted and becomes effective in all states.

20 4. The director of the department of revenue may take other action reasonably required to
21 implement the provisions set forth in the streamlined sales and use tax administration act, including,
22 but not limited to, the promulgation of rules and the joint procurement, with other member states, of
23 goods and services in furtherance of the streamlined sales and use tax agreement.

24 5. For the purposes of representing the state as a member of the agreement and, if necessary,
25 amending the agreement, the state shall be represented by three delegates, one of whom shall be
26 appointed by the governor, one shall be a member of the general assembly appointed by mutual
27 agreement of the president pro tem of the senate and the speaker of the house of representatives, with
28 the director of the department of revenue or the director's designee as the third delegate. The
29 delegates shall recommend to the committees responsible for reviewing tax issues in the senate and
30 the house of representatives each year any amendment of state statutes required to be substantially in
31 compliance with the agreement. Such delegates shall make a written report by the fifteenth day of
32 January each year regarding the status of the agreement.

33 6. The department of revenue shall promulgate rules necessary to implement the provisions
34 of the streamlined sales and use tax agreement.

35 32.086. Notwithstanding any other provision of law, for all local sales and use taxes
36 collected by the department and remitted to a political jurisdiction or taxing district, the department
37 shall remit one percent of the amount collected to the general revenue fund to offset the cost of

1 collection, unless a greater amount is specified in the local sales and use tax law. The department
 2 shall not commingle the remaining amounts collected with general revenues and shall remit the
 3 remaining amounts collected to the political jurisdiction or taxing district less any credits for

6 Further amend said bill, Page 4, Section 32.087, Line 8, by deleting all of said line and inserting in
 7 lieu thereof the following:

8 "except as provided in subsection [18] 17 of this section, and shall be imposed on all
 9 transactions"; and

11 Further amend said bill, page, section, Lines 17-20, by deleting all of said lines and inserting in lieu
 12 thereof the following:

13 4. [The brackets required to be established by the director of revenue under the provisions of
 14 section 144.285 shall be based upon the sum of the combined rate of the state sales tax and all local
 15 sales taxes imposed under the provisions of the local sales tax law.

16 5.] (1) The ordinance or order imposing a local sales tax under the local sales tax law"; and

18 Further amend said bill, Pages 6-9, section, Lines 91-191, by deleting all of said lines and inserting
 19 in lieu thereof the following:

20 [6.] 5. On and after the effective date of any local sales tax imposed under the provisions of
 21 the local sales tax law, the director of revenue shall perform all functions incident to the
 22 administration, collection, enforcement, and operation of the tax, and the director of revenue shall
 23 collect in addition to the sales tax for the state of Missouri all additional local sales taxes authorized
 24 under the authority of the local sales tax law. All local sales taxes imposed under the local sales tax
 25 law together with all taxes imposed under the sales tax law of the state of Missouri shall be collected
 26 together and reported upon such forms and under such administrative rules and regulations as may be
 27 prescribed by the director of revenue.

28 [7.] 6. All applicable provisions contained in sections 144.010 to 144.525 governing the state
 29 sales tax and section 32.057, the uniform confidentiality provision, shall apply to the collection of
 30 any local sales tax imposed under the local sales tax law except as modified by the local sales tax
 31 law.

32 [8.] 7. All exemptions granted to agencies of government, organizations, persons and to the
 33 sale of certain articles and items of tangible personal property and taxable services under the
 34 provisions of sections 144.010 to 144.525, as these sections now read and as they may hereafter be
 35 amended, it being the intent of this general assembly to ensure that the same sales tax exemptions
 36 granted from the state sales tax law also be granted under the local sales tax law, are hereby made
 37 applicable to the imposition and collection of all local sales taxes imposed under the local sales tax
 38 law.

39 [9.] 8. The same sales tax permit, exemption certificate and retail certificate required by
 40 sections 144.010 to 144.525 for the administration and collection of the state sales tax shall satisfy
 41 the requirements of the local sales tax law, and no additional permit or exemption certificate or retail
 42 certificate shall be required; except that the director of revenue may prescribe a form of exemption
 43 certificate for an exemption from any local sales tax imposed by the local sales tax law.

44 [10.] 9. All discounts allowed the retailer under the provisions of the state sales tax law for
 45 the collection of and for payment of taxes under the provisions of the state sales tax law are hereby
 46 allowed and made applicable to any local sales tax collected under the provisions of the local sales
 47 tax law.

48 [11.] 10. The penalties provided in section 32.057 and sections 144.010 to 144.525 for a

violation of the provisions of those sections are hereby made applicable to violations of the provisions of the local sales tax law.

[12. (1)] 11. (1) For the purposes of any local sales tax imposed by an ordinance or order under the local sales tax law, all sales[, except the sale of motor vehicles, trailers, boats, and outboard motors, shall be deemed to be consummated at the place of business of the retailer unless the tangible personal property sold is delivered by the retailer or his agent to an out-of-state destination. In the event a retailer has more than one place of business in this state which participates in the sale, the sale shall be deemed to be consummated at the place of business of the retailer where the initial order for the tangible personal property is taken, even though the order must be forwarded elsewhere for acceptance, approval of credit, shipment or billing. A sale by a retailer's agent or employee shall be deemed to be consummated at the place of business from which he works.

(2) For the purposes of any local sales tax imposed by an ordinance or order under the local sales tax law, all sales of motor vehicles, trailers, boats, and outboard motors shall be deemed to be consummated at the residence of the purchaser and not at the place of business of the retailer, or the place of business from which the retailer's agent or employee works.

(3) For the purposes of any local tax imposed by an ordinance or under the local sales tax law on charges for mobile telecommunications services, all taxes of mobile telecommunications service shall be imposed as provided in the Mobile Telecommunications Sourcing Act, 4 U.S.C. Sections 116 through 124, as amended] shall be sourced as provided by sections 144.040 to 144.043.

[13.] 12. Local sales taxes imposed pursuant to the local sales tax law on the purchase and sale of motor vehicles, trailers, boats, and outboard motors shall not be collected and remitted by the seller, but shall be collected from the purchaser by the director of revenue at the time application is made for a certificate of title, if the address of the applicant is within a taxing entity imposing a local sales tax under the local sales tax law.

[14.] 13. The director of revenue and any of [his] the director's deputies, assistants and employees who have any duties or responsibilities in connection with the collection, deposit, transfer, transmittal, disbursement, safekeeping, accounting, or recording of funds which come into the hands of the director of revenue under the provisions of the local sales tax law shall enter a surety bond or bonds payable to any and all taxing entities in whose behalf such funds have been collected under the local sales tax law in the amount of one hundred thousand dollars for each such tax; but the director of revenue may enter into a blanket bond covering [himself] the director and all such deputies, assistants and employees. The cost of any premium for such bonds shall be paid by the director of revenue from the share of the collections under the sales tax law retained by the director of revenue for the benefit of the state.

[15.] 14. The director of revenue shall annually report on [his] the director's management of each trust fund which is created under the local sales tax law and administration of each local sales tax imposed under the local sales tax law. [He] The director shall provide each taxing entity imposing one or more local sales taxes authorized by the local sales tax law with a detailed accounting of the source of all funds received by [him] the director for the taxing entity. Notwithstanding any other provisions of law, the state auditor shall annually audit each trust fund. A copy of the director's report and annual audit shall be forwarded to each taxing entity imposing one or more local sales taxes.

[16.] 15. Within the boundaries of any taxing entity where one or more local sales taxes have been imposed, if any person is delinquent in the payment of the amount required to be paid by [him] such person under the local sales tax law or in the event a determination has been made against [him] such person for taxes and penalty under the local sales tax law, the limitation for bringing suit for the collection of the delinquent tax and penalty shall be the same as that provided in sections 144.010 to 144.525. Where the director of revenue has determined that suit must be filed against any person for

the collection of delinquent taxes due the state under the state sales tax law, and where such person is also delinquent in payment of taxes under the local sales tax law, the director of revenue shall notify the taxing entity in the event any person fails or refuses to pay the amount of any local sales tax due so that appropriate action may be taken by the taxing entity.

[17.] 16. Where property is seized by the director of revenue under the provisions of any law authorizing seizure of the property of a taxpayer who is delinquent in payment of the tax imposed by the state sales tax law, and where such taxpayer is also delinquent in payment of any tax imposed by the local sales tax law, the director of revenue shall permit the taxing entity to join in any sale of property to pay the delinquent taxes and penalties due the state and to the taxing entity under the local sales tax law. The proceeds from such sale shall first be applied to all sums due the state, and the remainder, if any, shall be applied to all sums due such taxing entity.

[18.] 17. If a local sales tax has been in effect for at least one year under the provisions of the local sales tax law and voters approve reimposition of the same local sales tax at the same rate at an election as provided for in the local sales tax law prior to the date such tax is due to expire, the tax so reimposed shall become effective the first day of the first calendar quarter after the director receives a certified copy of the ordinance, order or resolution accompanied by a map clearly showing the boundaries thereof and the results of such election, provided that such ordinance, order or resolution and all necessary accompanying materials are received by the director at least thirty days prior to the expiration of such tax. Any administrative cost or expense incurred by the state as a result of the provisions of this subsection shall be paid by the city or county reimposing such tax.

18. If the boundaries of a city in which a sales tax or use tax has been imposed shall thereafter be changed or altered, the city clerk shall forward to the director of revenue by United States registered mail or certified mail a certified copy of the ordinance adding or detaching territory from the city within ten days of adoption of the ordinance. The ordinance shall reflect the effective date of the ordinance and shall be accompanied by a map of the city clearly showing the territory added or detached from the city boundaries. Upon receipt of the ordinance and map, the tax imposed under the local sales tax law or local use tax law shall be effective in the added territory or abolished in the detached territory on the first day of a calendar quarter after one hundred twenty days' notice to sellers.

19. Any change to any local sales tax or local use tax boundary or rate shall be effective on the first day of a calendar quarter after one hundred twenty days' notice to sellers."; and

Further amend said bill, Page 13, Section 52.250, Line 19, by inserting after all of said section the following:

"66.620. 1. All county sales taxes collected by the director of revenue under sections 66.600 to 66.630 on behalf of any county[, less one percent for cost of collection which shall be deposited in the state's general revenue fund after payment of premiums for surety bonds as provided in section 32.087,] shall be deposited in a special trust fund, which is hereby created, to be known as the "County Sales Tax Trust Fund". [The moneys in the county sales tax trust fund shall not be deemed to be state funds and shall not be commingled with any funds of the state.] The director of revenue shall keep accurate records of the amount of money in the trust fund which was collected in each county imposing a county sales tax, and the records shall be open to the inspection of officers of the county and the public. Not later than the tenth day of each month, the director of revenue shall distribute all moneys deposited in the trust fund during the preceding month to the county which levied the tax; such funds shall be deposited with the county treasurer of the county and all expenditures of funds arising from the county sales tax trust fund shall be by an appropriation act to be enacted by the legislative council of the county, and to the cities, towns and villages located wholly or partly within the county which levied the tax in the manner as set forth in sections 66.600

1 to 66.630.

2 2. In any county not adopting an additional sales tax and alternate distribution system as
3 provided in section 67.581, for the purposes of distributing the county sales tax, the county shall be
4 divided into two groups, "Group A" and "Group B". Group A shall consist of all cities, towns and
5 villages which are located wholly or partly within the county which levied the tax and which had a
6 city sales tax in effect under the provisions of sections 94.500 to 94.550 on the day prior to the
7 adoption of the county sales tax ordinance, except that beginning January 1, 1980, group A shall
8 consist of all cities, towns and villages which are located wholly or partly within the county which
9 levied the tax and which had a city sales tax approved by the voters of such city under the provisions
10 of sections 94.500 to 94.550 on the day prior to the effective date of the county sales tax. For the
11 purposes of determining the location of consummation of sales for distribution of funds to cities,
12 towns and villages in group A, the boundaries of any such city, town or village shall be the boundary
13 of that city, town or village as it existed on March 19, 1984. Group B shall consist of all cities,
14 towns and villages which are located wholly or partly within the county which levied the tax and
15 which did not have a city sales tax in effect under the provisions of sections 94.500 to 94.550 on the
16 day prior to the adoption of the county sales tax ordinance, and shall also include all unincorporated
17 areas of the county which levied the tax; except that, beginning January 1, 1980, group B shall
18 consist of all cities, towns and villages which are located wholly or partly within the county which
19 levied the tax and which did not have a city sales tax approved by the voters of such city under the
20 provisions of sections 94.500 to 94.550 on the day prior to the effective date of the county sales tax
21 and shall also include all unincorporated areas of the county which levied the tax.

22 3. Until January 1, 1994, the director of revenue shall distribute to the cities, towns and
23 villages in group A the taxes based on the location in which the sales were deemed consummated
24 under section 66.630 and subsection 12 of section 32.087. Except for distribution governed by
25 section 66.630, after deducting the distribution to the cities, towns and villages in group A, the
26 director of revenue shall distribute the remaining funds in the county sales tax trust fund to the cities,
27 towns and villages and the county in group B as follows: To the county which levied the tax, a
28 percentage of the distributable revenue equal to the percentage ratio that the population of the
29 unincorporated areas of the county bears to the total population of group B; and to each city, town or
30 village in group B located wholly within the taxing county, a percentage of the distributable revenue
31 equal to the percentage ratio that the population of such city, town or village bears to the total
32 population of group B; and to each city, town or village located partly within the taxing county, a
33 percentage of the distributable revenue equal to the percentage ratio that the population of that part
34 of the city, town or village located within the taxing county bears to the total population of group B.

35 4. From and after January 1, 1994, the director of revenue shall distribute to the cities, towns
36 and villages in group A a portion of the taxes based on the location in which the sales were deemed
37 consummated under section 66.630 and subsection 12 of section 32.087 in accordance with the
38 formula described in this subsection. After deducting the distribution to the cities, towns and
39 villages in group A, the director of revenue shall distribute funds in the county sales tax trust fund to
40 the cities, towns and villages and the county in group B as follows: To the county which levied the
41 tax, ten percent multiplied by the percentage of the population of unincorporated county which has
42 been annexed or incorporated since April 1, 1993, multiplied by the total of all sales tax revenues
43 countywide, and a percentage of the remaining distributable revenue equal to the percentage ratio
44 that the population of unincorporated areas of the county bears to the total population of group B;
45 and to each city, town or village in group B located wholly within the taxing county, a percentage of
46 the remaining distributable revenue equal to the percentage ratio that the population of such city,
47 town or village bears to the total population of group B; and to each city, town or village located
48 partly within the taxing county, a percentage of the remaining distributable revenue equal to the

percentage ratio that the population of that part of the city, town or village located within the taxing county bears to the total population of group B.

5. (1) For purposes of administering the distribution formula of subsection 4 of this section, the revenues arising each year from sales occurring within each group A city, town or village shall be distributed as follows: Until such revenues reach the adjusted county average, as hereinafter defined, there shall be distributed to the city, town or village all of such revenues reduced by the percentage which is equal to ten percent multiplied by the percentage of the population of unincorporated county which has been annexed or incorporated after April 1, 1993; and once revenues exceed the adjusted county average, total revenues shall be shared in accordance with the redistribution formula as defined in this subsection.

(2) For purposes of this subsection, the "adjusted county average" is the per capita countywide average of all sales tax distributions during the prior calendar year reduced by the percentage which is equal to ten percent multiplied by the percentage of the population of unincorporated county which has been annexed or incorporated after April 1, 1993; the "redistribution formula" is as follows: During 1994, each group A city, town and village shall receive that portion of the revenues arising from sales occurring within the municipality that remains after deducting therefrom an amount equal to the cumulative sales tax revenues arising from sales within the municipality multiplied by the percentage which is the sum of ten percent multiplied by the percentage of the population of unincorporated county which has been annexed or incorporated after April 1, 1993, and the percentage, if greater than zero, equal to the product of 8.5 multiplied by the logarithm (to base 10) of the product of 0.035 multiplied by the total of cumulative per capita sales taxes arising from sales within the municipality less the adjusted county average. During 1995, each group A city, town and village shall receive that portion of the revenues arising from sales occurring within the municipality that remains after deducting therefrom an amount equal to the cumulative sales tax revenues arising from sales within the municipality multiplied by the percentage which is the sum of ten percent multiplied by the percentage of the population of unincorporated county which has been annexed or incorporated after April 1, 1993, and the percentage, if greater than zero, equal to the product of seventeen multiplied by the logarithm (to base 10) of the product of 0.035 multiplied by the total of cumulative per capita sales taxes arising from sales within the municipality less the adjusted county average. From January 1, 1996, until January 1, 2000, each group A city, town and village shall receive that portion of the revenues arising from sales occurring within the municipality that remains after deducting therefrom an amount equal to the cumulative sales tax revenues arising from sales within the municipality multiplied by the percentage which is the sum of ten percent multiplied by the percentage of the population of unincorporated county which has been annexed or incorporated after April 1, 1993, and the percentage, if greater than zero, equal to the product of 25.5 multiplied by the logarithm (to base 10) of the product of 0.035 multiplied by the total of cumulative per capita sales taxes arising from sales within the municipality less the adjusted county average. From and after January 1, 2000, the distribution formula covering the period from January 1, 1996, until January 1, 2000, shall continue to apply, except that the percentage computed for sales arising within the municipalities shall be not less than 7.5 percent for municipalities within which sales tax revenues exceed the adjusted county average, nor less than 12.5 percent for municipalities within which sales tax revenues exceed the adjusted county average by at least twenty-five percent.

(3) For purposes of applying the redistribution formula to a municipality which is partly within the county levying the tax, the distribution shall be calculated alternately for the municipality as a whole, except that the factor for annexed portion of the county shall not be applied to the portion of the municipality which is not within the county levying the tax, and for the portion of the municipality within the county levying the tax. Whichever calculation results in the larger

1 distribution to the municipality shall be used.

2 (4) Notwithstanding any other provision of this section, the fifty percent of additional sales
 3 taxes as described in section 99.845 arising from economic activities within the area of a
 4 redevelopment project established after July 12, 1990, pursuant to sections 99.800 to 99.865, while
 5 tax increment financing remains in effect shall be deducted from all calculations of countywide sales
 6 taxes, shall be distributed directly to the municipality involved, and shall be disregarded in
 7 calculating the amounts distributed or distributable to the municipality. Further, any agreement,
 8 contract or covenant entered into prior to July 12, 1990, between a municipality and any other
 9 political subdivision which provides for an appropriation of incremental sales tax revenues to the
 10 special allocation fund of a tax increment financing project while tax increment financing remains in
 11 effect shall continue to be in full force and effect and the sales taxes so appropriated shall be
 12 deducted from all calculations of countywide sales taxes, shall be distributed directly to the
 13 municipality involved, and shall be disregarded in calculating the amounts distributed or
 14 distributable to the municipality. In addition, and notwithstanding any other provision of this chapter
 15 to the contrary, economic development funds shall be distributed in full to the municipality in which
 16 the sales producing them were deemed consummated. Additionally, economic development funds
 17 shall be deducted from all calculations of countywide sales taxes and shall be disregarded in
 18 calculating the amounts distributed or distributable to the municipality. As used in this subdivision,
 19 the term "economic development funds" means the amount of sales tax revenue generated in any
 20 fiscal year by projects authorized pursuant to chapter 99 or chapter 100 in connection with which
 21 such sales tax revenue was pledged as security for, or was guaranteed by a developer to be sufficient
 22 to pay, outstanding obligations under any agreement authorized by chapter 100, entered into or
 23 adopted prior to September 1, 1993, between a municipality and another public body. The
 24 cumulative amount of economic development funds allowed under this provision shall not exceed
 25 the total amount necessary to amortize the obligations involved.

26 6. If the qualified voters of any city, town or village vote to change or alter its boundaries by
 27 annexing any unincorporated territory included in group B or if the qualified voters of one or more
 28 city, town or village in group A and the qualified voters of one or more city, town or village in group
 29 B vote to consolidate, the area annexed or the area consolidated which had been a part of group B
 30 shall remain a part of group B after annexation or consolidation. After the effective date of the
 31 annexation or consolidation, the annexing or consolidated city, town or village shall receive a
 32 percentage of the group B distributable revenue equal to the percentage ratio that the population of
 33 the annexed or consolidated area bears to the total population of group B and such annexed area shall
 34 not be classified as unincorporated area for determination of the percentage allocable to the county.
 35 If the qualified voters of any two or more cities, towns or villages in group A each vote to
 36 consolidate such cities, towns or villages, then such consolidated cities, towns or villages shall
 37 remain a part of group A. For the purpose of sections 66.600 to 66.630, population shall be as
 38 determined by the last federal decennial census or the latest census that determines the total
 39 population of the county and all political subdivisions therein. For the purpose of calculating the
 40 adjustment based on the percentage of unincorporated county population which is annexed after
 41 April 1, 1993, the accumulated percentage immediately before each census shall be used as the new
 42 percentage base after such census. After any annexation, incorporation or other municipal boundary
 43 change affecting the unincorporated area of the county, the chief elected official of the county shall
 44 certify the new population of the unincorporated area of the county and the percentage of the
 45 population which has been annexed or incorporated since April 1, 1993, to the director of revenue.
 46 After the adoption of the county sales tax ordinance, any city, town or village in group A may by
 47 adoption of an ordinance by its governing body cease to be a part of group A and become a part of
 48 group B. Within ten days after the adoption of the ordinance transferring the city, town or village

from one group to the other, the clerk of the transferring city, town or village shall forward to the director of revenue, by registered mail, a certified copy of the ordinance. Distribution to such city as a part of its former group shall cease and as a part of its new group shall begin on the first day of January of the year following notification to the director of revenue, provided such notification is received by the director of revenue on or before the first day of July of the year in which the transferring ordinance is adopted. If such notification is received by the director of revenue after the first day of July of the year in which the transferring ordinance is adopted, then distribution to such city as a part of its former group shall cease and as a part of its new group shall begin the first day of July of the year following such notification to the director of revenue. Once a group A city, town or village becomes a part of group B, such city may not transfer back to group A.

7. If any city, town or village shall hereafter change or alter its boundaries, the city clerk of the municipality shall forward to the director of revenue, by registered mail, a certified copy of the ordinance adding or detaching territory from the municipality. The ordinance shall reflect the effective date thereof, and shall be accompanied by a map of the municipality clearly showing the territory added thereto or detached therefrom. Upon receipt of the ordinance and map, the tax imposed by sections 66.600 to 66.630 shall be redistributed and allocated in accordance with the provisions of this section on the effective date of the change of the municipal boundary so that the proper percentage of group B distributable revenue is allocated to the municipality in proportion to any annexed territory. If any area of the unincorporated county elects to incorporate subsequent to the effective date of the county sales tax as set forth in sections 66.600 to 66.630, the newly incorporated municipality shall remain a part of group B. The city clerk of such newly incorporated municipality shall forward to the director of revenue, by registered mail, a certified copy of the incorporation election returns and a map of the municipality clearly showing the boundaries thereof. The certified copy of the incorporation election returns shall reflect the effective date of the incorporation. Upon receipt of the incorporation election returns and map, the tax imposed by sections 66.600 to 66.630 shall be distributed and allocated in accordance with the provisions of this section on the effective date of the incorporation.

8. The director of revenue may authorize the state treasurer to make refunds from the amounts in the trust fund and credited to any county for erroneous payments and overpayments made, and may redeem dishonored checks and drafts deposited to the credit of such counties. All revenue received by a county or municipality from the tax authorized pursuant to the provisions of this section shall be deposited in a special trust fund and shall be used solely for economic development purposes within such county or municipality for so long as the tax shall remain in effect.

6. Once the tax authorized by this section is abolished or is terminated by any means, all funds remaining in the special trust fund shall be used solely for economic development purposes within the county or municipality. Any funds in such special trust fund which are not needed for current expenditures may be invested by the governing body in accordance with applicable laws relating to the investment of other county or municipal funds.

7. All sales taxes collected by the director of revenue pursuant to this section on behalf of any county or municipality[, less one percent for cost of collection which shall be deposited in the state's general revenue fund after payment of premiums for surety bonds as provided in section 32.087,] shall be deposited in a special trust fund, which is hereby created, to be known as the "Local Economic Development Sales Tax Trust Fund".

8. [The moneys in the local economic development sales tax trust fund shall not be deemed to be state funds and shall not be commingled with any funds of the state.] The director of revenue shall keep accurate records of the amount of money in the trust fund and which was collected in each county or municipality imposing a sales tax pursuant to this section, and the records shall be open to the inspection of officers of the county or municipality and the public.

The tax imposed under this section and the tax imposed under the sales tax law of the state of Missouri shall be collected together and reported upon such forms and under such administrative rules and regulations as may be prescribed by the director of revenue.

All sales taxes collected by the director of revenue under this section on behalf of any city or county, or city not within a county[, less one percent for the cost of collection, which shall be deposited in the state's general revenue fund after payment of premiums for surety bonds as provided in section 32.087,] shall be deposited with the state treasurer in a special fund, which is hereby created, to be known as the "Community Children's Services Fund". The director of revenue shall notify each city or county, or city not within a county, of each instance of any amount refunded or any check redeemed from receipts due the city or county.

5. Except as modified in this section, all provisions of sections 32.085 [and] to 32.087 shall apply to the tax imposed under this section.

6. All revenues generated by the tax prescribed in this section shall be deposited in the county treasury or, in a city not within a county, to the board established by law to administer such fund to the credit of a special community children's services fund to accomplish the purposes set out herein and in section 210.861, and shall be used for no other purpose. Such fund shall be administered by a board of directors, established under section 210.861.

67.1959. 1. (10) Any county of the first classification with more than two hundred forty thousand three hundred but less than two hundred forty thousand four hundred inhabitants;

(11) Any county of the third classification with a township form of government and with more than eight thousand nine hundred but fewer than nine thousand inhabitants;

extended. Any funds in the trust fund which are not needed for current expenditures may be invested by the district in the securities described in subdivisions (1) to (12) of subsection 1 of section 30.270 or repurchase agreements secured by such securities. Before beginning the discharge of duties, the trustee shall take and subscribe an oath to faithfully discharge the duties of the office, and shall give bond with sufficient security, approved by the governing bodies of the counties, to the use of the dissolved or terminated district, for the faithful discharge of duties. The trustee shall have and exercise all powers necessary to liquidate the district, and upon satisfaction of all remaining obligations of the district, shall pay over to the county treasurer of each county in the district and take receipt for all remaining moneys in amounts based on the ratio the levy of each county bears to the total levy for the district in the previous three years or since the establishment of the district, whichever time period is shorter. Upon payment to the county treasurers, the trustee shall deliver to the clerk of the governing body of any county in the district all books, papers, records, and deeds belonging to the dissolved district.

67.2030. 1. The governing authority of any city of the fourth classification with more than one thousand six hundred but less than one thousand seven hundred inhabitants and located in any county of the first classification with more than seventy-three thousand seven hundred but less than seventy-three thousand eight hundred inhabitants is hereby authorized to impose, by ordinance or order, a sales tax in the amount not to exceed one-half of one percent on all retail sales made in such city which are subject to taxation pursuant to sections 144.010 to 144.525 for the promotion of tourism in such city. The tax authorized by this section shall be in addition to any and all other sales taxes allowed by law, except that no ordinance or order imposing a sales tax pursuant to this section shall be effective unless the governing authority of the city submits to the qualified voters of the city, at any municipal or state general, primary, or special election, a proposal to authorize the governing authority of the city to impose a tax.

If a proposal receives less than the required majority, then the governing authority of the city shall have no power to impose the sales tax unless and until the governing authority of the city has submitted another proposal to authorize the imposition of the sales tax authorized by this section and such proposal is

7 67.2530. 1. Any note, bond, or other indebtedness of the district may be refunded at any
8 time by the district by issuing refunding bonds in such amount as the district may deem necessary.
9 Such bonds shall be subject to and shall have the benefit of the foregoing provisions regarding notes,
10 bonds, and other obligations. Without limiting the generality of the foregoing, refunding bonds may

In the event a retailer has more than one place of business in this state which participates in the sale, the sale shall be deemed to be consummated at the place of business of the retailer where the initial order for the tangible personal property is taken, even though the order must be forwarded elsewhere for acceptance, approval of credit, shipment, or billing.

A sale by a retailer's employee shall be deemed to be consummated at the place of business from which the employee works.

(7) Subsequent to the initial approval by the voters and implementation of a sales tax in the district, the rate of the sales tax may be increased, but not to exceed a rate of one-half of one percent on retail sales as provided in this subsection. The election shall be conducted in accordance with section 67.2520; provided, however, that the district board of directors may place the question of the increase of the sales tax before the voters of the district by resolution, and the municipal clerk of the city, town, or village which originally conducted the incorporation of the district, or the circuit clerk of the court which originally conducted the incorporation of the district, shall conduct the subsequent election. (1) At such time as the board of directors of the district determines that further operation of the district is not in the best interests of the inhabitants of the district, and that the district should dissolve, the board shall submit for a vote in an election held throughout the district the question of whether the district should be abolished. The question shall be submitted in substantially the following form:

Prior to submitting the question to abolish the district to a vote of the entire district, the state auditor shall audit the district to determine the financial status of the district, and whether the district may be abolished pursuant to law.  8 pins, scissors, sewing machines, sewing needles, tape measures, and thimbles; and
 9 e. Sewing materials that become part of clothing, including but not limited to buttons, fabric,
 10 lace, thread, yarn, and zippers;
 11 (18) "Clothing accessories and equipment", incidental items worn on the person or in
 12 conjunction with clothing. Clothing accessories and equipment are mutually exclusive of clothing,
 13 sport or recreational equipment, and protective equipment;
 14 (19) "Coin-operated telephone service", a telecommunications service paid for by inserting
 15 money into a telephone accepting direct deposits of money to operate;
 16 (20) "Communications channel", a physical or virtual path of communications over which
 17 signals are transmitted between or among customer channel termination points;
 18 (21) "Computer", an electronic device that accepts information in digital or similar form and
 19 manipulates it for a result based on a sequence of instructions;
 20 (22) "Computer software", a set of coded instructions designed to cause a computer or
 21 automatic data processing equipment to perform a task. Computer software shall not include
 22 specified digital products, digital audio-visual works, digital audio works, or digital books;
 23 (23) "Conference bridging service", an ancillary service that links two or more participants
 24 of an audio or video conference call and may include the provision of a telephone number.
 25 Conference bridging service does not include the telecommunications services used to reach the
 26 conference bridge;
 27 (24) "Customer", the person or entity that contracts with the seller of telecommunications
 28 services. If the end user of telecommunications services is not the contracting party, the end user of
 29 the telecommunications service is the customer of the telecommunication service, but this definition
 30 only applies to the purpose of sourcing sales of telecommunications services under section 144.043.
 31 Customer shall not include a reseller of telecommunications service or for mobile
 32 telecommunications service of a serving carrier under an agreement to serve the customer outside the
 33 home service provider's licensed service area;
 34 (25) "Customer channel termination point", the location where the customer either inputs or
 35 receives the communication;
 36 (26) "Delivered electronically", delivered to the purchaser by means other than tangible
 37 storage media;
 38 (27) "Delivery charges", charges by the seller of personal property or services for
 39 preparation and delivery to a location designated by the purchaser of personal property or services,
 40 including but not limited to transportation, shipping, postage, handling, crating, and packing;
 41 (28) "Detailed telecommunications billing service", an ancillary service of separately stating
 42 information pertaining to individual calls on a customer's billing statement;
 43 (29) "Dietary supplement", any product, other than tobacco, intended to supplement the diet
 44 that contains one or more of the following dietary ingredients: a vitamin; a mineral; an herb or other
 45 botanical; an amino acid; a dietary substance for use by humans to supplement the diet by increasing
 46 the total dietary intake; or a concentrate, metabolite, constituent, extract, or combination of any
 47 ingredient described above; and that is intended for ingestion in tablet, capsule, powder, softgel,
 48 gelcap, or liquid form, or if not intended for ingestion in such a form, is not represented as a

1 conventional food and is not represented for use as a sole item of a meal or of the diet; and that is
 2 required to be labeled as a dietary supplement, identifiable by the supplemental facts box found on
 3 the label and as required under 21 CFR Section 101.36;

4 (30) "Digital audio works", works that result from the fixation of a series of musical, spoken,
 5 or other sounds, including ringtones;

6 (31) "Digital audio-visual works", a series of related images which, when shown in
 7 succession, impart an impression of motion, together with accompanying sounds, if any;

8 (32) "Digital books", works that are generally recognized in the ordinary and usual sense as
 9 books;

10 (33) "Direct mail", printed material delivered or distributed by United States mail or other
 11 delivery service to a mass audience or to addressees on a mailing list provided by the purchaser or at
 12 the direction of the purchaser when the cost of the items is not billed directly to the recipients.
 13 Direct mail shall include tangible personal property supplied directly or indirectly by the purchaser
 14 to the direct mail seller for inclusion in the package containing the printed material. Direct mail shall
 15 not include multiple items of printed material delivered to a single address;

16 (34) "Directory assistance", an ancillary service of providing telephone number information,
 17 or address information;

18 (35) "Drug":

19 (a) A compound, substance, or preparation, and any component of a compound, substance,
 20 or preparation, other than food and food ingredients, dietary supplements, alcoholic beverages, or
 21 grooming and hygiene products:

22 a. Recognized in the official United States Pharmacopoeia, official Homeopathic
 23 Pharmacopoeia of the United States, or official National Formulary, or supplement to any of them;

24 b. Intended for use in the diagnosis, cure, mitigation, treatment, or prevention of disease; or

25 c. Intended to affect the structure or any function of the body;

26 (b) Drug shall include insulin and medical oxygen;

27 (36) "Durable medical equipment", equipment including repair and replacement parts for
 28 same, excluding mobility enhancing equipment. Durable medical equipment:

29 (a) Can withstand repeated use;

30 (b) Is primarily and customarily used to serve a medical purpose;

31 (c) Generally is not useful to a person in the absence of illness or injury;

32 (d) Is not worn in or on the body;

33 (e) Is for home use;

34 (f) Is within the classification of devices eligible for MO HealthNet and Medicare
 35 reimbursement;

36 (g) Shall not include:

37 a. Kidney dialysis equipment not worn in or on the body, including repair and replacement
 38 parts; and

39 b. Enteral feeding systems not worn in or on the body, including repair and replacement
 40 parts.

41
 42 As used in this subdivision, repair and replacement parts shall include all components or attachments
 43 used in conjunction with the durable medical equipment;

44 (37) "Electronic", relating to technology having electrical, digital, magnetic, wireless,
 45 optical, electromagnetic, or similar capabilities;

46 (38) "End user", the person who utilizes the telecommunication service. In case of an entity,
 47 "end user" means the individual who utilizes the service on behalf of the entity;

48 (39) "Energy star qualified product", a product that meets the energy efficient guidelines set

by the United States Environmental Protection Agency and the United States Department of Energy that is authorized to carry the Energy Star label. Covered products are those listed at www.energystar.gov or successor address;

(40) "Engages in business activities within this state", includes:

(a) Purposefully or systematically exploiting the market provided by this state by any media-assisted, media-facilitated, or media-solicited means, including but not limited to direct mail advertising, distribution of catalogs, computer-assisted shopping, telephone, television, radio, or other electronic media, or magazine or newspaper advertisements, or other media; or

(b) Being owned or controlled by the same interests which own or control any seller engaged in the same or similar line of business in this state; or

(c) Maintaining or having a franchisee or licensee operating under the seller's trade name in this state if the franchisee or licensee is required to collect sales tax under sections 144.010 to 144.525; or

(d) Soliciting sales or taking orders by sales agents or traveling representatives;

(41) "Food and food ingredients", substances, whether in liquid, concentrated, solid, frozen, dried, or dehydrated form, that are sold for ingestion or chewing by humans and are consumed for their taste or nutritional value. Food and food ingredients shall not include alcoholic beverages, tobacco, or dietary supplements;

(42) "Food sold through a vending machine", food dispensed from a machine or other mechanical device that accepts payment;

(43) "Grooming and hygiene products", soaps and cleaning solutions, shampoo, toothpaste, mouthwash, antiperspirants, and suntan lotions and screens, regardless of whether the items meet the definition of over-the-counter drugs;

[(4)] (44) "Gross receipts"[,] or "sales price":

(a) Except as provided in section 144.012, [means the total amount of the sale price of the sales at retail including any services other than charges incident to the extension of credit that are a part of such sales made by the businesses herein referred to, capable of being valued in money, whether received in money or otherwise; except that, the term "gross receipts" shall not include the sale price of property returned by customers when the full sale price thereof is refunded either in cash or by credit. In determining any tax due under sections 144.010 to 144.525 on the gross receipts, charges incident to the extension of credit shall be specifically exempted. For the purposes of sections 144.010 to 144.525 the total amount of the sale price above mentioned shall be deemed to be the amount received. It shall also include the lease or rental consideration where the right to continuous possession or use of any article of tangible personal property is granted under a lease or contract and such transfer of possession would be taxable if outright sale were made and, in such cases, the same shall be taxable as if outright sale were made and considered as a sale of such article, and the tax shall be computed and paid by the lessee upon the rentals paid;] applies to the measure subject to sales tax and means the total amount of consideration, including cash, credit, property, and services, for which personal property or services are sold, leased, or rented, valued in money, whether received in money or otherwise, without any deduction for the following:

a. The seller's cost of the property sold;

b. The cost of materials used, labor or service cost, interest, losses, all costs of transportation to the seller, all taxes imposed on the seller, and any other expense of the seller;

c. Charges by the seller for any services necessary to complete the sale, other than delivery and installation charges;

d. Delivery charges; and

e. Credit for any trade-in;

(b) Shall not include:

- 1 a. Discounts, including cash, term, or coupons that are not reimbursed by a third party that
2 are allowed by a seller and taken by a purchaser on a sale;
- 3 b. Interest, financing, and carrying charges from credit extended on the sale of personal
4 property or services, if the amount is separately stated on the invoice, bill of sale or similar document
5 given to the purchaser; and
- 6 c. Any taxes legally imposed directly on the consumer that are separately stated on the
7 invoice, bill of sale or similar document given to the purchaser;
- 8 (c) Shall include consideration received by the seller from third parties if:
9 a. The seller actually receives consideration from a party other than the purchaser and the
10 consideration is directly related to a price reduction or discount on the sale;
11 b. The seller has an obligation to pass the price reduction or discount through to the
12 purchaser;
- 13 c. The amount of the consideration attributable to the sale is fixed and determinable by the
14 seller at the time of the sale of the item to the purchaser; and
- 15 d. One of the following criteria is met:
16 (i) The purchaser presents a coupon, certificate or other documentation to the seller to claim
17 a price reduction or discount where the coupon, certificate or documentation is authorized,
18 distributed, or granted by a third party with the understanding that the third party will reimburse any
19 seller to whom the coupon, certificate or documentation is presented;
20 (ii) The purchaser identifies himself or herself to the seller as a member of a group or
21 organization entitled to a price reduction or discount (a preferred customer card that is available to
22 any patron does not constitute membership in such a group); or
23 (iii) The price reduction or discount is identified as a third-party price reduction or discount
24 on the invoice received by the purchaser or on a coupon, certificate or other documentation presented
25 by the purchaser;
- 26 (45) "Home service provider", the same as such term is defined in Section 124(5) of Public
27 Law 106-252, Mobile Telecommunications Sourcing Act;
- 28 (46) "Lease or rental":
29 (a) Any transfer of possession or control of tangible personal property for a fixed or
30 indeterminate term for consideration. A lease or rental may include future options to purchase or
31 extend;
- 32 (b) Lease or rental shall not include:
33 a. A transfer of possession or control of property under a security agreement or deferred
34 payment plan that requires the transfer of title upon completion of the required payments;
35 b. A transfer of possession or control of property under an agreement that requires the
36 transfer of title upon completion of required payments and where any payment of an option price
37 does not exceed the greater of one hundred dollars or one percent of the total required payments;
38 c. Providing tangible personal property along with an operator for a fixed or indeterminate
39 period of time provided that the operator is necessary for the equipment to perform as designed and
40 the operator does more than maintain, inspect, or set up the tangible personal property;
- 41 (c) Lease or rental includes agreements covering motor vehicles and trailers where the
42 amount of consideration may be increased or decreased by reference to the amount realized upon
43 sale or disposition of the property as defined in 26 U.S.C. Section 7701(h)(1), as amended;
- 44 (47) "Light aircraft", a light airplane that seats no more than four persons, with a gross
45 weight of three thousand pounds or less, which is primarily used for recreational flying or flight
46 training;
- 47 (48) "Light aircraft kit", factory manufactured light aircraft parts and components, including
48 engine, propeller, instruments, wheels, brakes, and air frame parts which make up a complete aircraft

kit or partial kit designed to be assembled into a light aircraft and then operated by a qualified light aircraft purchaser for recreational and educational purposes;

(49) "Light aircraft parts and components", manufactured light aircraft parts, including air frame and engine parts, that are required by the qualified light aircraft purchaser to complete a light aircraft kit, or spare or replacement parts for an already completed light aircraft;

[(5)] (50) "Livestock", cattle, calves, sheep, swine, ratite birds, including but not limited to, ostrich and emu, aquatic products as defined in section 277.024, llamas, alpaca, buffalo, elk documented as obtained from a legal source and not from the wild, goats, horses, other equine, or rabbits raised in confinement for human consumption;

[(6)] (51) "Load and leave", delivery to the purchaser by use of a tangible storage media where the tangible storage media is not physically transferred to the purchaser;

(52) "Maintains a place of business in this state", includes maintaining, occupying, or using, permanently or temporarily, directly or indirectly, or through a subsidiary, or agent, by whatever name called, an office, place of distribution, sales or sample room or place, warehouse or storage place, or other place of business;

(53) "Mobile telecommunications service", the same as such term is defined in Section 124(7) of Public Law 106-252, Mobile Telecommunications Sourcing Act;

(54) "Mobility enhancing equipment", equipment, including repair and replacement parts to same, which:

(a) Is primarily and customarily used to provide or increase the ability to move from one place to another and which is appropriate for use either in a home or a motor vehicle; and

(b) Is not generally used by persons with normal mobility; and

(c) Is within the classification of devices eligible for MO HealthNet and Medicare reimbursement.

Mobility enhancement equipment shall not include durable medical equipment or any motor vehicle or equipment on a motor vehicle normally provided by a motor vehicle manufacturer;

(55) "Model 1 seller", a seller registered under the agreement that has selected a certified service provider as its agent to perform all the seller's sales and use tax functions, other than the seller's obligation to remit tax on its own purchases;

(56) "Model 2 seller", a seller that has selected a certified automated system (CAS) to perform part of its sales and use tax functions, but retains responsibility for remitting the tax;

(57) "Model 3 seller", a seller registered under the agreement that has sales in at least five member states, has total annual sales revenue of at least five hundred million dollars, has a proprietary system that calculates the amount of tax due each jurisdiction, and has entered into a performance agreement with the member states that establishes a tax performance standard for the seller. As used in this subdivision, a seller shall include an affiliated group of sellers using the same proprietary system;

(58) "Model 4 seller", a seller that is registered under the agreement and is not a Model 1 Seller, a Model 2 Seller or a Model 3 Seller;

(59) "Motor vehicle leasing company" [shall be], a company obtaining a permit from the director of revenue to operate as a motor vehicle leasing company. Not all persons renting or leasing trailers or motor vehicles need to obtain such a permit; however, no person failing to obtain such a permit may avail itself of the optional tax provisions of subsection 5 of section 144.070, as hereinafter provided;

[(7)] (60) "Other direct mail", any direct mail that is not advertising and promotional direct mail regardless of whether advertising and promotional direct mail is included in the same mailing. Other direct mail includes, but is not limited to:

1 (a) Transactional direct mail that contains personal information specific to the one addressee
 2 including, but not limited to, invoices, bills, statements of account, and payroll advices;

3 (b) Any legally required mailings including, but not limited to, privacy notices, tax reports,
 4 and stockholder reports; and

5 (c) Other nonpromotional direct mail delivered to existing or former shareholders,
 6 customers, employees, or agents including, but not limited to, newsletters and informational pieces.

7
 8 Other direct mail shall not include the development of billing information or the provision of any
 9 data processing service that is more than incidental;

10 (61) "Over-the-counter drug", a drug, excluding grooming and hygiene products, that
 11 contains a label that identifies the product as a drug as required by 21 CFR Section 201.66 and
 12 includes:

13 (a) A drug facts panel; or

14 (b) A statement of the active ingredients with a list of those ingredients contained in the
 15 compound, substance, or preparation;

16 (62) "Person" includes any individual, firm, copartnership, joint adventure, association,
 17 corporation, municipal or private, and whether organized for profit or not, state, county, political
 18 subdivision, state department, commission, board, bureau or agency, [except the state transportation
 19 department,] estate, trust, business trust, receiver or trustee appointed by the state or federal court,
 20 syndicate, or any other group or combination acting as a unit, and the plural as well as the singular
 21 number, or any other legal entity;

22 [(8)] (63) "Place of primary use", the street address representative of where the customer's
 23 use of the telecommunications service primarily occurs, which shall be the residential street address
 24 or the primary business street address of the customer. In the case of mobile telecommunications
 25 services, place of primary use shall be within the licensed service area of the home service provider;

26 (64) "Post-paid calling service", the telecommunications service obtained by making a
 27 payment on a call-by-call basis either through the use of a credit card or payment mechanism such as
 28 a bank card, travel card, credit card, or debit card, or by charge made to a telephone number which is
 29 not associated with the origination or termination of the telecommunications service. A post-paid
 30 calling service includes a telecommunications service, except a prepaid wireless calling service, that
 31 would be a prepaid calling service except it is not exclusively a telecommunications service;

32 (65) "Prepaid calling service", the right to access exclusively telecommunications services,
 33 which must be paid for in advance and which enables the origination of calls using an access number
 34 or authorization code, whether manually or electronically dialed, and that is sold in predetermined
 35 units or dollars of which the number declines with use in a known amount;

36 (66) "Prepaid wireless calling service", a telecommunications service that provides the right
 37 to utilize mobile wireless services as well as other nontelecommunications services, including the
 38 download of digital products delivered electronically, content and ancillary services, which must be
 39 paid for in advance and that is sold in predetermined units or dollars of which the number declines
 40 with use in a known amount;

41 (67) "Prepared food", food sold in a heated state or heated by the seller; two or more food
 42 ingredients mixed or combined by the seller for sale as a single item; or food sold with eating
 43 utensils provided by the seller, including plates, knives, forks, spoons, glasses, cups, napkins, or
 44 straws. A plate shall not include a container or packaging used to transport the food. Prepared food
 45 shall not include food that is only cut, repackaged, or pasteurized by the seller and eggs, fish, meat,
 46 poultry, and foods containing these raw animal foods requiring cooking by the consumer as
 47 recommended by the Food and Drug Administration in Chapter 3, Part 401.11 of the Food Code so
 48 as to prevent food borne illnesses;

1 (68) "Prescription", an order, formula, or recipe issued in any form of oral, written,
 2 electronic, or other means of transmission by a duly licensed practitioner authorized by the laws of
 3 the state;

4 (69) "Prewritten computer software", computer software, including prewritten upgrades,
 5 which is not designed and developed by the author or other creator to the specifications of a specific
 6 purchaser. The combining of two or more prewritten computer software programs or prewritten
 7 portions thereof shall not cause the combination to be other than prewritten computer software.
 8 Prewritten computer software shall include software designed and developed by the author or other
 9 creator to the specifications of a specific purchaser when it is sold to a person other than the specific
 10 purchaser. Where a person modifies or enhances computer software of which the person is not the
 11 author or creator, the person shall be deemed to be the author or creator only of such person's
 12 modifications or enhancements. Prewritten computer software or a prewritten portion thereof that is
 13 modified or enhanced to any degree, where such modification or enhancement is designed and
 14 developed to the specifications of a specific purchaser, remains prewritten computer software;
 15 provided, however, that where there is a reasonable, separately stated charge or an invoice or other
 16 statement of the price given to the purchaser for such modification or enhancement, such
 17 modification or enhancement shall not constitute prewritten computer software;

18 (70) "Private communication service", a telecommunications service that entitles the
 19 customer to exclusive or priority use of a communications channel or group of channels between or
 20 among termination points, regardless of the manner in which such channel or channels are
 21 connected, and includes switching capacity, extension lines, stations, and any other associated
 22 services that are provided in connection with the use of such channel or channels;

23 (71) "Product-based exemption", an exemption based on the description of the product and
 24 not based on who purchases the product or how the purchaser intends to use the product;

25 (72) "Product which is intended to be sold ultimately for final use or consumption", tangible
 26 personal property, or any service that is subject to state or local sales or use taxes, or any tax that is
 27 substantially equivalent to these taxes, in this state or any other state;

28 (73) "Prosthetic device", a replacement, corrective, or supportive device including repair and
 29 replacement parts for same worn on or in the body to artificially replace a missing portion of the
 30 body, prevent or correct physical deformity or malfunction, or support a weak or deformed portion
 31 of the body. The term "prosthetic device" shall not include corrective eyeglasses or contact lenses
 32 and shall be limited to the classification of devices eligible for MO HealthNet and Medicare
 33 reimbursement;

34 (74) "Protective equipment", items for human wear and designed as protection of the wearer
 35 against injury or disease or as protection against damage or injury of other persons or property but
 36 not suitable for general use. Protective equipment is mutually exclusive of clothing, clothing
 37 accessories or equipment, and sport or recreational equipment;

38 (75) "Purchase", the acquisition of the ownership of, or title to, tangible personal property,
 39 through a sale, as defined herein, for the purpose of storage, use or consumption in this state;

40 (76) "Purchase price", applies to the measure subject to use tax and has the same meaning as
 41 sales price;

42 (77) "Purchaser" [means], a person [who purchases tangible] to whom a sale of personal
 43 property is made or to whom [are rendered services, receipts from which are taxable under sections
 44 144.010 to 144.525] a service is furnished;

45 [(9)] (78) "Qualified light aircraft purchaser", a purchaser of a light aircraft, light aircraft kit,
 46 light aircraft parts or components who is a nonresident of this state, who will transport the light
 47 aircraft, light aircraft kit, light aircraft parts or components outside this state within ten days after the
 48 date of purchase, and who will register any light aircraft so purchased in another state or country.

1 Such purchaser shall not base such aircraft in this state and such purchaser shall not be a resident of
 2 the state unless such purchaser has paid sales or use tax on such aircraft in another state;

3 (79) "Receive" or "receipt", taking possession of tangible personal property; making first use
 4 of services; or taking possession or making first use of digital goods, whichever comes first. Receive
 5 and receipt shall not include possession by a shipping company on behalf of the purchaser;

6 (80) "Registered under the agreement", registration by a seller with the member states under
 7 the central registration system provided in Article IV of the agreement;

8 (81) "Research or experimentation activities" are the development of an experimental or
 9 pilot model, plant process, formula, invention or similar property, and the improvement of existing
 10 property of such type. Research or experimentation activities do not include activities such as
 11 ordinary testing or inspection of materials or products for quality control, efficiency surveys,
 12 advertising promotions or research in connection with literary, historical or similar projects;

13 [(10) "Sale" or "sales" includes installment and credit sales, and the exchange of properties
 14 as well as the sale thereof for money, every closed transaction constituting a sale, and means any
 15 transfer, exchange or barter, conditional or otherwise, in any manner or by any means whatsoever, of
 16 tangible personal property for valuable consideration and the rendering, furnishing or selling for a
 17 valuable consideration any of the substances, things and services herein designated and defined as
 18 taxable under the terms of sections 144.010 to 144.525;

19 (11)] (82) "Sale at retail" [means any transfer made by any person engaged in business as
 20 defined herein of the ownership of, or title to, tangible personal property to the purchaser, for use or
 21 consumption and not for resale in any form as tangible personal property, for a valuable
 22 consideration; except that, for the purposes of sections 144.010 to 144.525 and the tax imposed
 23 thereby: (i) purchases of tangible personal property made by duly licensed physicians, dentists,
 24 optometrists and veterinarians and used in the practice of their professions shall be deemed to be
 25 purchases for use or consumption and not for resale; and (ii) the selling of computer printouts,
 26 computer output or microfilm or microfiche and computer-assisted photo compositions to a
 27 purchaser to enable the purchaser to obtain for his or her own use the desired information contained
 28 in such computer printouts, computer output on microfilm or microfiche and computer-assisted
 29 photo compositions shall be considered as the sale of a service and not as the sale of tangible
 30 personal property] or "retail sale" means any sale, lease, or rental for any purpose other than for
 31 resale, sublease, or subrent. Purchases of tangible personal property made by duly licensed
 32 physicians, dentists, optometrists, and veterinarians and used in the practice of their professions shall
 33 be deemed to be purchases for use or consumption and not for resale. Where necessary to conform
 34 to the context of sections 144.010 to 144.525 and the tax imposed thereby, the term "sale at retail"
 35 shall be construed to embrace:

36 (a) Sales of admission tickets, cash admissions, charges and fees to or in places of
 37 amusement, entertainment and recreation, games and athletic events;

38 (b) Sales of electricity, electrical current, water and gas, natural or artificial, to domestic,
 39 commercial or industrial consumers;

40 (c) Sales of local and long distance telecommunications service to telecommunications

A purchaser may rely on a written representation by the seller as to the location where the order for such sale was received by the seller. When the purchaser does not have a written representation by the seller as to the location where the order for such sale was received by the seller, the purchaser may use a location indicated by a business address for the seller that is available from the business records of the purchaser that are maintained in the ordinary course of the purchaser's business to determine the rate applicable to the location where the order was received.

(5) The location where the order is received by or on behalf of the seller means the physical location of a seller or third party such as an established outlet, office location or automated order receipt system operated by or on behalf of the seller where an order is initially received by or on behalf of the seller and not where the order may be subsequently accepted, completed or fulfilled. An order is received when all of the information from the purchaser necessary to the determination whether the order can be accepted has been received by or on behalf of the seller. The location from which a product is shipped shall not be used in determining the location where the order is received by the seller.

(6) When taxable services are sold with tangible personal property or digital products pursuant to a single contract or in the same transaction, are billed on the same billing statement or statements, and, because of the application of this section, would be sourced to different jurisdictions, this subsection shall apply to determine the source for tax.

 12 sourced to the location indicated by an address for the purchaser obtained during the consummation
 13 of the sale, including the address of a purchaser's payment instrument, if no other address is
 14 available, when use of this address does not constitute bad faith;

15 (5) When none of the previous rules of subdivisions (1), (2), (3), and (4) of this subsection
 16 do not apply, including the circumstances in which the seller is without sufficient information to
 17 apply the previous rules, then the location will be determined by the address from which tangible
 18 personal property was shipped, from which the digital good or computer software delivered
 19 electronically was first available for transmission from the seller, or from which the service was
 20 provided (disregarding for these purposes any location that merely provided the digital transfer of

7. (1) The retail sale of a product shall be sourced in accordance with this section. The provisions of this section shall apply regardless of the characterization of a product as tangible personal property, a digital good, or a service. The provisions of this section shall only apply to determine a seller's obligation to pay or collect and remit sales or use tax with respect to the seller's retail sale of a product. The provisions of this subsection shall not affect the obligation of a purchaser or lessee to remit tax on the use of the product to the taxing jurisdictions of that use.

(2) This section shall not apply to sales or use taxes levied on the following:

(a) Retail sales or transfers of watercraft, modular homes, manufactured homes, or mobile homes; and

(b) Telecommunications services and ancillary services.

144.042. 1. (1) A purchaser of advertising and promotional direct mail may provide the seller with either:

(a) A direct pay permit;

(b) An agreement certificate of exemption claiming direct mail (or other written statement approved, authorized or accepted by the state); or

(c) Information showing the jurisdictions to which the advertising and promotional direct mail is to be delivered to recipients.

(2) If the purchaser provides the permit, certificate or statement referred to in paragraph (a) or (b) of subdivision (1) of subsection 1 of this section, the seller, in the absence of bad faith, is relieved of all obligations to collect, pay, or remit any tax on any transaction involving advertising and promotional direct mail to which the permit, certificate or statement applies. The purchaser shall source the sale to the jurisdictions to which the advertising and promotional direct mail is to be delivered to the recipients and shall report and pay any applicable tax due.

(3) If the purchaser provides the seller information showing the jurisdictions to which the advertising and promotional direct mail is to be delivered to recipients, the seller shall source the sale to the jurisdictions to which the advertising and promotional direct mail is to be delivered and shall collect and remit the applicable tax. In the absence of bad faith, the seller is relieved of any further obligation to collect any additional tax on the sale of advertising and promotional direct mail where the seller has sourced the sale according to the delivery information provided by the purchaser.

(4) If the purchaser does not provide the seller with any of the items listed in paragraph (a), (b) or (c) of subdivision (1) of subsection 1 of this section, the sale shall be sourced according to subdivision (5) of subsection 2 of section 144.040. The state to which the advertising and promotional direct mail is delivered may disallow credit for tax paid on sales sourced under this subdivision.

(5) Notwithstanding section 144.040, this subsection shall apply to sales of advertising and promotional direct mail.

2. (1) Except as otherwise provided in this subsection, sales of other direct mail are sourced in accordance with subdivision (3) of subsection 2 of section 144.040.

(2) A purchaser of other direct mail may provide the seller with either:

(a) A direct pay permit; or

(b) An agreement certificate of exemption claiming direct mail (or other written statement approved, authorized or accepted by the state).

(3) If the purchaser provides the permit, certificate or statement referred to in paragraph (a)

or (b) of subdivision (2) of this subsection, the seller, in the absence of bad faith, is relieved of all obligations to collect, pay or remit any tax on any transaction involving other direct mail to which the permit, certificate or statement apply. Notwithstanding subdivision (1) of this subsection, the sale shall be sourced to the jurisdictions to which the other direct mail is to be delivered to the recipients and the purchaser shall report and pay applicable tax due.

(4) Notwithstanding section 144.040, this subsection shall apply to sales of other direct mail.

3. (1) (a) This section applies to a transaction characterized under state law as the sale of services only if the service is an integral part of the production and distribution of printed material that meets the definition of direct mail.

(b) This section does not apply to any transaction that includes the development of billing information or the provision of any data processing service that is more than incidental regardless of whether advertising and promotional direct mail is included in the same mailing.

(2) If a transaction is a bundled transaction that includes advertising and promotion direct mail, this section applies only if the primary purpose of the transaction is the sale of products or services that meet the definition of advertising and promotional direct mail.

(3) Nothing in this section shall limit any purchaser's:

(a) Obligation for sales or use tax to any state to which the direct mail is delivered;

(b) Right under local, state, federal or constitutional law, to a credit for sales or use taxes legally due and paid to other jurisdictions; or

(c) Right to a refund of sales or use taxes overpaid to any jurisdiction.

(4) This section applies for purposes of uniformly sourcing direct mail transactions and does not impose requirements on states regarding the taxation of products that meet the definition of direct mail or to the application of sales for resale or other exemptions.

144.043. 1. [As used in this section, the following terms mean:

(1) "Light aircraft", a light airplane that seats no more than four persons, with a gross weight of three thousand pounds or less, which is primarily used for recreational flying or flight training;

Such purchaser shall not base such aircraft in this state and such purchaser shall not be a resident of the state unless such purchaser has paid sales or use tax on such aircraft in another state.

 42 144.049. 1. [For purposes of this section, the following terms mean:

43 (1) "Clothing", any article of wearing apparel, including footwear, intended to be worn on
 44 or about the human body. The term shall include but not be limited to cloth and other material used
 45 to make school uniforms or other school clothing. Items normally sold in pairs shall not be separated
 46 to qualify for the exemption. The term shall not include watches, watchbands, jewelry, handbags,

 30 department may issue the applicant a license or reinstate the revoked license. All persons beginning
 31 business subsequent to August 13, 1986, and who are required to collect the sales tax shall secure a
 32 retail sales license prior to making sales at retail. Such license may, after ten days' notice, be revoked
 33 by the director of revenue only in the event the licensee shall be in default for a period of sixty days
 34 in the payment of any taxes levied under section 144.020 or sections 143.191 to 143.261.
 35 Notwithstanding the provisions of section 32.057 in the event of revocation, the director of revenue
 36 may publish the status of the business account including the date of revocation in a manner as
 37 determined by the director.

38 2. The possession of a retail sales license and a statement from the department of revenue
 39 that the licensee owes no tax due under sections 144.010 to 144.510 or sections 143.191 to 143.261
 40 shall be a prerequisite to the issuance or renewal of any city or county occupation license or any state
 41 license which is required for conducting any business where goods are sold at retail. The date of
 42 issuance on the statement that the licensee owes no tax due shall be no more than ninety days before
 43 the date of submission for application or renewal of the local license. The revocation of a retailer's
 44 license by the director shall render the occupational license or the state license null and void.

45 3. No person responsible for the collection of taxes under section 144.080 shall make sales at
 46 retail unless such person is the holder of a valid retail sales license. After all appeals have been
 47 exhausted, the director of revenue may notify the county or city law enforcement agency
 48 representing the area in which the former licensee's business is located that the retail sales license of

such person has been revoked, and that any county or city occupation license of such person is also revoked. The county or city may enforce the provisions of this section, and may prohibit further sales at retail by such person.

4. In addition to the provisions of subsection 2 of this section, beginning January 1, 2009, the possession of a statement from the department of revenue stating no tax is due under sections 143.191 to 143.265 or sections 144.010 to 144.510 shall also be a prerequisite to the issuance or renewal of any city or county occupation license or any state license required for conducting any business where goods are sold at retail. The statement of no tax due shall be dated no longer than ninety days before the date of submission for application or renewal of the city or county license.

[5. Notwithstanding any law or rule to the contrary, sales tax shall only apply to the sale price paid by the final purchaser and not to any off-invoice discounts or other pricing discounts or mechanisms negotiated between manufacturers, wholesalers, and retailers.]

144.084. 1. The director shall promulgate rules and regulations for remittance of returns. Such rules shall:

(1) Allow for electronic payments by all remitters by both ACH credit and ACH debit;

(2) Provide an alternative method for making "same day" payments if an electronic funds transfer fails;

(3) Provide that if a due date falls on a legal banking holiday in the state, the taxes shall be due on the next succeeding business day; and

(4) Require that any data that accompanies a remittance be formatted using uniform tax type and payment type codes approved by the streamlined sales and use tax governing board.

2. All model 1, model 2, and model 3 sellers shall file returns electronically. Any model 1, model 2, or model 3 seller shall submit its sales and use tax returns in a simplified format approved by the director at such times as may be prescribed by the director.

144.100. 1. Every person making any taxable sales of property or service, except transactions provided for in sections 144.070 and 144.440, individually or by duly authorized officer or agent, shall make and file a written return with the director of revenue in such manner as he may prescribe.

2. The returns shall be on blanks designed and furnished by the director of the department of revenue and shall be filed at the times provided in sections 144.080 and 144.090. The returns shall [show the amount of gross receipts from sales of taxable property and services by the person and the amount of tax due thereon by that person during and for the period covered by the return] state:

(1) The name and address of the retailer;

(2) The total amount of gross sales of all tangible personal property and taxable services rendered by the retailer during the period for which the return is made;

(3) The total amount received during the period for which the return is made on charge and time sales of tangible personal property made and taxable services rendered prior to the period for which the return is made;

(4) Deductions allowed by law from such total amount of gross sales and from total amount received during the period for which the return is made on such charge and time sales;

(5) Receipts during the period for which the return is made from the total amount of sales of tangible personal property and taxable services rendered during such period in the course of such business, after deductions allowed by law have been made;

(6) Receipts during the period for which the return is made from charge and time sales of tangible personal property made and taxable services rendered prior to such period in the course of such business, after deductions allowed by law have been made;

(7) Gross receipts during the period for which the return is made from sales of tangible personal property and taxable services rendered in the course of such business upon the basis of

1 which the tax is imposed; and

2 (8) Such other pertinent information as the director may require.

3 3. In making such return, the retailer shall determine the market value of any consideration,
 4 other than money, received in connection with the sale of any tangible personal property in the
 5 course of the business and shall include such value in the return. Such value shall be subject to
 6 review and revision by the director as hereinafter provided. Refunds made by a retailer during the
 7 period for which the return is made on account of tangible personal property returned to the retailer
 8 shall be allowed as a deduction under subdivision (4) of subsection 2 of this section in case the
 9 retailer has included the receipts from such sale in a return made by such retailer and paid taxes on
 10 such sale. The retailer shall, at the time of making such return, pay to the director the amount of tax
 11 owed, except as otherwise provided in this section. The director may extend the time for making
 12 returns and paying the tax required by this section for any period not to exceed sixty days under such
 13 rules and regulations as the director of revenue may prescribe.

14 4. The director shall only require a single tax return for each taxing period and such return
 15 shall include only the taxing jurisdictions in which the seller makes sales within the state. With each
 16 return, the person shall remit to the director of revenue the full amount of the tax due.

17 [3.] 5. In case of charge and time sales the gross receipts thereof shall be included as sales in
 18 the returns as and when payments are received by the person, without any deduction therefrom
 19 whatsoever.

20 [4.] 6. If an error or omission is discovered in a return or a change be necessary to show the
 21 true facts, the error may be corrected, the omission supplied, or the change made in the return next
 22 filed with the director for the filing period immediately following the filing period in which the error
 23 was made or the omission occurred, as prescribed by law, except that no refund under this chapter
 24 shall be allowed for any amount of tax paid by a seller which is based upon charges incident to credit
 25 card discounts. Any other omission or error must be corrected by filing an amended return for the
 26 erroneously reported period if the amount of tax is less than that originally reported, or an additional
 27 return if the amount of tax is greater than that originally reported. An additional return shall be
 28 deemed filed on the date the envelope in which it is mailed is postmarked or the date it is received by
 29 the director, whichever is earlier. Any payment of tax, interest, penalty or additions to tax shall be
 30 deemed filed on the date the envelope containing the payment is postmarked or the date the payment
 31 is received by the director, whichever is earlier. If a refund or credit results from the filing of an
 32 amended return, no refund or credit shall be allowed unless an application for refund or credit is
 33 properly completed and submitted to the director pursuant to section 144.190.

34 [5.] 7. The amount of gross receipts from sales and the amount of tax due returned by the
 35 person, as well as all matters contained in the return, is subject to review and revision in the manner
 36 herein provided for the correction of the returns.

37 144.104. 1. A seller shall be allowed a deduction from taxable sales for bad debts
 38 attributable to taxable sales of such seller that have become uncollectable. Any deduction taken that
 39 is attributed to bad debts shall not include interest.

40 2. The amount of the bad debt deduction shall be calculated pursuant to 26 U.S.C. Section
 41 166(b), as amended, except that such amount shall be adjusted to exclude financing charges or
 42 interest, sales, or use taxes charged on the purchase price, uncollectable amounts on property that
 43 remain in the possession of the seller until the full purchase price is paid, and expenses incurred in
 44 attempting to collect any debt or repossessed property.

45 3. Bad debts may be deducted on the return for the period during which the bad debt is
 46 written off as uncollectable in the seller's books and records and is eligible to be deducted for federal
 47 income tax purposes. For purposes of this subsection, a seller who is not required to file federal
 48 income tax returns may deduct a bad debt on a return filed for the period in which the bad debt is

1 written off as uncollectable in the seller's books and records and would be eligible for a bad debt
 2 deduction for federal income tax purposes if the seller was required to file a federal income tax
 3 return.

4 4. If a deduction is taken for a bad debt and the debt is subsequently collected in whole or in
 5 part, the tax on the amount so collected shall be paid and reported on the return filed for the period in
 6 which the collection is made.

7 5. When the amount of bad debt exceeds the amount of taxable sales for the period during
 8 which the bad debt is written off, a refund claim may be filed by the seller within the applicable
 9 statute of limitations for refund claim; however, the statute of limitations shall be measured from the
 10 due date of the return on which the bad debt could first be claimed.

11 6. Where filing responsibilities have been assumed by a certified service provider, such
 12 service provider may claim, on behalf of the seller, any bad debt allowance provided by this section.
 13 The certified service provider shall credit or refund the full amount of any bad debt allowance or
 14 refund received to the seller.

15 7. For the purposes of reporting a payment received on a previously claimed bad debt, any
 16 payments made on a debt or account shall first be applied proportionally to the taxable price of the
 17 property or service and the sales tax thereon, and secondly to interest, service charges, and any other
 18 charges.

19 8. In situations where the books and records of the seller, or certified service provider on
 20 behalf of the seller, claiming the bad debt allowance support an allocation of the bad debts among the
 21 member states, such an allocation shall be permitted.

22 144.105. 1. The state shall review software submitted to the streamlined sales and use tax
 23 governing board for certification as a certified automated system (CAS) under Section 501 of the
 24 streamlined sales and use tax agreement. Such review shall include a review to determine that the
 25 program adequately classifies the state's product-based exemptions. Upon completion of the review,
 26 the state shall certify to the governing board its acceptance of the classifications made by the system.
 27 The state shall relieve a certified service provider (CSP) or model 2 seller from liability to this state
 28 and its local jurisdictions for failure to collect sales or use taxes resulting from the CSP or model 2
 29 seller's reliance on the certification provided by the state.

30 2. The streamlined sales and use tax governing board and this state shall not be responsible
 31 for classification of an item or transaction with the product-based exemptions. The relief from
 32 liability provided in this section shall not be available for a CSP or model 2 seller that has incorrectly
 33 classified an item or transaction into a product-based exemption certified by this state. This
 34 subsection shall apply to the individual listing of items or transactions within a product definition
 35 approved by the governing board or the state.

36 3. If the state determines that an item or transaction is incorrectly classified as to its
 37 taxability, it shall notify the CSP or model 2 seller of the incorrect classification. The CSP or model
 38 2 seller shall have ten days to revise the classification after receipt of notice from the state of the
 39 determination. Upon expiration of the ten days, such CSP or model 2 seller shall be liable for failure
 40 to collect the correct amount of sales or use taxes due and owing to the state.

41 144.123. 1. The director shall provide and maintain a database that describes boundary
 42 changes for all taxing jurisdictions and the effective dates of such changes for sales and use tax
 43 purposes.

44 2. The director shall provide and maintain a database of all sales and use tax rates for all
 45 taxing jurisdictions. For the identification of counties and cities, codes corresponding to the rates
 46 shall be provided according to Federal Information Processing Standards (FIPS) as developed by the
 47 National Institute of Standards and Technology. For the identification of all other jurisdictions,
 48 codes corresponding to the rates shall be in a format determined by the director.

3. The director shall provide and maintain a database that assigns each five- and nine-digit zip code to the proper rates and taxing jurisdictions. The lowest combined tax rate imposed in the zip code area shall apply if the area includes more than one tax rate in any level of taxing jurisdiction. If a nine-digit zip code designation is not available for a street address, or if a seller or a certified service provider (CSP) is unable to determine the nine-digit zip code designation applicable to a purchase after exercising due diligence to determine the designation, the seller or CSP may apply the rate for the five-digit zip code area. For purposes of this section, there shall be a rebuttable presumption that a seller or CSP has exercised due diligence if the seller has attempted to determine the nine-digit zip code designation by utilizing software approved by the secretary that makes this designation from the street address and the five-digit zip code applicable to a purchase.

4. The director may provide address-based boundary database records for assigning taxing jurisdictions and associated rates which shall be in addition to the requirements of subsection 3 of this section. The database records shall be in the same approved format as the database records required under subsection 3 of this section and shall meet the requirements developed under the federal Mobile Telecommunications Sourcing Act, 4 U.S.C. Section 119(a), as amended. If the director develops address-based assignment database records under the agreement, sellers that register under the agreement shall be required to use such database. A seller or CSP shall use such database records in place of the five- and nine-digit zip code database records provided for in subsection 3 of this section. If a seller or CSP is unable to determine the applicable rate and jurisdiction using an address-based database record after exercising due diligence, the seller or CSP may apply the nine-digit zip code designation applicable to a purchase. If a nine-digit zip code designation is not available for a street address or if a seller or CSP is unable to determine the nine-digit zip code designation applicable to a purchase after exercising due diligence to determine the designation, the seller or CSP may apply the rate for the five-digit zip code area. For the purposes of this section, there shall be a rebuttable presumption that a seller or CSP has exercised due diligence if the seller or CSP has attempted to determine the tax rate and jurisdiction by utilizing software approved by the director and makes the assignment from the address and zip code information applicable to the purchase. If the director has met the requirements of subsection 3 of this section, the director may also elect to certify vendor provided address-based databases for assigning tax rates and jurisdictions. The databases shall be in the same approved format as the database records under this section and meet the requirements developed under the federal Mobile Telecommunications Sourcing Act, 4 U.S.C. Section 119(a), as amended. If the director certifies a vendor address-based database, a seller or CSP may use such database in place of the database provided for in this subsection.

5. The electronic databases provided for in subsections 1, 2, 3, and 4 of this section shall be in downloadable format as determined by the director. The databases may be directly provided by the director or provided by a vendor as designated by the director. A database provided by a vendor as designated by the director shall be applicable and subject to the provisions of section 144.1031 and this section. The databases shall be provided at no cost to the user of the database. The provisions of subsections 3 and 4 of this section shall not apply when the purchased product is received by the purchaser at the business location of the seller.

6. No seller or CSP shall be liable for reliance upon erroneous data provided by the director on tax rates, boundaries, or taxing jurisdiction assignments.

144.124. 1. The director shall complete a taxability matrix. The state's entries in the matrix shall be provided and maintained by the director in a database that is in a downloadable format.

2. The director shall provide reasonable notice of changes in the taxability of the products or services listed in the taxability matrix.

3. A seller or certified service provider (CSP) shall be relieved from liability to this state or

any local taxing jurisdiction for having charged and collected the incorrect amount of state or local sales or use tax resulting from such seller's or CSP's reliance upon erroneous data provided by the director in the taxability matrix.

144.125. 1. (1) Amnesty shall be granted for uncollected or unpaid sales or use tax to a seller who registers to pay or to collect and remit applicable sales or use tax on sales made to purchasers in this state in accordance with the terms of the agreement, provided that the seller was not so registered in this state in the twelve-month period preceding the effective date of this state's participation in the agreement.

(2) Amnesty shall preclude assessment for uncollected or unpaid sales or use tax together with penalty or interest for sales made during the period the seller was not registered in this state, provided registration occurs within twelve months of the effective date of this state's participation in the agreement.

(3) Amnesty shall be provided if this state joins the agreement after the seller has registered.

2. Amnesty shall not be available to a seller with respect to any matter or matters for which the seller received notice of the commencement of an audit and which audit is not yet finally resolved including any related administrative and judicial processes. The amnesty shall not be available for sales or use taxes already paid or remitted to this state or to taxes collected by the seller.

3. Amnesty provided under this section shall be fully effective, absent the seller's fraud or intentional misrepresentation of a material fact, as long as the seller continues registration and payment or collection and remittance of applicable sales or use taxes for a period of at least thirty-six months. The statute of limitations applicable to asserting a tax liability during this thirty-six month period shall be tolled.

4. Amnesty provided under this section shall be applicable only to sales or use taxes due from a seller in its capacity as a seller and not to sales or use taxes due from a seller in its capacity as a purchaser.

5. The provisions of this section shall become effective as of the date that the state joins and becomes a member state of the agreement.

144.140. 1. From every remittance to the director of revenue made on or before the date when the same becomes due, the person required to remit the same shall be entitled to deduct and retain an amount equal to two percent thereof.

2. If the director of the department of revenue enters into the streamlined sales and use tax agreement under section 32.070, the director shall provide a monetary allowance from the taxes collected to each of the following:

(1) A certified service provider, in accordance with the agreement and under the terms of the contract signed with the provider, provided that such allowance shall not exceed two percent of the amount collected;

(2) Any vendor registered under the agreement that selects a certified automated system to perform part of its sales or use tax functions;

(3) Any vendor registered under the agreement that uses a proprietary system to calculate taxes due and has entered into a performance agreement with states that are members to the streamlined sales and use tax agreement.

3. The monetary allowance provided for vendors in subdivision (2) or (3) of subsection 2 of this section shall be in an amount equal to two percent of the taxes collected.

4. Any vendor receiving an allowance under subsection 2 of this section shall not be entitled simultaneously to deduct the allowance provided for in subsection 1 of this section.”; and

Further amend said bill, Page 57, Section 144.190, Line 122, by inserting after all of said section the following:

1 "144.210. 1. The burden of proving that a sale of tangible personal property, services,
 2 substances or things was not a sale at retail shall be upon the person who made the sale, except that
 3 with respect to sales, services, or transactions provided for in section 144.070. [The seller shall
 4 obtain and maintain exemption certificates signed by the purchaser or his agent as evidence for any
 5 exempt sales claimed; provided, however, that before any administrative tribunal of this state, a
 6 seller may prove that sale is exempt from tax under this chapter in accordance with proof admissible
 7 under the applicable rules of evidence; except that when a purchaser has purchased tangible personal
 8 property or services sales tax free under a claim of exemption which is found to be improper, the

 10 the purchaser directly. Any tax, interest, additions to tax or penalty collected by the director from

17 3. The director of revenue shall give to the person written notice of such additional or
 18 revised assessment by certified or registered mail to the person at his or its last known address.

19 144.212. 1. In addition to all other provisions of law provided for exemptions, when an
 20 exemption is claimed by a purchaser:

21 (1) The seller shall obtain identifying information of the purchaser and the reason for
 22 claiming a tax exemption at the time of the purchase;

23 (2) A purchaser shall not be required to provide a signature to claim an exemption from tax
 24 unless a paper exemption certificate is used;

25 (3) The seller shall use the standard form for claiming an exemption electronically
 26 prescribed by the director of the department of revenue and acceptable to the streamlined sales and
 27 use tax governing board;

28 (4) The seller shall obtain the same information for proof of a claimed exemption regardless
 29 of the medium in which the transaction occurred;

30 (5) The seller shall maintain proper records of exempt transactions and provide such records

 39 exemption and such purchaser shall be liable for the nonpayment of tax. Relief from liability
 40 provided under this section shall not apply to a seller who fraudulently fails to collect tax; to a seller
 41 who solicits purchasers to participate in the unlawful claim of an exemption; to a seller who accepts
 42 an exemption certificate when the purchaser claims an entity-based exemption when the subject of
 43 the transaction sought to be covered by the exemption certificate is actually received by the

 47 use for tangible personal property other than computer software for which an exemption claiming
 48 multiple points of use not available in such state.

1 (1) A seller shall be relieved from collecting and remitting tax otherwise applicable if the
 2 seller obtains a fully completed exemption certificate or captures the relevant data elements required
 3 under the agreement within ninety days subsequent to the date of sale.

4 (2) If a seller fails to obtain an exemption certificate or all relevant data elements as provided
 5 in this section, the seller may, within one hundred twenty days subsequent to a request for
 6 substantiation by the director of the department of revenue or the director's designee, either prove
 7 that the transaction was not subject to tax by other means or obtain a fully completed exemption
 8 certificate from the purchaser, taken in good faith.

9 3. Nothing in this section shall affect the ability of the director of the department of revenue
 10 or the director's designee to require purchasers to update exemption certificate information or to

 13 shall relieve a seller of the tax otherwise applicable if the seller obtains a blanket exemption

 16 information or data elements when there is a recurring business relationship between the buyer and
 17 seller. For purposes of this section, a recurring business relationship exists when a period of no more
 18 than twelve months elapses between sales transactions.

19 144.285. 1. [In order to permit sellers required to collect and report the sales tax to collect
 20 the amount required to be reported and remitted, but not to change the requirements of reporting or
 21 remitting tax or to serve as a levy of the tax, and in order to avoid fractions of pennies, the director of
 22 revenue shall establish brackets, showing the amounts of tax to be collected on sales of specified
 23 amounts, which shall be applicable to all taxable transactions] When the seller is computing the
 24 amount of tax owed by the purchaser and remitted to the state:

25 (1) Tax computation shall be carried to the third decimal place; and

26 (2) The tax shall be rounded to a whole cent using a method that rounds up to the next cent
 27 whenever the third decimal place is greater than four.

 37 purchaser by use of a formula which applies the applicable tax rate to each taxable purchase, rounded
 38 to the nearest whole cent. The formula shall be uniformly and consistently applied to all purchases
 39 similarly situated.

40 5.] Amounts which a vendor charges to and receives from the purchaser in accordance with
 41 this section shall not be includable in his gross receipts if the amounts are separately charged or
 42 stated.

43 [6.] 5. If sales tax for one or more local political subdivisions is owed by a taxpayer pursuant
 44 to chapter 66, 67, 92, or 94 and that taxpayer remits less than all sales tax due for a filing period
 45 specified in section 144.080, the director of revenue shall deposit the tax remitted proportionately to
 46 each taxing jurisdiction in accordance with the percentage that each such jurisdiction's share of the
 47 tax due for the filing period bears to the total tax due from such taxpayer for such period. The
 48 unpaid balance due along with penalties and interest shall be similarly prorated among the state and

all local jurisdictions for which tax was due during the filing period for which an underpayment occurs. The provisions of this subsection shall apply to all returns or remittances relating to sales made on or after January 1, 1984."; and

Further amend said bill, Page 60, Section 144.525, Line 9, by inserting after all of said section the following:

"144.526. 1. This section shall be known and may be cited as the "Show Me Green Sales Tax Holiday".

2. [For purposes of this section, the following terms mean:

(1) "Appliance", clothes washers and dryers, water heaters, trash compactors, dishwashers, conventional ovens, ranges, stoves, air conditioners, furnaces, refrigerators and freezers; and

(2) "Energy star certified", any appliance approved by both the United States Environmental Protection Agency and the United States Department of Energy as eligible to display the energy star label, as amended from time to time.

3.] In each year beginning on or after January 1, 2009, there is hereby specifically exempted from state sales tax law all retail sales of any [energy star certified] new appliance that is an energy star qualified product, up to one thousand five hundred dollars per appliance, during a seven-day period beginning at 12:01 a.m. on April nineteenth and ending at midnight on April twenty-fifth.

[4. A political subdivision may allow the sales tax holiday under this section to apply to its local sales taxes by enacting an ordinance to that effect. Any such political subdivision shall notify the department of revenue not less than forty-five calendar days prior to the beginning date of the sales tax holiday occurring in that year of any such ordinance or order.

5. This section may not apply to any retailer when less than two percent of the retailer's merchandise offered for sale qualifies for the sales tax holiday. The retailer shall offer a sales tax refund in lieu of the sales tax holiday.]"

Further amend said bill, Page 61, Section 144.615, Line 21, by inserting after all of said section the following:

"144.655. 1. Every vendor, on or before the last day of the month following each calendar quarterly period of three months, shall file with the director of revenue a return of all taxes collected for the preceding quarter in the form prescribed by the director of revenue, showing the total sales price of the tangible personal property sold by the vendor, the storage, use or consumption of which is subject to the tax levied by this law, and other information the director of revenue deems necessary. The return shall be accompanied by a remittance of the amount of the tax required to be collected by the vendor during the period covered by the return. Returns shall be signed by the vendor or the vendor's authorized agent. personal property, the storage, use or consumption of which is subject to the tax levied by sections 144.600 to 144.748, who has not paid the tax due to a vendor registered in accordance with the provisions of section 144.650, shall file with the director of revenue a return for the preceding reporting period in the form and manner that the director of revenue prescribes, showing the total sales price of the tangible property purchased during the preceding reporting period and any other information that the director of revenue deems necessary for the proper administration of sections 144.600 to 144.748. 7 "County Transit Authority Sales Tax Trust Fund". The moneys in the county transit authority sales
8 tax trust fund shall not be deemed to be state funds and shall not be commingled with any funds of
9 the state. The director of revenue shall keep accurate records of the amount of money in the trust
10 fund which was collected in each transit authority imposing a sales tax under this section, and the
11 records shall be open to the inspection of officers of the county and the public. Not later than the
12 tenth day of each month the director of revenue shall distribute all moneys deposited in the trust fund
13 during the preceding month to the transit authority which levied the tax.

14 [10.] 9. The director of revenue may authorize the state treasurer to make refunds from the
15 amounts in the trust fund and credited to any transit authority for erroneous payments and
16 overpayments made, and may authorize the state treasurer to redeem dishonored checks and drafts
17 deposited to the credit of such transit authorities. If any transit authority abolishes the tax, the transit
18 authority shall notify the director of revenue of the action at least ninety days prior to the effective
19 date of the repeal and the director of revenue may order retention in the trust fund, for a period of
20 one year, of two percent of the amount collected after receipt of such notice to cover possible refunds
21 or overpayment of the tax and to redeem dishonored checks and drafts deposited to the credit of such
22 accounts. After one year has elapsed after the effective date of abolition of the tax in such transit

24 account to the transit authority and close the account of that transit authority. The director of
25 revenue shall notify each transit authority of each instance of any amount refunded or any check
26 redeemed from receipts due the transit authority. The director of revenue shall annually report on his
27 management of the trust fund and administration of the sales taxes authorized by this section. He
28 shall provide each transit authority imposing the tax authorized by this section with a detailed
29 accounting of the source of all funds received by him for the transit authority.

30 [11.] 10. The director of revenue and any of his deputies, assistants and employees who shall
31 have any duties or responsibilities in connection with the collection, deposit, transfer, transmittal,
32 disbursement, safekeeping, accounting, or recording of funds which come into the hands of the
33 director of revenue under the provisions of this section shall enter a surety bond or bonds payable to
34 any and all transit authorities in whose behalf such funds have been collected under this section in
35 the amount of one hundred thousand dollars; but the director of revenue may enter into a blanket
36 bond or bonds covering himself and all such deputies, assistants and employees. The cost of the
37 premium or premiums for the surety bond or bonds shall be paid by the director of revenue from the
38 share of the collection retained by the director of revenue for the benefit of the state.

39 [12.] 11. Sales taxes imposed pursuant to this section and use taxes on the purchase and sale
40 of motor vehicles, trailers, boats, and outboard motors shall not be collected and remitted by the
41 seller, but shall be collected by the director of revenue at the time application is made for a certificate
42 of title, if the address of the applicant is within a county where a sales tax is imposed under this
43 section. The amounts so collected, less the one percent collection cost, shall be deposited in the
44 county transit authority sales tax trust fund. The purchase or sale of motor vehicles, trailers, boats,
45 and outboard motors shall be deemed to be consummated at the address of the applicant. As used in
46 this subsection, the term "boat" shall only include motorboats and vessels as the terms "motorboat"
47 and "vessel" are defined in section 306.010.

48 [13.] 12. In any county where the transit authority sales tax has been imposed, if any person

is delinquent in the payment of the amount required to be paid by him under this section or in the event a determination has been made against him for taxes and penalty under this section, the limitation for bringing suit for the collection of the delinquent tax and penalty shall be the same as that provided in sections 144.010 to 144.525. Where the director of revenue has determined that suit must be filed against any person for the collection of delinquent taxes due the state under the state sales tax law, and where such person is also delinquent in payment of taxes under this section, the director of revenue shall notify the transit authority to which delinquent taxes are due under this section by United States registered mail or certified mail at least ten days before turning the case over to the attorney general. The transit authority, acting through its attorney, may join in such suit as a party plaintiff to seek a judgment for the delinquent taxes and penalty due such transit authority. In the event any person fails or refuses to pay the amount of any sales tax due under this section, the director of revenue shall promptly notify the transit authority to which the tax would be due so that appropriate action may be taken by the transit authority.

[14.] 13. Where property is seized by the director of revenue under the provisions of any law authorizing seizure of the property of a taxpayer who is delinquent in payment of the tax imposed by the state sales tax law, and where such taxpayer is also delinquent in payment of any tax imposed by this section, the director of revenue shall permit the transit authority to join in any sale of property to pay the delinquent taxes and penalties due the state and to the transit authority under this section. The proceeds from such sale shall first be applied to all sums due the state, and the remainder, if any, shall be applied to all sums due such transit authority under this section.

[15. The transit authority created under the provisions of sections 238.400 to 238.412 shall notify any and all affected businesses of the change in tax rate caused by the imposition of the tax authorized by sections 238.400 to 238.412.

16.] 14. In the event that any transit authority in any county with a charter form of government and with more than two hundred fifty thousand but fewer than three hundred fifty thousand inhabitants submits a proposal in any election to increase the sales tax under this section, and such proposal is approved by the voters, the county shall be reimbursed for the costs of submitting such proposal from the funds derived from the tax levied under this section.

15. Except as provided in sections 238.400 to 238.412, all provisions of sections 32.085 to 32.087 shall apply to the tax imposed under sections 238.410 to 238.412."; and

Further amend said bill, Page 130, Section 577.041, Line 138, by inserting after all of said section the following:

"644.032. 1. The governing body of any municipality or county may impose, by ordinance or order, a sales tax in an amount not to exceed one-half of one percent on all retail sales made in such municipality or county which are subject to taxation under the provisions of sections 144.010 to 144.525. The tax authorized by this section and section 644.033 shall be in addition to any and all other sales taxes allowed by law, except that no ordinance or order imposing a sales tax under the provisions of this section and section 644.033 shall be effective unless the governing body of the municipality or county submits to the voters of the municipality or county, at a municipal, county or state general, primary or special election, a proposal to authorize the governing body of the municipality or county to impose a tax[, provided, that the tax authorized by this section shall not be imposed on the sales of food, as defined in section 144.014, when imposed by any county with a charter form of government and with more than one million inhabitants].

If a majority of the votes cast on the proposal by the qualified voters voting thereon are in favor of the proposal, then the ordinance or order and any amendments thereto shall be in effect on the first day of the second quarter after the director of revenue receives notice of adoption of the tax. If a majority of the votes cast by the qualified voters voting are opposed to the proposal, then the governing body of the municipality or county shall not impose the sales tax authorized in this section and section 644.033 until the governing body of the municipality or county resubmits another proposal to authorize the governing body of the municipality or county to impose the sales tax authorized by this section and section 644.033 and such proposal is approved by a majority of the qualified voters voting thereon; however, in no event shall a proposal pursuant to this section and section 644.033 be submitted to the voters sooner than twelve months from the date of the last proposal pursuant to this section and section 644.033.

30 various levels of complexity to be completed by July 1, 2003;
- 31 (7) The agreement should require each state to certify compliance with the terms of
32 the agreement prior to joining and to maintain compliance, under the laws of the
33 member state, with all provisions of the agreement while a member, only if the
34 agreement and any amendment thereto complies with the provisions of section
35 144.1012;
- 36 (8) The agreement should require each state to adopt a uniform policy for certified
37 service providers that protects the privacy of consumers and maintains the
38 confidentiality of tax information; and
- 39 (9) The agreement should provide for the appointment of an advisory council of
40 private sector representatives and an advisory council of nonmember state
41 representatives to consult with in the administration of the agreement.]" and
