1 AMEND House Committee Substitute for Senate Committee Substitute for Senate Bill No. 88, Page
2 5, Section 197.100, Line 31, by inserting after all of said Section and Line the following:

4 "198.310. 1. For the purpose of purchasing nursing home district sites, erecting nursing
5 homes and related facilities and furnishing the same, building additions to and repairing old
6 buildings, the board of directors may borrow money and issue bonds for the payment thereof in the
7 manner provided herein. The question of the loan shall be submitted by an order of the board of
8 directors of the district. Notice of the submission of the question, the amount and the purpose of the
9 loan shall be given as provided in section 198.250.

10 2. The question shall be submitted in substantially the following form:

11 Shall the Nursing Home District borrow money in the amount of dollars for the
12 purpose of and issue bonds in payment thereof?

13 3. If [two-thirds] the constitutionally required percentage of the votes cast are for the loan,
14 the board shall, subject to the restrictions of subsection 4, be vested with the power to borrow money
15 in the name of the district, to the amount and for the purposes specified on the ballot, and issue the
16 bonds of the district for the payment thereof.

17 4. The loans authorized by this section shall not be contracted for a period longer than
18 twenty years, and the entire amount of the loan shall at no time exceed, including the existing
19 indebtedness of the district, in the aggregate, ten percent of the value of taxable tangible property
20 therein, as shown by the last completed assessment for state and county purposes, the rate of interest
21 to be agreed upon by the parties, but in no case to exceed the highest legal rate allowed by contract;
22 when effected, it shall be the duty of the directors to provide for the collection of an annual tax
23 sufficient to pay the interest on the indebtedness as it falls due, and also to constitute a sinking fund
24 for the payment of the principal thereof within the time the principal becomes due.

25 198.345. Nothing in sections 198.200 to 198.350 shall prohibit a nursing home district from
26 establishing and maintaining apartments for seniors that provide at a minimum housing[, and food
27 services[, and emergency call buttons to the apartment residents] in any county of the third or fourth
28 classification [without a township form of government and with more than twenty-eight thousand
29 two hundred but fewer than twenty-eight thousand three hundred inhabitants or any county of the
30 third classification without a township form of government and with more than nine thousand five
31 hundred fifty but fewer than nine thousand six hundred fifty inhabitants] within its corporate limits.
32 Such nursing home districts shall not lease such apartments for less than fair market rent as reported
33 by the United States Department of Housing and Urban Development."; and

35 Further amend said bill by amending the title, enacting clause, and intersectional references
36 accordingly.
