1 AMEND Senate Committee Substitute for Senate Bill No. 224, Page 4, Section 84.490, Line 66, by
2 inserting after all of said section and line the following:

3 "313.817. 1. Except as permitted in this section, the licensee licensed to operate gambling
4 games shall permit no form of wagering on gambling games.

5 2. The licensee may receive wagers only from a person present on a licensed excursion
6 gambling boat.

7 3. Wagering shall not be conducted with money or other negotiable currency. The licensee
8 shall exchange the money of each wagerer for electronic or physical tokens, chips, or other forms of
9 credit to be wagered on the gambling games. The licensee shall exchange the tokens, chips, or other
10 forms of wagering credit for money at the request of the wagerer.

11 4. A person under twenty-one years of age shall not make a wager on an excursion gambling
12 boat and shall not be allowed in the area of the excursion boat where gambling is being conducted;
13 provided that employees of the licensed operator of the excursion gambling boat who have attained
14 eighteen years of age shall be permitted in the area in which gambling is being conducted when
15 performing employment-related duties, except that no one under twenty-one years of age may be
16 employed as a dealer or accept a wager on an excursion gambling boat. The governing body of a
17 home dock city or county may restrict the age of entrance onto an excursion gambling boat by
18 passage of a local ordinance.

19 5. In order to help protect patrons from invasion of privacy and the possibility of identity
20 theft, patrons shall not be required to provide fingerprints, retinal scans, biometric forms of
21 identification, any type of patron-tracking cards, or other types of identification prior to being
22 permitted to enter the area where gambling is being conducted on an excursion gambling boat or to
23 make a wager, except that, for purposes of establishing that a patron is at least twenty-one years of
24 age as provided in subsection 4 above, a licensee operating an excursion gambling boat shall be
25 authorized to request such patron to provide a valid state or federal photo identification or a valid
26 passport. This section shall not prohibit enforcement of identification requirements that are required
27 by federal law. This section shall not prohibit enforcement of any Missouri statute requiring
28 identification of patrons for reasons other than being permitted to enter the area of an excursion
29 gambling boat where gambling is being conducted or to make a wager.

30 6. A licensee shall only allow wagering and conduct gambling games at the times allowed by
31 the commission.

32 7. It shall be unlawful for a person twenty-one years of age or older to present false
33 identification to a licensee or a gaming agent in order to gain entrance to an excursion gambling
34 boat, cash a check or verify that such person is legally entitled to be present on the excursion
35 gambling boat. Any person who violates the provisions of this subsection shall be guilty of a class B
36 misdemeanor for the first offense and a class A misdemeanor for second and subsequent offenses.

37 8. It shall be unlawful for a person under twenty-one years of age to present false identification to a

1 licensee or a gaming agent in order to gain entrance to an excursion gambling boat, cash a check or
2 verify that such person is legally entitled to be present on the excursion gambling boat. Any person
3 who violates the provisions of this subsection shall be fined five hundred dollars and guilty of an
4 infraction for the first offense and a class B misdemeanor for second and subsequent offenses.
5 Notwithstanding any other provision of law to the contrary, any fines collected for offenses
6 committed under this subsection shall be deposited into the Veterans Commission Capitol
7 Improvement Trust Fund established in section 42.300."; and

9 Further amend said bill by amending the title, enacting clause, and intersectional references
10 accordingly.
