FISCAL ANALYSIS

ASSUMPTION

Officials from the **Office of the State Courts Administrator** assume the proposal authorizes the clerk of the circuit court to charge and collect a surcharge of up to \$10 in cases where a garnishment is granted.

Based on data for the past four years, FY 2009 through FY 2012, CTS assumes that the average is approximately 237,354 executions and garnishments on which this surcharge could be applied. CTS assumes all circuit courts would collect the \$10 surcharge and anticipate revenues would be approximately \$2,373,540 in any given year.

FISCAL IMPACT - Small Business

No direct fiscal impact to small businesses would be expected as a result of this proposal.

FISCAL DESCRIPTION

This bill allows the clerk of the circuit court to charge and collect a surcharge of up to \$10 in cases where a garnishment is granted. Any moneys collected must be placed in a fund to be used at the discretion of the circuit clerk to maintain and improve case processing and record preservation.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
