ASSUMPTION

Officials from the **Department of Insurance, Financial Institutions and Professional Registration** assume the proposal creates new requirements for licensing navigators in Missouri. Due to these new regulatory requirements, the department will need one (1.00) Licensing Technician I FTE to review and process navigator licensure applications and one (1.00) Investigator II FTE to ensure compliance with these new requirements and investigate consumer complaints against navigators. The department will require minimal contract computer programming to add these new requirements to our current licensing system and can do so under existing appropriation.

FISCAL DESCRIPTION

This proposal creates an insurance navigator licensing system so that no individual or entity shall perform, offer to perform, or advertise any service as a navigator in Missouri or receive navigator funding from a health insurance exchange unless licensed as a navigator by the Department of Insurance, Financial Institutions and Professional Registration. The proposal sets forth provisions concerning prohibited activities, applications for licensure, license renewal, and revocations and suspensions of navigator licenses.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
