WHEREAS, this resolution affirms Missouri's sovereignty under the Tenth Amendment to the Constitution of the United States and demands the federal government to halt its practice of assuming powers and imposing mandates upon the state for purposes not enumerated by the Constitution of the United States; and
WHEREAS, Article I, Section 1 of the Missouri Constitution states:
"That all political power is vested in and derived from the people; that all government of right originates from the people, is founded upon their will only, and is instituted solely for the good of the whole."; and
<b>WHEREAS</b> , the Tenth Amendment to the Constitution of the United States reads a follows:
"The powers not delegated to the United States by the Constitution, nor prohibited by it to the States, are reserved to the States respectively, or to the people."; and
WHEREAS, the Tenth Amendment to the Constitution of the United States assures that each sovereign State possesses rights the federal government may not usurp; and
WHEREAS, the Tenth Amendment to the Constitution of the United States defines the total scope of federal power as being that specifically granted by the Constitution of the United States and no more; and
<b>WHEREAS</b> , the scope of power defined by the Tenth Amendment to the Constitution of the United States means that the federal government was created by the states specifically to be an agent of the states; and

30 31	<b>WHEREAS</b> , today, in 2013, the states are demonstrably treated as agents of the federal government; and

33 34	<b>WHEREAS</b> , many federal laws are directly in violation of the Tenth Amendment to the Constitution of the United States; and

36 37 38 39 40	WHEREAS, Article IV, Section 4 of the Constitution of the United States reads that "The United States shall guarantee to every State in this Union a Republican Form of Government" and the Ninth Amendment to the Constitution of the United States reads that "The enumeration in the Constitution, of certain rights, shall not be construed to deny or disparage others retained by the people."; and

42 43 44	<b>WHEREAS</b> , the United States Supreme Court has ruled in <i>New York v. United States</i> , 112 S.Ct. 2408 (1992), that Congress may not simply commandeer the legislative and regulatory processes of the states; and

46 47 48	<b>WHEREAS</b> , a number of proposals from previous administrations and some now pending from the present administration and from Congress may further violate the Constitution of the United States and the Missouri Constitution:

50 51 52 53 54	NOW, THEREFORE, BE IT RESOLVED that the members of the House of Representatives of the Ninety-seventh General Assembly, First Regular Session, the Senate concurring therein, hereby claims sovereignty under the Tenth Amendment to the Constitution of the United States over all powers not otherwise enumerated and granted to the federal government by the Constitution of the United States; and

56 57 58	<b>BE IT FURTHER RESOLVED</b> that this concurrent resolution serve as Notice and Demand to the federal government, as our agent, to cease and desist, effective immediately, mandates that are beyond the scope of these constitutionally delegated powers; and

60 61 62	<b>BE IT FURTHER RESOLVED</b> that all compulsory federal legislation which directs states to comply under threat of civil or criminal penalties or sanctions or requires states to pass legislation or lose federal funding be prohibited or repealed; and

**BE IT FURTHER RESOLVED** that the sovereign State of Missouri reserves the right to declare any such Act void by the Congress of the United States, Executive Order of the President of the United States of America, or Judicial Order by the Judicatories of the United States of America which assumes a power not delegated to the government of the United States of America by the Constitution of the United States of America and which serves to diminish the liberty of any of the several States or their citizens are unconstitutional under the Constitution of the United States of America; and

**BE IT FURTHER RESOLVED** that the Chief Clerk of the Missouri House of Representatives be instructed to prepare a properly inscribed copy of this resolution for the President of the United States, the President of the United States Senate, the Speaker of the United States House of Representatives, the Speaker of the House of Representatives and President of the Senate of each state's legislature, and each member of the Missouri Congressional delegation.
