1 AMEND House Committee Substitute for Senate Bill No. 614, Page 1, Section A, Line 4, by
2 inserting after all of said section and line the following:

3 "43.650. 1. The patrol shall, subject to appropriation, maintain a web page on the internet
4 which shall be open to the public and shall include a registered sexual offender search capability.

5 2. The registered sexual offender search shall make it possible for any person using the
6 internet to search for and find the information specified in subsection 4 of this section, if known, on
7 offenders registered in this state pursuant to sections 589.400 to 589.425, except that only persons
8 who have been convicted of, found guilty of or plead guilty to committing, attempting to commit, or
9 conspiring to commit sexual offenses shall be included on this website.

10 3. The registered sexual offender search shall include the capability to search for sexual
11 offenders by name, zip code, and by typing in an address and specifying a search within a certain
12 number of miles radius from that address.

13 4. Only the information listed in this subsection shall be provided to the public in the
14 registered sexual offender search:

15 (1) The name and any known aliases of the offender;

16 (2) The date of birth and any known alias dates of birth of the offender;

17 (3) A physical description of the offender;

18 (4) The residence, temporary, work, and school addresses of the offender, including the street
19 address, city, county, state, and zip code;

20 (5) Any photographs of the offender;

21 (6) A physical description of the offender's vehicles, including the year, make, model, color,
22 and license plate number;

23 (7) The nature and dates of all offenses qualifying the offender to register;

24 (8) The date on which the offender was released from the department of mental health,
25 prison,

26 or jail, or placed on parole, supervised release, or probation for the offenses qualifying the offender
27 to register;

28 (9) Compliance status of the offender with the provisions of section 589.400 to 589.425; and

29 (10) Any online identifiers, as defined in section 43.651, used by the person. Such online
30 identifiers shall not be included in the general profile of an offender on the web page and shall only
31 be available to a member of the public by a search using the specific online identifier to determine if
32 a match exists with a registered offender.

33 5. No person required to register under sections 589.400 to 589.425 for an offense committed
34 in Missouri or any other state or jurisdiction who was under seventeen years of age at the time of the
35 commission of the offense requiring registration shall have his or her information published on the
36 internet web page described in this section. Any person currently on the internet web page who was

1 under eighteen years of age at the time of the commission of the offense in Missouri or any other
 2 state or jurisdiction requiring registration under this section shall be immediately removed from the
 3 internet web page."; and

5 Further amend said bill, Page 2, Section 477.180, Line 2, by inserting after all of said section and
 6 line the following:

7 "589.402. 1. The chief law enforcement officer of the county or city not within a county may
 8 maintain a web page on the internet, which shall be open to the public and shall include a registered
 9 sexual offender search capability.

10 2. The registered sexual offender search shall make it possible for any person using the
 11 internet to search for and find the information specified in subsection 3 of this section, if known, on
 12 offenders registered in this state pursuant to sections 589.400 to 589.425, except that only persons
 13 who have been convicted of, found guilty of, or plead guilty to committing, attempting to commit, or
 14 conspiring to commit sexual offenses shall be included on this website.

15 3. Only the information listed in this subsection shall be provided to the public in the
 16 registered sexual offender search:

- 17 (1) The name and any known aliases of the offender;
- 18 (2) The date of birth and any known alias dates of birth of the offender;
- 19 (3) A physical description of the offender;

- 29 (9) Compliance status of the offender with the provisions of sections 589.400 to 589.425; and
- 30 (10) Any online identifiers, as defined in section 43.651, used by the person. Such online
- 31 identifiers shall not be included in the general profile of an offender on the web page and shall only
- 32 be available to a member of the public by a search using the specific online identifier to determine if
- 33 a match exists with a registered offender.

34 4. The chief law enforcement officer of any county or city not within a county may publish in
 35 any newspaper distributed in the county or city not within a county the sexual offender information
 36 provided under subsection 3 of this section for any offender residing in the county or city not within
 37 a county.

38 5. No person required to register under sections 589.400 to 589.425 for an offense committed
 39 in Missouri or any other state or jurisdiction who was under seventeen years of age at the time of the
 40 commission of the offense requiring registration shall have his or her information published on the
 41 internet web page described in this section. Any person currently on the internet web page who was
 42 under eighteen years of age at the time of the commission of the offense in Missouri or any other
 43 state or jurisdiction requiring registration under this section shall be immediately removed from the
 44 internet web page."; and
