1 AMEND House Committee Substitute for House Bill No. 1689, Page 3, Section 160.055, Line 26,
2 by inserting immediately after said line the following:

4 "162.1265. 1. The department of elementary and secondary education shall develop and
5 implement a grant program for unaccredited and provisionally accredited districts that commit to
6 extended instructional time for the purpose of improving academic achievement, including but not
7 limited to early childhood education. Such grants shall be for a two-year term and shall be
8 renewable for up to three additional two-year terms.

9 2. To be eligible for a grant a school district shall:

10 (1) Demonstrate that it has analyzed its current use of instructional time and determined the
11 potential effects of additional instructional time on student academic achievement. The analysis
12 shall also include a study of the potential effects of extended instructional time on assignments of
13 personnel and on the need for professional development; and

14 (2) Provide a rationale for the method of adding instructional time, whether it is a longer
15 school year, longer day, fewer days between school years or school terms, or early childhood
16 program, as applied to the chosen target student population which may include an entire school
17 district, particular building, or small group.

18 3. Grant award amounts shall be proportional to additional instructional time over the
19 minimum hours required by law and the average daily attendance rate of the affected students.
20 Unaccredited districts shall receive priority.

21 4. There is hereby established in the state treasury a fund to be known as the "Extended
22 Instructional Time Fund", which shall consist of all moneys that may be appropriated to it by the
23 general assembly, and in addition may include any gifts, contributions, grants, or bequests received
24 from federal, state, private, or other sources. The fund shall be administered by the department of
25 elementary and secondary education. The state treasurer shall be custodian of the fund and may
26 approve disbursements from the fund in accordance with sections 30.170 and 30.180. Upon
27 appropriation, moneys in the fund shall be used solely for the administration of the extended
28 instructional time program. Notwithstanding the provisions of section 33.080 to the contrary, any
29 moneys remaining in the fund at the end of the biennium shall not revert to the credit of the general
30 revenue fund. The state treasurer shall invest moneys in the fund in the same manner as other funds
31 are invested. Any interest and moneys earned on such investments shall be credited to the fund.

32 5. Any rule or portion of a rule, as that term is defined in section 536.010, that is created
33 under the authority delegated in this section shall become effective only if it complies with and is
34 subject to all of the provisions of chapter 536 and, if applicable, section 536.028. This section and
35 chapter 536 are nonseverable and if any of the powers vested with the general assembly pursuant to
36 chapter 536 to review, to delay the effective date, or to disapprove and annul a rule are subsequently

1 held unconstitutional, then the grant of rulemaking authority and any rule proposed or adopted after
2 August 28, 2014, shall be invalid and void."; and

5 accordingly.
