1 AMEND House Committee Substitute for House Bill No. 1662, Page 3, Section 191.875, Line 80,
2 by inserting after all of said section and line the following:

4 "208.151. 1. Medical assistance on behalf of needy persons shall be known as "MO
5 HealthNet". For the purpose of paying MO HealthNet benefits and to comply with Title XIX, Public
6 Law 89-97, 1965 amendments to the federal Social Security Act (42 U.S.C. Section 301, et seq.) as
7 amended, the following needy persons shall be eligible to receive MO HealthNet benefits to the
8 extent and in the manner hereinafter provided:

9 (1) All participants receiving state supplemental payments for the aged, blind and disabled;

10 (2) All participants receiving aid to families with dependent children benefits, including all
11 persons under nineteen years of age who would be classified as dependent children except for the
12 requirements of subdivision (1) of subsection 1 of section 208.040. Participants eligible under this
13 subdivision who are participating in drug court, as defined in section 478.001, shall have their
14 eligibility automatically extended sixty days from the time their dependent child is removed from the
15 custody of the participant, subject to approval of the Centers for Medicare and Medicaid Services;

16 (3) All participants receiving blind pension benefits;

17 (4) All persons who would be determined to be eligible for old age assistance benefits,
18 permanent and total disability benefits, or aid to the blind benefits under the eligibility standards in
19 effect December 31, 1973, or less restrictive standards as established by rule of the family support
20 division, who are sixty-five years of age or over and are patients in state institutions for mental
21 diseases or tuberculosis;

22 (5) All persons under the age of twenty-one years who would be eligible for aid to families
23 with dependent children except for the requirements of subdivision (2) of subsection 1 of section
24 208.040, and who are residing in an intermediate care facility, or receiving active treatment as
25 inpatients in psychiatric facilities or programs, as defined in 42 U.S.C. 1396d, as amended;

26 (6) All persons under the age of twenty-one years who would be eligible for aid to families
27 with dependent children benefits except for the requirement of deprivation of parental support as
28 provided for in subdivision (2) of subsection 1 of section 208.040;

29 (7) All persons eligible to receive nursing care benefits;

30 (8) All participants receiving family foster home or nonprofit private child-care institution
31 care, subsidized adoption benefits and parental school care wherein state funds are used as partial or

1 full payment for such care;

2 (9) All persons who were participants receiving old age assistance benefits, aid to the
3 permanently and totally disabled, or aid to the blind benefits on December 31, 1973, and who
4 continue to meet the eligibility requirements, except income, for these assistance categories, but who
5 are no longer receiving such benefits because of the implementation of Title XVI of the federal
6 Social Security Act, as amended;

7 (10) Pregnant women who meet the requirements for aid to families with dependent
8 children, except for the existence of a dependent child in the home;

9 (11) Pregnant women who meet the requirements for aid to families with dependent
10 children, except for the existence of a dependent child who is deprived of parental support as
11 provided for in subdivision (2) of subsection 1 of section 208.040;

12 (12) Pregnant women or infants under one year of age, or both, whose family income does
13 not exceed an income eligibility standard equal to one hundred eighty-five percent of the federal
14 poverty level as established and amended by the federal Department of Health and Human Services,
15 or its successor agency;

16 (13) Children who have attained one year of age but have not attained six years of age who
17 are eligible for medical assistance under 6401 of P.L. 101-239 (Omnibus Budget Reconciliation Act
18 of 1989). The family support division shall use an income eligibility standard equal to one hundred
19 thirty-three percent of the federal poverty level established by the Department of Health and Human
20 Services, or its successor agency;

21 (14) Children who have attained six years of age but have not attained nineteen years of age.
22 For children who have attained six years of age but have not attained nineteen years of age, the
23 family support division shall use an income assessment methodology which provides for eligibility
24 when family income is equal to or less than equal to one hundred percent of the federal poverty level
25 established by the Department of Health and Human Services, or its successor agency. As necessary
26 to provide MO HealthNet coverage under this subdivision, the department of social services may
27 revise the state MO HealthNet plan to extend coverage under 42 U.S.C. 1396a (a)(10)(A)(i)(III) to
28 children who have attained six years of age but have not attained nineteen years of age as permitted
29 by paragraph (2) of subsection (n) of 42 U.S.C. 1396d using a more liberal income assessment
30 methodology as authorized by paragraph (2) of subsection (r) of 42 U.S.C. 1396a;

31 (15) The family support division shall not establish a resource eligibility standard in
32 assessing eligibility for persons under subdivision (12), (13) or (14) of this subsection. The MO
33 HealthNet division shall define the amount and scope of benefits which are available to individuals
34 eligible under each of the subdivisions (12), (13), and (14) of this subsection, in accordance with the
35 requirements of federal law and regulations promulgated thereunder;

36 (16) Notwithstanding any other provisions of law to the contrary, ambulatory prenatal care
37 shall be made available to pregnant women during a period of presumptive eligibility pursuant to 42
38 U.S.C. Section 1396r-1, as amended;

39 (17) A child born to a woman eligible for and receiving MO HealthNet benefits under this
40 section on the date of the child's birth shall be deemed to have applied for MO HealthNet benefits
41 and to have been found eligible for such assistance under such plan on the date of such birth and to

1 remain eligible for such assistance for a period of time determined in accordance with applicable
2 federal and state law and regulations so long as the child is a member of the woman's household and
3 either the woman remains eligible for such assistance or for children born on or after January 1,
4 1991, the woman would remain eligible for such assistance if she were still pregnant. Upon
5 notification of such child's birth, the family support division shall assign a MO HealthNet eligibility
6 identification number to the child so that claims may be submitted and paid under such child's
7 identification number;

8 (18) Pregnant women and children eligible for MO HealthNet benefits pursuant to
9 subdivision (12), (13) or (14) of this subsection shall not as a condition of eligibility for MO
10 HealthNet benefits be required to apply for aid to families with dependent children. The family
11 support division shall utilize an application for eligibility for such persons which eliminates
12 information requirements other than those necessary to apply for MO HealthNet benefits. The
13 division shall provide such application forms to applicants whose preliminary income information
14 indicates that they are ineligible for aid to families with dependent children. Applicants for MO
15 HealthNet benefits under subdivision (12), (13) or (14) of this subsection shall be informed of the aid
16 to families with dependent children program and that they are entitled to apply for such benefits.
17 Any forms utilized by the family support division for assessing eligibility under this chapter shall be
18 as simple as practicable;

19 (19) Subject to appropriations necessary to recruit and train such staff, the family support
20 division shall provide one or more full-time, permanent eligibility specialists to process applications
21 for MO HealthNet benefits at the site of a health care provider, if the health care provider requests
22 the placement of such eligibility specialists and reimburses the division for the expenses including
23 but not limited to salaries, benefits, travel, training, telephone, supplies, and equipment of such
24 eligibility specialists. The division may provide a health care provider with a part-time or temporary
25 eligibility specialist at the site of a health care provider if the health care provider requests the
26 placement of such an eligibility specialist and reimburses the division for the expenses, including but
27 not limited to the salary, benefits, travel, training, telephone, supplies, and equipment, of such an
28 eligibility specialist. The division may seek to employ such eligibility specialists who are otherwise
29 qualified for such positions and who are current or former welfare participants. The division may
30 consider training such current or former welfare participants as eligibility specialists for this
31 program;

32 (20) Pregnant women who are eligible for, have applied for and have received MO
33 HealthNet benefits under subdivision (2), (10), (11) or (12) of this subsection shall continue to be
34 considered eligible for all pregnancy-related and postpartum MO HealthNet benefits provided under
35 section 208.152 until the end of the sixty-day period beginning on the last day of their pregnancy;

36 (21) Case management services for pregnant women and young children at risk shall be a
37 covered service. To the greatest extent possible, and in compliance with federal law and regulations,
38 the department of health and senior services shall provide case management services to pregnant
39 women by contract or agreement with the department of social services through local health
40 departments organized under the provisions of chapter 192 or chapter 205 or a city health department
41 operated under a city charter or a combined city-county health department or other department of

1 health and senior services designees. To the greatest extent possible the department of social services
2 and the department of health and senior services shall mutually coordinate all services for pregnant
3 women and children with the crippled children's program, the prevention of intellectual disability
4 and developmental disability program and the prenatal care program administered by the department
5 of health and senior services. The department of social services shall by regulation establish the
6 methodology for reimbursement for case management services provided by the department of health
7 and senior services. For purposes of this section, the term "case management" shall mean those
8 activities of local public health personnel to identify prospective MO HealthNet-eligible high-risk
9 mothers and enroll them in the state's MO HealthNet program, refer them to local physicians or local
10 health departments who provide prenatal care under physician protocol and who participate in the
11 MO HealthNet program for prenatal care and to ensure that said high-risk mothers receive support
12 from all private and public programs for which they are eligible and shall not include involvement in
13 any MO HealthNet prepaid, case-managed programs;

14 (22) By January 1, 1988, the department of social services and the department of health and
15 senior services shall study all significant aspects of presumptive eligibility for pregnant women and
16 submit a joint report on the subject, including projected costs and the time needed for
17 implementation, to the general assembly. The department of social services, at the direction of the
18 general assembly, may implement presumptive eligibility by regulation promulgated pursuant to
19 chapter 207;

20 (23) All participants who would be eligible for aid to families with dependent children
21 benefits except for the requirements of paragraph (d) of subdivision (1) of section 208.150;

22 (24) (a) All persons who would be determined to be eligible for old age assistance benefits
23 under the eligibility standards in effect December 31, 1973, as authorized by 42 U.S.C. Section
24 1396a(f), or less restrictive methodologies as contained in the MO HealthNet state plan as of January
25 1, 2005; except that, on or after July 1, 2005, less restrictive income methodologies, as authorized in
26 42 U.S.C. Section 1396a(r)(2), may be used to change the income limit if authorized by annual
27 appropriation;

28 (b) All persons who would be determined to be eligible for aid to the blind benefits under the
29 eligibility standards in effect December 31, 1973, as authorized by 42 U.S.C. Section 1396a(f), or
30 less restrictive methodologies as contained in the MO HealthNet state plan as of January 1, 2005,
31 except that less restrictive income methodologies, as authorized in 42 U.S.C. Section 1396a(r)(2),
32 shall be used to raise the income limit to one hundred percent of the federal poverty level;

33 (c) All persons who would be determined to be eligible for permanent and total disability
34 benefits under the eligibility standards in effect December 31, 1973, as authorized by 42 U.S.C.
35 1396a(f); or less restrictive methodologies as contained in the MO HealthNet state plan as of January
36 1, 2005; except that, on or after July 1, 2005, less restrictive income methodologies, as authorized in
37 42 U.S.C. Section 1396a(r)(2), may be used to change the income limit if authorized by annual
38 appropriations. Eligibility standards for permanent and total disability benefits shall not be limited
39 by age;

40 (25) Persons who have been diagnosed with breast or cervical cancer and who are eligible
41 for coverage pursuant to 42 U.S.C. 1396a (a)(10)(A)(ii)(XVIII). Such persons shall be eligible

1 during a period of presumptive eligibility in accordance with 42 U.S.C. 1396r-1;

2 (26) Effective August 28, 2013, persons who are in foster care under the responsibility of the
3 state of Missouri on the date such persons attain the age of eighteen years, or at any time during the
4 thirty-day period preceding their eighteenth birthday, without regard to income or assets, if such
5 persons:

6 (a) Are under twenty-six years of age;

7 (b) Are not eligible for coverage under another mandatory coverage group; and

8 (c) Were covered by Medicaid while they were in foster care.

9 2. Rules and regulations to implement this section shall be promulgated in accordance with
10 chapter 536. Any rule or portion of a rule, as that term is defined in section 536.010, that is created
11 under the authority delegated in this section shall become effective only if it complies with and is
12 subject to all of the provisions of chapter 536 and, if applicable, section 536.028. This section and
13 chapter 536 are nonseverable and if any of the powers vested with the general assembly pursuant to
14 chapter 536 to review, to delay the effective date or to disapprove and annul a rule are subsequently
15 held unconstitutional, then the grant of rulemaking authority and any rule proposed or adopted after
16 August 28, 2002, shall be invalid and void.

17 3. After December 31, 1973, and before April 1, 1990, any family eligible for assistance
18 pursuant to 42 U.S.C. 601, et seq., as amended, in at least three of the last six months immediately
19 preceding the month in which such family became ineligible for such assistance because of increased
20 income from employment shall, while a member of such family is employed, remain eligible for MO
21 HealthNet benefits for four calendar months following the month in which such family would
22 otherwise be determined to be ineligible for such assistance because of income and resource
23 limitation. After April 1, 1990, any family receiving aid pursuant to 42 U.S.C. 601, et seq., as
24 amended, in at least three of the six months immediately preceding the month in which such family
25 becomes ineligible for such aid, because of hours of employment or income from employment of the
26 caretaker relative, shall remain eligible for MO HealthNet benefits for six calendar months following
27 the month of such ineligibility as long as such family includes a child as provided in 42 U.S.C.
28 1396r-6. Each family which has received such medical assistance during the entire six-month period
29 described in this section and which meets reporting requirements and income tests established by the
30 division and continues to include a child as provided in 42 U.S.C. 1396r-6 shall receive MO
31 HealthNet benefits without fee for an additional six months. The MO HealthNet division may
32 provide by rule and as authorized by annual appropriation the scope of MO HealthNet coverage to be
33 granted to such families.

34 4. When any individual has been determined to be eligible for MO HealthNet benefits, such
35 medical assistance will be made available to him or her for care and services furnished in or after the
36 third month before the month in which he made application for such assistance if such individual
37 was, or upon application would have been, eligible for such assistance at the time such care and
38 services were furnished; provided, further, that such medical expenses remain unpaid.

39 5. The department of social services may apply to the federal Department of Health and
40 Human Services for a MO HealthNet waiver amendment to the Section 1115 demonstration waiver
41 or for any additional MO HealthNet waivers necessary not to exceed one million dollars in additional

costs to the state, unless subject to appropriation or directed by statute, but in no event shall such waiver applications or amendments seek to waive the services of a rural health clinic or a federally qualified health center as defined in 42 U.S.C. 1396d(l)(1) and (2) or the payment requirements for such clinics and centers as provided in 42 U.S.C. 1396a(a)(15) and 1396a(bb) unless such waiver application is approved by the oversight committee created in section 208.955. A request for such a waiver so submitted shall only become effective by executive order not sooner than ninety days after the final adjournment of the session of the general assembly to which it is submitted, unless it is disapproved within sixty days of its submission to a regular session by a senate or house resolution adopted by a majority vote of the respective elected members thereof, unless the request for such a waiver is made subject to appropriation or directed by statute.

6. Notwithstanding any other provision of law to the contrary, in any given fiscal year, any persons made eligible for MO HealthNet benefits under subdivisions (1) to (22) of subsection 1 of this section shall only be eligible if annual appropriations are made for such eligibility. This subsection shall not apply to classes of individuals listed in 42 U.S.C. Section 1396a(a)(10)(A)(i).

7. The department of social services shall notify any potential exchange-eligible participant who may be eligible for services due to spenddown that the participant may qualify for more cost-effective private insurance and premium tax credits under Section 36B of the Internal Revenue Code of 1986, as amended, available through the purchase of a health insurance plan in a health care exchange, whether federally facilitated, state based, or operated on a partnership basis and the benefits potentially covered under such insurance."; and

Further amend said bill, Page 6, Section 208.166, Line 108, by inserting after all of said section and line the following:

"208.186. 1. Any person participating in the MO HealthNet program who has pled guilty to or been found guilty of a crime or in a juvenile case admitted to allegations or had allegations found to be true involving alcohol or a controlled substance or any crime in which alcohol or substance abuse was, in the opinion of the court, a contributing factor to the person's commission of the crime shall be required to obtain an assessment by a treatment provider approved by the department of mental health to determine the need for services. Recommendations of the treatment provider may be used by the court in sentencing or rendering of a disposition.

2. Any person participating in the MO HealthNet program who is a parent or guardian of a child subject to proceedings in juvenile court under subsection 1 or 2 of section 211.031, whose misuse of controlled substances or alcohol is found to be a significant, contributing factor to the reason the child was adjudicated shall be required to obtain an assessment by a treatment provider approved by the department of mental health to determine the need for services. Recommendations of the treatment provider shall be included in the child's juvenile court record. The court may order the parent or guardian to successfully complete treatment before the child is reunified with the parent or guardian.

3. The MO HealthNet division shall certify a MO HealthNet participant's enrollment in MO HealthNet if requested by the court under this section. A letter signed by the director of the MO

HealthNet division, his or her designee, or the family support division certifying that the individual is a participant in the MO HealthNet program shall be prima facie evidence of such participation and shall be admissible into evidence without further foundation for that purpose. The letter may specify additional information such as anticipated dates of coverage as may be deemed necessary by the department of social services.

208.189. 1. As used in this section, the following terms shall mean:

(1) "Health information exchange" or "HIE", the electronic movement of health-related information among organizations in accordance with nationally recognized standards, with the goal of facilitating access to and retrieval of clinical data to provide safe, timely, efficient, effective, equitable, patient-centered care;

(2) "HIPAA", the federal Health Insurance Portability and Accountability Act.

2. The MO HealthNet division shall contract for a system that shall:

(1) Support an interoperable data analytics platform for analyzing clinical data for defined populations, such as mothers at risk of premature birth, frequent utilizers of emergency departments, and those suffering from chronic pain conditions. The system shall be able to leverage cloud-based technology and be hosted remotely by the vendor of the application services system with interoperability capabilities to connect with disparate systems;

(2) Have the ability to interoperate using accepted industry standards, collect and aggregate data from disparate systems, and include, but not be limited to, clinical data, electronic medical records, claims and eligibility databases, state-managed registries, and health information exchanges;

(3) Provide a member portal to beneficiaries to view and manage their personal health information, wellness plans, and overall health, and a HIPAA-compliant provider portal that allows providers access to patient information;

(4) Allow for real-time patient queries and present clinical information to providers for the purpose of avoiding duplicate tests and improving care coordination;

(5) Have the ability to create condition-specific registries for managing populations and provide predictive modeling or alerting functionality which alerts providers of at-risk patients and is able to communicate between various systems to provide electronic medical record (EMR) workflow integration or similar tools to communicate with a health care provider's workflow; and

(6) Operate on a statewide, regional, or community-wide basis.

3. All MO HealthNet providers providing services to MO HealthNet recipients shall be required to participate in the system described in this section for their MO HealthNet recipient patients.

208.662. 1. There is hereby established within the department of social services the "Show-Me Healthy Babies Program" as a separate children's health insurance program (CHIP) for any low-income unborn child. The program shall be established under the authority of Title XXI of the federal Social Security Act, the State Children's Health Insurance Program, as amended, and 42 CFR 457.1.

2. For an unborn child to be enrolled in the show-me healthy babies program, his or her mother shall not be eligible for coverage under Title XIX of the federal Social Security Act, the Medicaid program as it is administered by the state, and shall not have access to affordable

1 employer-subsidized health care insurance or other affordable health care coverage that includes
2 coverage for the unborn child. In addition, the unborn child shall be in a family with income
3 eligibility of no more than three hundred percent of the federal poverty level, or the equivalent
4 modified adjusted gross income, unless the income eligibility is set lower by the general assembly
5 through appropriations. In calculating family size as it relates to income eligibility, the family shall
6 include, in addition to other family members, all unborn children.

7 3. Coverage for an unborn child enrolled in the show-me healthy babies program shall
8 include all prenatal care and pregnancy-related services that benefit the health of the unborn child
9 and that promote healthy labor, delivery, and birth. Coverage need not include services that are
10 solely for the benefit of the pregnant mother, that are unrelated to maintaining or promoting a
11 healthy pregnancy, or that provide no benefit to the unborn child. However, the department may
12 include pregnancy-related assistance as defined in 42 U.S.C. Section 1397II.

13 4. There shall be no waiting period before an unborn child may be enrolled in the show-me
14 healthy babies program. In accordance with the definition of child in 42 CFR 457.10, coverage shall
15 include the period from conception to birth. The department shall develop a presumptive eligibility
16 procedure for enrolling an unborn child, which shall include verification of the pregnancy.

17 5. Coverage for the child shall continue for up to one year after birth, unless otherwise
18 prohibited by law or limited by the general assembly through appropriations.

19 6. Pregnancy-related and postpartum coverage for the mother shall begin on the day the
20 pregnancy ends and extend through the last day of the month that includes the sixtieth day after the
21 pregnancy ends, unless otherwise prohibited by law or limited by the general assembly through
22 appropriations. The department may include pregnancy-related assistance as defined in 42 U.S.C.
23 1397II.

24 7. The department may provide coverage for an unborn child enrolled in the show-me
25 healthy babies program through:

26 (1) Direct coverage whereby the state pays health care providers directly, by contracting with
27 a managed care organization or with a group or individual health insurance provider;

28 (2) A premium assistance program whereby the state assists in payment of the premiums,
29 co-payments, coinsurance, or deductibles for a person who is eligible for health coverage through an
30 employer, former employer, labor union, credit union, church, spouse, other organization, other
31 individual, or through an individual health insurance policy that includes coverage for the unborn
32 child when such person needs assistance in paying such premiums, co-payments, coinsurance, or
33 deductibles;

34 (3) A combination of direct coverage when the unborn child is first enrolled and premium
35 assistance after the child is born; or

36 (4) Any other similar arrangement whereby there:

37 (a) Are lower program costs without sacrificing health care coverage for the unborn child or
38 the child up to one year after birth;

39 (b) Are greater covered services for the unborn child or the child up to one year after birth;

40 (c) Is also coverage for siblings or other family members, including the unborn child's
41 mother, such as by providing pregnancy-related assistance under 42 U.S.C. 1397II, relating to

1 coverage of targeted low-income pregnant women through the children's health insurance program
2 (CHIP); or

3 (d) Will be an ability for the child to transition more easily to non-government or less
4 government-subsidized group or individual health insurance coverage after the child is no longer
5 enrolled in the show-me healthy babies program.

6 8. The department shall provide information about the show-me healthy babies program to
7 maternity homes as defined in section 135.600, pregnancy resource centers as defined in section
8 135.630, and other similar agencies and programs in the state that assist unborn children and their
9 mothers. The department shall consider allowing such agencies and programs to assist in the
10 enrollment of unborn children in the program and in making determinations about presumptive
11 eligibility and verification of the pregnancy.

12 9. Within sixty days after the effective date of this section, the department shall submit a
13 state plan amendment or seek any necessary waivers from the federal Department of Health and
14 Human Services requesting approval for the show-me healthy babies program.

15 10. At least annually, the department shall prepare and submit a report to the governor, the
16 speaker of the house of representatives, and the president pro tempore of the senate analyzing and
17 projecting the cost savings and benefits, if any, to the state, counties, local communities, school
18 districts, law enforcement agencies, correctional centers, health care providers, employers, other
19 public and private entities, and persons by enrolling unborn children in the show-me healthy babies
20 program. The analysis and projection of cost savings and benefits, if any, may include, but need not
21 be limited to:

22 (1) The higher federal matching rate for having an unborn child enrolled in the show-me
23 healthy babies program versus the lower federal matching rate for a pregnant woman being enrolled
24 in MO HealthNet or other federal programs;

25 (2) The efficacy in providing services to unborn children through managed care
26 organizations, group or individual health insurance providers, premium assistance, or through other
27 nontraditional arrangements of providing health care;

28 (3) The change in the proportion of unborn children who receive care in the first trimester of
29 pregnancy due to a lack of waiting periods, by allowing presumptive eligibility, or by removal of
30 other barriers, and any resulting or projected decrease in health problems and other problems for
31 unborn children and women throughout pregnancy; at labor, delivery, and birth; and during infancy
32 and childhood;

33 (4) The change in healthy behaviors by pregnant women, such as the cessation of the use of
34 tobacco, alcohol, illicit drugs, or other harmful practices, and any resulting or projected short-term
35 and long-term decrease in birth defects; poor motor skills; vision, speech, and hearing problems;
36 breathing and respiratory problems; feeding and digestive problems; and other physical, mental,
37 educational, and behavioral problems; and

38 (5) The change in infant and maternal mortality, pre-term births and low birth weight babies,
39 and any resulting or projected decrease in short-term and long-term medical and other interventions.

40 11. The show-me healthy babies program shall not be deemed an entitlement program, but
41 instead shall be subject to a federal allotment or other federal appropriations and matching state

1 appropriations.

2 12. Nothing in this section shall be construed as obligating the state to continue the show-me
 3 healthy babies program if the allotment or payments from the federal government end, are not
 4 sufficient for the program to operate, or if the general assembly does not appropriate funds for the
 5 program.

6 13. Nothing in this section shall be construed as expanding MO HealthNet or fulfilling a
 7 mandate imposed by the federal government on the state.

36B(d)(2) of the Internal Revenue Code of 1986, as amended, and:

- (a) Any foreign earned income or housing costs;
- (b) Tax-exempt interest received or accrued by the individual; and
- (c) Tax-exempt Social Security income;

[(5)] (6) "MAGI equivalent net income standard", an income eligibility threshold based on modified adjusted gross income that is not less than the income eligibility levels that were in effect prior to the enactment of Public Law 111-148 and Public Law 111-152;

(7) "Medically frail", individuals:

(a) Described in 42 CFR 438.50(d)(3);

(b) With disabling mental disorders;

(c) With chronic substance use disorders;

(d) With serious and complex medical conditions;

(e) With a physical, intellectual, or developmental disability that significantly impairs their ability to perform one or more activities of daily living; or

(f) With a disability determination based on Social Security criteria.

2. (1) Effective January 1, 2014, notwithstanding any other provision of law to the contrary, the following individuals shall be eligible for MO HealthNet coverage as provided in this section:

(a) Individuals covered by MO HealthNet for families as provided in section 208.145;

(b) Individuals covered by transitional MO HealthNet as provided in 42 U.S.C. Section 1396r-6;

(c) Individuals covered by extended MO HealthNet for families on child support closings as provided in 42 U.S.C. Section 1396r-6;

(d) Pregnant women as provided in subdivisions (10), (11), and (12) of subsection 1 of section 208.151;

(e) Children under one year of age as provided in subdivision (12) of subsection 1 of section 208.151;

(f) Children under six years of age as provided in subdivision (13) of subsection 1 of section 208.151;

(g) Children under nineteen years of age as provided in subdivision (14) of subsection 1 of section 208.151;

(h) CHIP-eligible children; and

(i) Uninsured women as provided in section 208.659.

(2) Effective January 1, 2014, the department shall determine eligibility for individuals eligible for MO HealthNet under subdivision (1) of this subsection based on the following income eligibility standards, unless and until they are changed:

(a) For individuals listed in paragraphs (a), (b), and (c) of subdivision (1) of this subsection, the department shall apply the July 16, 1996, Aid to Families with Dependent Children (AFDC) income standard as converted to the MAGI equivalent net income standard;

(b) For individuals listed in paragraphs (f) and (g) of subdivision (1) of this subsection, the department shall apply one hundred thirty-three percent of the federal poverty level converted to the MAGI equivalent net income standard;

40 16. The department may seek and apply for grants to educate MO HealthNet recipients how

- (2) Improve health outcomes; and
- (3) Properly utilize health care providers and services.

208.997. 1. The MO HealthNet division shall develop and implement the "Health Care Homes Program" as a provider-directed care coordination program for MO HealthNet recipients who are not enrolled in a prepaid MO HealthNet benefits option and who are receiving services on a fee-for-service basis or are otherwise identified by the department. The health care homes program shall provide payment to primary care clinics, community mental health centers, and other appropriate providers for care coordination for individuals who are deemed medically frail. Clinics shall meet certain criteria including, but not limited to, the following:

- (1) The capacity to develop care plans;
- (2) A dedicated care coordinator;
- (3) An adequate number of clients, evaluation mechanisms, and quality improvement processes to qualify for reimbursement; and
- (4) The capability to maintain and use a disease registry.

2. For purposes of this section, "primary care clinic" means a medical clinic designated as the patient's first point of contact for medical care, available twenty-four hours a day, seven days a week, that provides or arranges the patient's comprehensive health care needs and provides overall integration, coordination, and continuity over time and referrals for specialty care.

3. The department may designate that the health care homes program be administered through an organization with a statewide primary care presence, experience with Medicaid population health management, and an established health care homes outcomes monitoring and improvement system.

4. This section shall be implemented in such a way that it does not conflict with federal requirements for health care home participation by MO HealthNet participants.

5. The department or appropriate divisions of the department may promulgate rules to implement the provisions of this section. Any rule or portion of a rule, as that term is defined in section 536.010, that is created under the authority delegated in this section shall become effective only if it complies with and is subject to all of the provisions of chapter 536 and, if applicable, section 536.028. This section and chapter 536 are nonseverable and if any of the powers vested with the general assembly under chapter 536 to review, to delay the effective date, or to disapprove and annul a rule are subsequently held unconstitutional, then the grant of rulemaking authority and any rule proposed or adopted after August 28, 2014, shall be invalid and void.

6. Nothing in this section shall be construed to limit the department's ability to create health care homes for participants in a managed care plan.

208.998. 1. Except for individuals who meet the definition of medically frail, individuals who qualify for coverage under subsections 2 and 4 of section 208.991 shall receive covered services through health plans offered by managed care entities which are authorized by the department. Health plans authorized by the department:

- (1) Shall resemble commercially available health plans while complying with federal Medicaid requirements as authorized by federal law or through a federal waiver and may include

risk-bearing accountable care organizations which provide covered services to individuals who qualify for coverage under subsection 4 of section 208.991 and managed care organizations paid on a capitated basis which provide covered services to individuals who qualify for coverage under subsections 2 and 4 of section 208.991;

(2) Shall promote, to the greatest extent possible, the opportunity for children and their parents to be covered under the same plan;

(3) Shall offer plans statewide;

(4) Shall include cost sharing for outpatient services to the maximum extent allowed by federal law;

(5) May include other co-payments and provide incentives that encourage and reward the prudent use of the health benefit provided;

(6) Shall encourage access to care through provider rates that include pay-for-performance and are comparable to commercial rates. The department of social services shall determine pay-for-performance provisions that managed care organizations shall execute and shall provide incentives for managed care organizations that perform well;

(7) Shall provide incentives, including shared risk and savings, to health plans and providers to encourage cost-effective delivery of care;

(8) Shall provide incentive programs for participants to encourage healthy behaviors and promote the adoption of healthier personal habits including limiting tobacco use or behaviors that lead to obesity;

(9) May provide multiple plan options and reward participants for choosing a low-cost plan;

(10) Shall include the services of community mental health centers; and

(11) Shall include the services of health providers as defined in 42 U.S.C. Section 1396d(1)(1) and (2) and meet the payment requirements for such health providers as provided in 42 U.S.C. Sections 1396a(a)(15) and 1396a(bb).

2. The department may designate that certain health care services be excluded from such health plans if it is determined cost effective by the department.

3. (1) The department may accept regional proposals as an additional option for beneficiaries.

(2) The department shall advance the development of systems of care for medically complex children who are recipients of MO HealthNet benefits by accepting cost-effective regional proposals from and contracting with appropriate pediatric care networks, pediatric centers for excellence, and medical homes for children to provide MO HealthNet benefits when the department determines it is cost effective to do so.

(3) The provisions of subsection 1 of this section shall not apply to this subsection.

4. The department shall establish, in collaboration with plans and providers, uniform utilization review protocols to be used by all authorized health plans.

5. Any managed care organization that enters into a contract with the state to provide managed care plans shall be required to fulfill the terms of the contract and provide such plans for at least twelve months, or longer if the contract so provides. The state shall not increase the reimbursement rate provided to the managed care organization during the contract period above the

rate included in the contract. If the managed care organization breaches the contract, the state shall be entitled to bring an action against the managed care organization for any remedy allowed by law or equity and shall also recover any and all damages provided by law including liquidated damages in an amount determined by the department during the bidding process. Nothing in this subsection shall be construed to preclude the department or the state of Missouri from terminating the contract as specified in the terms of the contract including for breach of contract, lack of appropriated funds, or exercising any remedies for breach as may be provided in the contract.

6. (1) Participants enrolling in managed care plans under this section shall have the ability to choose their plan. In the enrollment process participants shall be provided a list of all plans available ranked by the relative actuarial value of each plan. Each participant shall be informed in the enrollment process that he or she will be eligible to receive a portion of the amount saved by Missouri taxpayers if he or she chooses a lower cost plan offered in his or her region. The portion received by a participant shall be determined by the department according to the department's best judgment as to the portion which will bring the maximum savings to Missouri taxpayers.

(2) If a participant fails or refuses to choose a plan as set forth in subdivision (1) of this subsection, the department shall determine rules for auto-assignment, which shall include incentives for low-cost bids and improved health outcomes as determined by the department. Auto-enrolled participants shall be assigned to the highest performing managed care organization.

7. This section shall not be construed to require the department to terminate any existing managed care contract or to extend any managed care contract.

8. All MO HealthNet plans under this section shall provide coverage for the following services unless they are specifically excluded under subsection 2 of this section:

(1) Ambulatory patient services;

(2) Emergency services;

(3) Hospitalization;

(4) Maternity and newborn care;

(5) Mental health and substance abuse treatment, including behavioral health treatment;

(6) Prescription drugs;

(7) Rehabilitative and habilitative services and devices;

(8) Laboratory services;

(9) Preventive and wellness care, and chronic disease management;

(10) Pediatric services, including oral and vision care; and

(11) Any other services required by federal law.

9. No MO HealthNet plan or program shall provide coverage for an abortion unless a physician certifies in writing to the MO HealthNet agency that, in the physician's professional judgment, the life of the mother would be endangered if the fetus were carried to term.

10. The MO HealthNet program shall require managed care plans under this section to provide a high deductible health plan option for uninsured adults nineteen years of age or older and under sixty-five years of age with incomes of less than one hundred percent of the federal poverty level as converted to the MAGI equivalent net income standard who are enrolled in managed care plans under this section. The high deductible health plan shall include:

1 (1) A minimum deductible of one thousand dollars and upon meeting the deductible,
 2 coverage for benefits as specified by rule of the department;

3 (2) An account, funded by the department, of at least one thousand dollars per adult to pay
 4 medical costs for the initial deductible in the form of a prepaid card;

5 (3) Preventive care, as defined by the department by rule, that is not subject to the deductible
 6 and does not require a payment of moneys from the account described in subdivision (2) of this
 7 subsection;

8 (4) A basic benefits package if annual medical costs exceed one thousand dollars;

9 (5) Primary care provider visits, as defined by the department by rule, that are not subject to
 10 the deductible and do not require a payment of moneys from the account described in subdivision (2)
 11 of this subsection;

12 (6) As soon as practicable, the establishment and maintenance of a record-keeping system
 13 for each health care visit or service received by recipients under this subsection. The plan shall
 14 require that the recipient's prepaid card number be entered or electronic strip be swiped by the health
 15 care provider for purposes of maintaining a record of every health care visit or service received by
 16 the recipient from such provider, regardless of any balance on the recipient's card. Such information
 17 shall include only the date, provider name, and general description of the visit or service provided.
 18 The plan shall maintain a complete history of all health care visits and services for which the
 19 recipient's prepaid card is entered or swiped in accordance with this subdivision. If required under
 20 the federal Health Insurance Portability and Accountability Act (HIPAA) or other relevant state or
 21 federal law or regulation, a recipient shall, as a condition of participation in the prepaid card
 22 incentive, be required to provide a written waiver for disclosure of any information required under
 23 this subdivision;

24 (7) The determination of a proportion of the amount left in a participant's account described
 25 in subdivision (2) of this subsection at the end of the plan year, which shall be paid to the participant
 26 for saving taxpayer money. The amount and method of payment shall be determined by the
 27 department; and

28 (8) The determination of a proportion of a participant's account described in subdivision (2)
 29 of this subsection which shall be used to subsidize premiums to facilitate a participant's transition
 30 from health coverage under MO HealthNet to private health insurance based on cost-effective
 31 principles determined by the department.

32 11. The department shall require managed care plans under this section to offer an incentive
 33 program in which all MO HealthNet participants with chronic conditions, as specified by the
 34 department, who are enrolled in managed care plans under this section shall enroll. Participants who
 35 obtain specified primary care and preventive services and who participate or refrain from
 36 participation in specified activities to improve the overall health of the recipient shall be eligible to
 37 receive an annual cash payment if federal financial participation is obtained for such a payment, or a
 38 cash equivalent if not, for successful completion of the program. The department shall establish, by
 39 rule, the specific primary care and preventive services, activities to be included in the incentive
 40 program, and the amount of any annual payments to recipients.

41 12. A MO HealthNet recipient shall be eligible for participation in only one of either the

1 high deductible health plan under subsection 11 of this section or the incentive program under
 2 subsection 12 of this section.

3 13. No cash payments, incentives, or credits paid to or on behalf of a MO HealthNet
 4 participant under a program established by the department under this section shall be deemed to be
 5 income to the participant in any means-tested benefit program unless otherwise specifically required
 6 by law or rule of the department.

7 14. Managed care entities shall inform participants who choose the high deductible health
 8 plan under subsection 11 of this section that the participant may lose his or her incentive payment
 9 under subdivision (7) of subsection 11 of this section if the participant utilizes visits to the
 10 emergency department for non-emergent purposes. Such information shall be included on every
 11 electronic and paper correspondence between the managed care plan and the participant.

12 15. The department shall seek all necessary waivers and state plan amendments from the
 13 federal Department of Health and Human Services necessary to implement the provisions of this
 14 section. The provisions of this section shall not be implemented unless such waivers and state plan
 15 amendments are approved. If this section is approved in part by the federal government, the
 16 department is authorized to proceed on those sections for which approval has been granted; except
 17 that, any increase in eligibility shall be contingent upon the receipt of all necessary waivers and state
 18 plan amendments. The provisions of this section shall not be implemented until eligibility of persons
 19 set out in subsection 4 of section 208.991 has been approved by the federal Department of Health
 20 and Human Services and has been implemented by the department. However, nothing shall prevent
 21 the department from expanding managed care for populations under other granted authority.

22 16. The department may promulgate rules to implement the provisions of this section. Any
 23 rule or portion of a rule, as the term is defined in section 536.010, that is created under the authority
 24 delegated in this section shall become effective only if it complies with and is subject to all of the
 25 provisions of chapter 536 and, if applicable, section 536.028. This section and chapter 536 are
 26 nonseverable and if any of the powers vested with the general assembly under chapter 536 to review,
 27 to delay the effective date, or to disapprove and annul a rule are subsequently held unconstitutional,
 28 then the grant of rulemaking authority and any rule proposed or adopted after August 28, 2014, shall
 29 be invalid and void."; and

22 (1) Reducing emergency department utilization;

2 care providers whereby the department measures and tracks baseline expenditures on a per-member,
3 per-month basis for the target population. The department shall develop a shared savings funding
4 model that may be adapted to a wider array of health payment models.

5 3. The department also shall develop additional innovative programs that seek to address the
6 cost and quality of care for individuals who disproportionately utilize emergency departments for
7 care. Health care providers participating in the regional care coordination models shall be
8 encouraged to include uninsured individuals who frequently utilize the emergency department for
9 care in this program to the greatest extent possible."; and
