1 AMEND House Committee Substitute for House Bill No. 1662, Page 1, Section A, Line 3, by
2 inserting after all of said section and line the following:

3
4 "143.013. 1. As used in this section, the following terms shall mean:

5 (1) "Average payroll", the amount of taxable wages of full-time employees of the business
6 divided by the total number of full-time employees;

7 (2) "Business income", income greater than zero arising from transactions and activity in the
8 regular course of the taxpayer's trade or business and includes income from tangible property if the
9 acquisition, management, and disposition of the property constitute integral parts of the individual
10 taxpayer's regular trade or business operations. "Business income" shall not include "compensation"
11 as such term is defined under subsection 1 of article IV of section 32.200;

12 (3) "County average wage", the same meaning ascribed to it as in section 620.1878;

13 (4) "Full-time employee", an employee of the qualified company who is scheduled to work
14 an average of at least thirty-five hours per week for a twelve-month period and one for whom the
15 qualified company offers health insurance and pays at least fifty percent of such insurance
16 premiums;

17 (5) "Individual taxpayer", the owner or owners of a qualified company doing business in the
18 state of Missouri and subject to the state income tax imposed under chapter 143 excluding
19 withholding tax under sections 143.191 to 143.265;

20 (6) "Qualified company", a Missouri business that meets the following:

21 (a) The average payroll for the tax year of the business that is the source of such business
22 income exceeds one hundred fifty percent of the county average wage in the county in which the
23 business is located;

24 (b) The business employs at least two persons; and

25 (c) The business provides health insurance coverage to its employees.

26 2. For all tax years beginning on or after January 1, 2014, in addition to all other
27 modifications allowed by law, there shall be subtracted from the federal adjusted gross income of an
28 individual taxpayer fifty percent of business income to the extent included in federal adjusted gross
29 income when determining the individual taxpayer's Missouri adjusted gross income to encourage
30 employers to provide health insurance coverage for all full-time employees.

31 3. In the case of a small corporation described in section 143.471 or a partnership computing the
32 deduction allowed under subsection 2 of this section, individual taxpayers described in subdivisions
33 (1), (2), or (3) of this subsection shall be allowed such deduction apportioned in proportion to their
34 share of ownership of the qualified company on the last day of the individual taxpayer's tax period
35 for which such deduction is being claimed when determining the Missouri adjusted gross income of:

36 (1) The shareholders of a small corporation as described in section 143.471;

4 Further amend said bill, Page 3, Section 191.875, Line 80, by inserting after all of said section and
 5 line the following:
 6

7 "208.151. 1. Medical assistance on behalf of needy persons shall be known as "MO
 8 HealthNet". For the purpose of paying MO HealthNet benefits and to comply with Title XIX, Public
 9 Law 89-97, 1965 amendments to the federal Social Security Act (42 U.S.C. Section 301, et seq.) as
 10 amended, the following needy persons shall be eligible to receive MO HealthNet benefits to the
 11 extent and in the manner hereinafter provided, unless otherwise provided in subsection 2 of this
 12 section:

13 (1) All participants receiving state supplemental payments for the aged, blind and disabled;

14 (2) All participants receiving aid to families with dependent children benefits, including all
 15 persons under nineteen years of age who would be classified as dependent children except for the
 16 requirements of subdivision (1) of subsection 1 of section 208.040. Participants eligible under this
 17 subdivision who are participating in drug court, as defined in section 478.001, shall have their
 18 eligibility automatically extended sixty days from the time their dependent child is removed from the
 19 custody of the participant, subject to approval of the Centers for Medicare and Medicaid Services;

20 (3) All participants receiving blind pension benefits;

21 (4) All persons who would be determined to be eligible for old age assistance benefits,
 22 permanent and total disability benefits, or aid to the blind benefits under the eligibility standards in
 23 effect December 31, 1973, or less restrictive standards as established by rule of the family support
 24 division, who are sixty-five years of age or over and are patients in state institutions for mental
 25 diseases or tuberculosis;

26 (5) All persons under the age of twenty-one years who would be eligible for aid to families
 27 with dependent children except for the requirements of subdivision (2) of subsection 1 of section
 28 208.040, and who are residing in an intermediate care facility, or receiving active treatment as
 29 inpatients in psychiatric facilities or programs, as defined in 42 U.S.C. 1396d, as amended;

30 (6) All persons under the age of twenty-one years who would be eligible for aid to families
 31 with dependent children benefits except for the requirement of deprivation of parental support as
 32 provided for in subdivision (2) of subsection 1 of section 208.040;

33 (7) All persons eligible to receive nursing care benefits;

34 (8) All participants receiving family foster home or nonprofit private child-care institution
 35 care, subsidized adoption benefits and parental school care wherein state funds are used as partial or
 36 full payment for such care;

37 (9) All persons who were participants receiving old age assistance benefits, aid to the
 38 permanently and totally disabled, or aid to the blind benefits on December 31, 1973, and who
 39 continue to meet the eligibility requirements, except income, for these assistance categories, but who
 40 are no longer receiving such benefits because of the implementation of Title XVI of the federal
 41 Social Security Act, as amended;

42 (10) Pregnant women who meet the requirements for aid to families with dependent

1 children, except for the existence of a dependent child in the home;

2 (11) Pregnant women who meet the requirements for aid to families with dependent
3 children, except for the existence of a dependent child who is deprived of parental support as
4 provided for in subdivision (2) of subsection 1 of section 208.040;

5 (12) Pregnant women or infants under one year of age, or both, whose family income does
6 not exceed an income eligibility standard equal to one hundred eighty-five percent of the federal
7 poverty level as established and amended by the federal Department of Health and Human Services,
8 or its successor agency;

9 (13) Children who have attained one year of age but have not attained six years of age who
10 are eligible for medical assistance under 6401 of P.L. 101-239 (Omnibus Budget Reconciliation Act
11 of 1989). The family support division shall use an income eligibility standard equal to one hundred
12 thirty-three percent of the federal poverty level established by the Department of Health and Human
13 Services, or its successor agency;

14 (14) Children who have attained six years of age but have not attained nineteen years of age.
15 For children who have attained six years of age but have not attained nineteen years of age, the
16 family support division shall use an income assessment methodology which provides for eligibility
17 when family income is equal to or less than equal to one hundred percent of the federal poverty level
18 established by the Department of Health and Human Services, or its successor agency. As necessary
19 to provide MO HealthNet coverage under this subdivision, the department of social services may
20 revise the state MO HealthNet plan to extend coverage under 42 U.S.C. 1396a (a)(10)(A)(i)(III) to
21 children who have attained six years of age but have not attained nineteen years of age as permitted
22 by paragraph (2) of subsection (n) of 42 U.S.C. 1396d using a more liberal income assessment
23 methodology as authorized by paragraph (2) of subsection (r) of 42 U.S.C. 1396a;

24 (15) The family support division shall not establish a resource eligibility standard in
25 assessing eligibility for persons under subdivision (12), (13) or (14) of this subsection. The MO
26 HealthNet division shall define the amount and scope of benefits which are available to individuals
27 eligible under each of the subdivisions (12), (13), and (14) of this subsection, in accordance with the
28 requirements of federal law and regulations promulgated thereunder;

29 (16) Notwithstanding any other provisions of law to the contrary, ambulatory prenatal care
30 shall be made available to pregnant women during a period of presumptive eligibility pursuant to 42
31 U.S.C. Section 1396r-1, as amended;

32 (17) A child born to a woman eligible for and receiving MO HealthNet benefits under this
33 section on the date of the child's birth shall be deemed to have applied for MO HealthNet benefits
34 and to have been found eligible for such assistance under such plan on the date of such birth and to
35 remain eligible for such assistance for a period of time determined in accordance with applicable
36 federal and state law and regulations so long as the child is a member of the woman's household and
37 either the woman remains eligible for such assistance or for children born on or after January 1,
38 1991, the woman would remain eligible for such assistance if she were still pregnant. Upon
39 notification of such child's birth, the family support division shall assign a MO HealthNet eligibility
40 identification number to the child so that claims may be submitted and paid under such child's
41 identification number;

1 (18) Pregnant women and children eligible for MO HealthNet benefits pursuant to
2 subdivision (12), (13) or (14) of this subsection shall not as a condition of eligibility for MO
3 HealthNet benefits be required to apply for aid to families with dependent children. The family
4 support division shall utilize an application for eligibility for such persons which eliminates
5 information requirements other than those necessary to apply for MO HealthNet benefits. The
6 division shall provide such application forms to applicants whose preliminary income information
7 indicates that they are ineligible for aid to families with dependent children. Applicants for MO
8 HealthNet benefits under subdivision (12), (13) or (14) of this subsection shall be informed of the aid
9 to families with dependent children program and that they are entitled to apply for such benefits.
10 Any forms utilized by the family support division for assessing eligibility under this chapter shall be
11 as simple as practicable;

12 (19) Subject to appropriations necessary to recruit and train such staff, the family support
13 division shall provide one or more full-time, permanent eligibility specialists to process applications
14 for MO HealthNet benefits at the site of a health care provider, if the health care provider requests
15 the placement of such eligibility specialists and reimburses the division for the expenses including
16 but not limited to salaries, benefits, travel, training, telephone, supplies, and equipment of such
17 eligibility specialists. The division may provide a health care provider with a part-time or temporary
18 eligibility specialist at the site of a health care provider if the health care provider requests the
19 placement of such an eligibility specialist and reimburses the division for the expenses, including but
20 not limited to the salary, benefits, travel, training, telephone, supplies, and equipment, of such an
21 eligibility specialist. The division may seek to employ such eligibility specialists who are otherwise
22 qualified for such positions and who are current or former welfare participants. The division may
23 consider training such current or former welfare participants as eligibility specialists for this
24 program;

25 (20) Pregnant women who are eligible for, have applied for and have received MO
26 HealthNet benefits under subdivision (2), (10), (11) or (12) of this subsection shall continue to be
27 considered eligible for all pregnancy-related and postpartum MO HealthNet benefits provided under
28 section 208.152 until the end of the sixty-day period beginning on the last day of their pregnancy;

29 (21) Case management services for pregnant women and young children at risk shall be a
30 covered service. To the greatest extent possible, and in compliance with federal law and regulations,
31 the department of health and senior services shall provide case management services to pregnant
32 women by contract or agreement with the department of social services through local health
33 departments organized under the provisions of chapter 192 or chapter 205 or a city health department
34 operated under a city charter or a combined city-county health department or other department of
35 health and senior services designees. To the greatest extent possible the department of social services
36 and the department of health and senior services shall mutually coordinate all services for pregnant
37 women and children with the crippled children's program, the prevention of intellectual disability
38 and developmental disability program and the prenatal care program administered by the department
39 of health and senior services. The department of social services shall by regulation establish the
40 methodology for reimbursement for case management services provided by the department of health
41 and senior services. For purposes of this section, the term "case management" shall mean those

activities of local public health personnel to identify prospective MO HealthNet-eligible high-risk mothers and enroll them in the state's MO HealthNet program, refer them to local physicians or local health departments who provide prenatal care under physician protocol and who participate in the MO HealthNet program for prenatal care and to ensure that said high-risk mothers receive support from all private and public programs for which they are eligible and shall not include involvement in any MO HealthNet prepaid, case-managed programs;

(22) By January 1, 1988, the department of social services and the department of health and senior services shall study all significant aspects of presumptive eligibility for pregnant women and submit a joint report on the subject, including projected costs and the time needed for implementation, to the general assembly. The department of social services, at the direction of the general assembly, may implement presumptive eligibility by regulation promulgated pursuant to chapter 207;

(23) All participants who would be eligible for aid to families with dependent children benefits except for the requirements of paragraph (d) of subdivision (1) of section 208.150;

(24) (a) All persons who would be determined to be eligible for old age assistance benefits under the eligibility standards in effect December 31, 1973, as authorized by 42 U.S.C. Section 1396a(f), or less restrictive methodologies as contained in the MO HealthNet state plan as of January 1, 2005; except that, on or after July 1, 2005, less restrictive income methodologies, as authorized in 42 U.S.C. Section 1396a(r)(2), may be used to change the income limit if authorized by annual appropriation;

(b) All persons who would be determined to be eligible for aid to the blind benefits under the eligibility standards in effect December 31, 1973, as authorized by 42 U.S.C. Section 1396a(f), or less restrictive methodologies as contained in the MO HealthNet state plan as of January 1, 2005, except that less restrictive income methodologies, as authorized in 42 U.S.C. Section 1396a(r)(2), shall be used to raise the income limit to one hundred percent of the federal poverty level;

(c) All persons who would be determined to be eligible for permanent and total disability benefits under the eligibility standards in effect December 31, 1973, as authorized by 42 U.S.C. 1396a(f); or less restrictive methodologies as contained in the MO HealthNet state plan as of January 1, 2005; except that, on or after July 1, 2005, less restrictive income methodologies, as authorized in 42 U.S.C. Section 1396a(r)(2), may be used to change the income limit if authorized by annual appropriations. Eligibility standards for permanent and total disability benefits shall not be limited by age;

(25) Persons who have been diagnosed with breast or cervical cancer and who are eligible for coverage pursuant to 42 U.S.C. 1396a (a)(10)(A)(ii)(XVIII). Such persons shall be eligible during a period of presumptive eligibility in accordance with 42 U.S.C. 1396r-1;

(26) Effective August 28, 2013, persons who are in foster care under the responsibility of the state of Missouri on the date such persons attain the age of eighteen years, or at any time during the thirty-day period preceding their eighteenth birthday, without regard to income or assets, if such persons:

(a) Are under twenty-six years of age;

(b) Are not eligible for coverage under another mandatory coverage group; and

1 (c) Were covered by Medicaid while they were in foster care.

2 2. Beginning July 1, 2015, eligibility for MO HealthNet benefits shall be amended as
3 follows:

4 (1) Persons eligible under subdivision (3) of subsection 1 of this section and section 208.146
5 with income up to and including one hundred thirty-three percent of the federal poverty level as
6 converted to the MAGI equivalent net income standard shall be eligible for MO HealthNet benefits.

7 Persons eligible under subdivision (3) of subsection 1 of this section with income greater than one
8 hundred thirty-three percent of the federal poverty level as converted to the MAGI equivalent net
9 income standard shall only be eligible for those MO HealthNet benefits they would otherwise be
10 entitled to receive including personal care assistance services as defined in section 208.900 that are
11 not available under a qualified health plan as the term is defined in 42 U.S.C. Section 18021(a)(1);

12 (2) The changes in eligibility under subdivision (1) of this subsection shall not take place
13 unless and until there are health insurance premium tax credits under Section 36B of the Internal
14 Revenue Code of 1986, as amended, available to persons through the purchase of a health insurance
15 plan in a health care exchange, whether federally facilitated, state based, or operated on a partnership
16 basis. The director of the department of revenue shall certify to the director of the department of
17 social services that health insurance premium tax credits are available, and the director of the
18 department of social services shall notify the revisor of statutes.

19 3. Rules and regulations to implement this section shall be promulgated in accordance with
20 chapter 536. Any rule or portion of a rule, as that term is defined in section 536.010, that is created
21 under the authority delegated in this section shall become effective only if it complies with and is
22 subject to all of the provisions of chapter 536 and, if applicable, section 536.028. This section and
23 chapter 536 are nonseverable and if any of the powers vested with the general assembly pursuant to
24 chapter 536 to review, to delay the effective date or to disapprove and annul a rule are subsequently
25 held unconstitutional, then the grant of rulemaking authority and any rule proposed or adopted after
26 August 28, 2002, shall be invalid and void.

27 [3.] 4. After December 31, 1973, and before April 1, 1990, any family eligible for assistance
28 pursuant to 42 U.S.C. 601, et seq., as amended, in at least three of the last six months immediately
29 preceding the month in which such family became ineligible for such assistance because of increased
30 income from employment shall, while a member of such family is employed, remain eligible for MO
31 HealthNet benefits for four calendar months following the month in which such family would
32 otherwise be determined to be ineligible for such assistance because of income and resource
33 limitation. After April 1, 1990, any family receiving aid pursuant to 42 U.S.C. 601, et seq., as
34 amended, in at least three of the six months immediately preceding the month in which such family
35 becomes ineligible for such aid, because of hours of employment or income from employment of the
36 caretaker relative, shall remain eligible for MO HealthNet benefits for six calendar months following
37 the month of such ineligibility as long as such family includes a child as provided in 42 U.S.C.
38 1396r-6. Each family which has received such medical assistance during the entire six-month period
39 described in this section and which meets reporting requirements and income tests established by the
40 division and continues to include a child as provided in 42 U.S.C. 1396r-6 shall receive MO
41 HealthNet benefits without fee for an additional six months. The MO HealthNet division may

1 provide by rule and as authorized by annual appropriation the scope of MO HealthNet coverage to be
2 granted to such families.

3 [4.] 5. When any individual has been determined to be eligible for MO HealthNet benefits,
4 such medical assistance will be made available to him or her for care and services furnished in or
5 after the third month before the month in which he made application for such assistance if such
6 individual was, or upon application would have been, eligible for such assistance at the time such
7 care and services were furnished; provided, further, that such medical expenses remain unpaid.

8 [5.] 6. The department of social services may apply to the federal Department of Health and
9 Human Services for a MO HealthNet waiver amendment to the Section 1115 demonstration waiver
10 or for any additional MO HealthNet waivers necessary not to exceed one million dollars in additional
11 costs to the state, unless subject to appropriation or directed by statute, but in no event shall such
12 waiver applications or amendments seek to waive the services of a rural health clinic or a federally
13 qualified health center as defined in 42 U.S.C. 1396d(l)(1) and (2) or the payment requirements for
14 such clinics and centers as provided in 42 U.S.C. 1396a(a)(15) and 1396a(bb) unless such waiver
15 application is approved by the oversight committee created in section 208.955. A request for such a
16 waiver so submitted shall only become effective by executive order not sooner than ninety days after
17 the final adjournment of the session of the general assembly to which it is submitted, unless it is
18 disapproved within sixty days of its submission to a regular session by a senate or house resolution
19 adopted by a majority vote of the respective elected members thereof, unless the request for such a
20 waiver is made subject to appropriation or directed by statute.

21 [6.] 7. Notwithstanding any other provision of law to the contrary, in any given fiscal year,
22 any persons made eligible for MO HealthNet benefits under subdivisions (1) to (22) of subsection 1
23 of this section shall only be eligible if annual appropriations are made for such eligibility. This
24 subsection shall not apply to classes of individuals listed in 42 U.S.C. Section 1396a(a)(10)(A)(i).";
25 and

26 8. The department of social services shall notify any potential exchange-eligible participant
27 who may be eligible for services due to spenddown that the participant may qualify for more
28 cost-effective private insurance and premium tax credits under Section 36B of the Internal Revenue
29 Code of 1986, as amended, available through the purchase of a health insurance plan in a health care
30 exchange, whether federally facilitated, state based, or operated on a partnership basis and the
31 benefits potentially covered under such insurance."; and

33 Further amend said bill, Page 6, Section 208.166, Line 108, by inserting after all of said section and
34 line the following:

36 "208.186. 1. Any person participating in the MO HealthNet program who has pled guilty to
37 or been found guilty of a crime or in a juvenile case admitted to allegations or had allegations found
38 to be true involving alcohol or a controlled substance or any crime in which alcohol or substance
39 abuse was, in the opinion of the court, a contributing factor to the person's commission of the crime
40 shall be required to obtain an assessment by a treatment provider approved by the department of
41 mental health to determine the need for services. Recommendations of the treatment provider may

1 be used by the court in sentencing or rendering of a disposition.

2 2. Any person participating in the MO HealthNet program who is a parent or guardian of a
3 child subject to proceedings in juvenile court under subsection 1 or 2 of section 211.031, whose
4 misuse of controlled substances or alcohol is found to be a significant, contributing factor to the
5 reason the child was adjudicated shall be required to obtain an assessment by a treatment provider
6 approved by the department of mental health to determine the need for services. Recommendations
7 of the treatment provider shall be included in the child's juvenile court record. The court may order
8 the parent or guardian to successfully complete treatment before the child is reunified with the parent
9 or guardian.

10 3. The MO HealthNet division shall certify a MO HealthNet participant's enrollment in MO
11 HealthNet if requested by the court under this section. A letter signed by the director of the MO
12 HealthNet division, his or her designee, or the family support division certifying that the individual
13 is a participant in the MO HealthNet program shall be prima facie evidence of such participation and
14 shall be admissible into evidence without further foundation for that purpose. The letter may specify
15 additional information such as anticipated dates of coverage as may be deemed necessary by the
16 department of social services.

17 208.189. 1. As used in this section, the following terms shall mean:

18 (1) "Health information exchange" or "HIE", the electronic movement of health-related
19 information among organizations in accordance with nationally recognized standards, with the goal
20 of facilitating access to and retrieval of clinical data to provide safe, timely, efficient, effective,
21 equitable, patient-centered care;

22 (2) "HIPAA", the federal Health Insurance Portability and Accountability Act.

23 2. The MO HealthNet division shall contract for a system that shall:

24 (1) Support an interoperable data analytics platform for analyzing clinical data for defined
25 populations, such as mothers at risk of premature birth, frequent utilizers of emergency departments,
26 and those suffering from chronic pain conditions. The system shall be able to leverage cloud-based
27 technology and be hosted remotely by the vendor of the application services system with
28 interoperability capabilities to connect with disparate systems;

29 (2) Have the ability to interoperate using accepted industry standards, collect and aggregate
30 data from disparate systems, and include, but not be limited to, clinical data, electronic medical
31 records, claims and eligibility databases, state-managed registries, and health information exchanges;

32 (3) Provide a member portal to beneficiaries to view and manage their personal health
33 information, wellness plans, and overall health, and a HIPAA-compliant provider portal that allows
34 providers access to patient information;

35 (4) Allow for real-time patient queries and present clinical information to providers for the
36 purpose of avoiding duplicate tests and improving care coordination;

37 (5) Have the ability to create condition-specific registries for managing populations and
38 provide predictive modeling or alerting functionality which alerts providers of at-risk patients and is
39 able to communicate between various systems to provide electronic medical record (EMR) workflow
40 integration or similar tools to communicate with a health care provider's workflow; and

41 (6) Operate on a statewide, regional, or community-wide basis.

1 3. All MO HealthNet providers providing services to MO HealthNet recipients shall be
2 required to participate in the system described in this section for their MO HealthNet recipient
3 patients.

4 208.631. 1. Notwithstanding any other provision of law to the contrary, the MO HealthNet
5 division shall establish a program to pay for health care for uninsured children. Coverage pursuant
6 to sections 208.631 to 208.659 is subject to appropriation. The provisions of sections 208.631 to
7 208.569, health care for uninsured children, shall be void and of no effect if there are no funds of the
8 United States appropriated by Congress to be provided to the state on the basis of a state plan
9 approved by the federal government under the federal Social Security Act. If funds are appropriated
10 by the United States Congress, the department of social services is authorized to manage the state
11 children's health insurance program (SCHIP) allotment in order to ensure that the state receives
12 maximum federal financial participation. Children in households with incomes up to one hundred
13 fifty percent of the federal poverty level may meet all Title XIX program guidelines as required by
14 the Centers for Medicare and Medicaid Services. Children in households with incomes of one
15 hundred fifty percent to three hundred percent of the federal poverty level shall continue to be
16 eligible as they were and receive services as they did on June 30, 2007, unless changed by the
17 Missouri general assembly.

18 2. For the purposes of sections 208.631 to 208.659, "children" are persons up to nineteen
19 years of age. "Uninsured children" are persons up to nineteen years of age who are emancipated and
20 do not have access to affordable employer-subsidized health care insurance or other health care
21 coverage or persons whose parent or guardian have not had access to affordable employer-subsidized
22 health care insurance or other health care coverage for their children for six months prior to
23 application, are residents of the state of Missouri, and have parents or guardians who meet the
24 requirements in section 208.636. A child who is eligible for MO HealthNet benefits as authorized in
25 section 208.151 is not uninsured for the purposes of sections 208.631 to 208.659.

26 3. Beginning October 1, 2020, a child eligible under sections 208.631 to 208.658 shall only
27 remain eligible if, in addition to the other requirements, his or her parents do not have access to
28 health insurance coverage for the child through their employment or through a health insurance plan
29 in a health care exchange, whether federally facilitated, state based, or operated on a partnership
30 basis because the parents are not eligible for a premium subsidy for the child or family through such
31 exchange. This subsection shall not go into effect unless and until, for a six-month period preceding
32 the additional requirements, there are health insurance premium tax credits available for children and
33 family coverage under Section 36B of the Internal Revenue Code of 1986, as amended, available to
34 persons through the purchase of a health insurance plan in a health care exchange, whether federally
35 facilitated, state based, or operated on a partnership basis and notice has been provided to the revisor
36 of statutes.

37 4. The department of social services shall inform participants six months prior to coverage
38 being discontinued under subsection 3 of this section as to the possibility of insurance coverage
39 through the purchase of a subsidized health insurance plan available through a health care exchange.

40 208.640. 1. Parents and guardians of uninsured children with incomes of more than one
41 hundred fifty but less than three hundred percent of the federal poverty level who do not have access

to affordable employer-sponsored health care insurance or other affordable health care coverage may obtain coverage for their children under this section. Health insurance plans that do not cover an eligible child's preexisting condition shall not be considered affordable employer-sponsored health care insurance or other affordable health care coverage. For the purposes of sections 208.631 to 208.659, "affordable employer-sponsored health care insurance or other affordable health care coverage" refers to health insurance requiring a monthly premium of:

(1) Three percent of one hundred fifty percent of the federal poverty level for a family of three for families with a gross income of more than one hundred fifty and up to one hundred eighty-five percent of the federal poverty level for a family of three;

(2) Four percent of one hundred eighty-five percent of the federal poverty level for a family of three for a family with a gross income of more than one hundred eighty-five and up to two hundred twenty-five percent of the federal poverty level;

(3) Five percent of two hundred twenty-five percent of the federal poverty level for a family of three for a family with a gross income of more than two hundred twenty-five but less than three hundred percent of the federal poverty level.

The parents and guardians of eligible uninsured children pursuant to this section are responsible for a monthly premium as required by annual state appropriation; provided that the total aggregate cost sharing for a family covered by these sections shall not exceed five percent of such family's income for the years involved. No co-payments or other cost sharing is permitted with respect to benefits for well-baby and well-child care including age-appropriate immunizations. Cost-sharing provisions for their children under sections 208.631 to 208.659 shall not exceed the limits established by 42 U.S.C. Section 1397cc(e). If a child has exceeded the annual coverage limits for all health care services, the child is not considered insured and does not have access to affordable health insurance within the meaning of this section.

2. Beginning October 1, 2020, for the purposes of sections 208.631 to 208.659, "affordable employer-sponsored health care insurance or other affordable health care coverage" refers to health insurance requiring a premium percentage on a sliding scale based on the taxpayer's household income tier as follows:

(1) For individuals with household income up to one hundred thirty-three percent of the federal poverty level the initial premium percentage is two percent and the final premium percentage is two percent;

(2) For individuals with household income from one hundred thirty-three up to one hundred fifty percent of the federal poverty level the initial premium percentage is three percent and the final premium percentage is four percent;

(3) For individuals with household income from one hundred fifty up to two hundred percent of the federal poverty level the initial premium percentage is four percent and the final premium percentage is six and three-tenths percent;

(4) For individuals with household income from two hundred up to two hundred fifty percent of the federal poverty level the initial premium percentage is six and three-tenths percent and the final premium percentage is eight and five hundredths percent;

(5) For individuals with household income from two hundred fifty up to three hundred

1 percent of the federal poverty level the initial premium percentage is eight and five hundredths
 2 percent and the final premium percentage is nine and one-half percent;

3 (6) For individuals with household income from three hundred up to four hundred percent of
 4 the federal poverty level the initial premium percentage is nine and one-half percent and the final
 5 premium percentage is nine and one-half percent.

6 3. The department of social services shall study the expansion of a presumptive eligibility
 7 process for children for medical assistance benefits.

8 208.659. 1. The MO HealthNet division shall revise the eligibility requirements for the
 9 uninsured women's health program, as established in 13 CSR Section 70-4.090, to include women
 10 who are at least eighteen years of age and with a net family income of at or below one hundred
 11 eighty-five percent of the federal poverty level. In order to be eligible for such program, the
 12 applicant shall not have assets in excess of two hundred [and] fifty thousand dollars, nor shall the

25 208.662. 1. There is hereby established within the department of social services the
 26 "Show-Me Healthy Babies Program" as a separate children's health insurance program (CHIP) for
 27 any low-income unborn child. The program shall be established under the authority of Title XXI of
 28 the federal Social Security Act, the State Children's Health Insurance Program, as amended, and 42
 29 CFR 457.1.

30 2. For an unborn child to be enrolled in the show-me healthy babies program, his or her
 31 mother shall not be eligible for coverage under Title XIX of the federal Social Security Act, the
 32 Medicaid program as it is administered by the state, and shall not have access to affordable
 33 employer-subsidized health care insurance or other affordable health care coverage that includes
 34 coverage for the unborn child. In addition, the unborn child shall be in a family with income
 35 eligibility of no more than three hundred percent of the federal poverty level, or the equivalent
 36 modified adjusted gross income, unless the income eligibility is set lower by the general assembly
 37 through appropriations. In calculating family size as it relates to income eligibility, the family shall
 38 include, in addition to other family members, all unborn children.

39 3. Coverage for an unborn child enrolled in the show-me healthy babies program shall
 40 include all prenatal care and pregnancy-related services that benefit the health of the unborn child
 41 and that promote healthy labor, delivery, and birth. Coverage need not include services that are

solely for the benefit of the pregnant mother, that are unrelated to maintaining or promoting a healthy pregnancy, or that provide no benefit to the unborn child. However, the department may include pregnancy-related assistance as defined in 42 U.S.C. Section 1397II.

4. There shall be no waiting period before an unborn child may be enrolled in the show-me healthy babies program. In accordance with the definition of child in 42 CFR 457.10, coverage shall include the period from conception to birth. The department shall develop a presumptive eligibility procedure for enrolling an unborn child, which shall include verification of the pregnancy.

5. Coverage for the child shall continue for up to one year after birth, unless otherwise prohibited by law or limited by the general assembly through appropriations.

6. Pregnancy-related and postpartum coverage for the mother shall begin on the day the pregnancy ends and extend through the last day of the month that includes the sixtieth day after the pregnancy ends, unless otherwise prohibited by law or limited by the general assembly through appropriations. The department may include pregnancy-related assistance as defined in 42 U.S.C. 1397II.

7. The department may provide coverage for an unborn child enrolled in the show-me healthy babies program through:

(1) Direct coverage whereby the state pays health care providers directly, by contracting with a managed care organization or with a group or individual health insurance provider;

(2) A premium assistance program whereby the state assists in payment of the premiums, co-payments, coinsurance, or deductibles for a person who is eligible for health coverage through an employer, former employer, labor union, credit union, church, spouse, other organization, other individual, or through an individual health insurance policy that includes coverage for the unborn child when such person needs assistance in paying such premiums, co-payments, coinsurance, or deductibles;

(3) A combination of direct coverage when the unborn child is first enrolled and premium assistance after the child is born; or

(4) Any other similar arrangement whereby there:

(a) Are lower program costs without sacrificing health care coverage for the unborn child or the child up to one year after birth;

(b) Are greater covered services for the unborn child or the child up to one year after birth;

(c) Is also coverage for siblings or other family members, including the unborn child's mother, such as by providing pregnancy-related assistance under 42 U.S.C. 1397II, relating to coverage of targeted low-income pregnant women through the children's health insurance program (CHIP); or

(d) Will be an ability for the child to transition more easily to non-government or less government-subsidized group or individual health insurance coverage after the child is no longer enrolled in the show-me healthy babies program.

8. The department shall provide information about the show-me healthy babies program to maternity homes as defined in section 135.600, pregnancy resource centers as defined in section 135.630, and other similar agencies and programs in the state that assist unborn children and their mothers. The department shall consider allowing such agencies and programs to assist in the

1 enrollment of unborn children in the program and in making determinations about presumptive
 2 eligibility and verification of the pregnancy.

3 9. Within sixty days after the effective date of this section, the department shall submit a
 4 state plan amendment or seek any necessary waivers from the federal Department of Health and
 5 Human Services requesting approval for the show-me healthy babies program.

6 10. At least annually, the department shall prepare and submit a report to the governor, the
 7 speaker of the house of representatives, and the president pro tempore of the senate analyzing and
 8 projecting the cost savings and benefits, if any, to the state, counties, local communities, school
 9 districts, law enforcement agencies, correctional centers, health care providers, employers, other
 10 public and private entities, and persons by enrolling unborn children in the show-me healthy babies
 11 program. The analysis and projection of cost savings and benefits, if any, may include, but need not
 12 be limited to:

13 (1) The higher federal matching rate for having an unborn child enrolled in the show-me
 14 healthy babies program versus the lower federal matching rate for a pregnant woman being enrolled
 15 in MO HealthNet or other federal programs;

16 (2) The efficacy in providing services to unborn children through managed care
 17 organizations, group or individual health insurance providers, premium assistance, or through other
 18 nontraditional arrangements of providing health care;

19 (3) The change in the proportion of unborn children who receive care in the first trimester of
 20 pregnancy due to a lack of waiting periods, by allowing presumptive eligibility, or by removal of
 21 other barriers, and any resulting or projected decrease in health problems and other problems for
 22 unborn children and women throughout pregnancy; at labor, delivery, and birth; and during infancy
 23 and childhood;

24 (4) The change in healthy behaviors by pregnant women, such as the cessation of the use of
 25 tobacco, alcohol, illicit drugs, or other harmful practices, and any resulting or projected short-term
 26 and long-term decrease in birth defects; poor motor skills; vision, speech, and hearing problems;
 27 breathing and respiratory problems; feeding and digestive problems; and other physical, mental,
 28 educational, and behavioral problems; and

29 (5) The change in infant and maternal mortality, pre-term births and low birth weight babies,
 30 and any resulting or projected decrease in short-term and long-term medical and other interventions.

31 11. The show-me healthy babies program shall not be deemed an entitlement program, but
 32 instead shall be subject to a federal allotment or other federal appropriations and matching state
 33 appropriations.

34 12. Nothing in this section shall be construed as obligating the state to continue the show-me
 35 healthy babies program if the allotment or payments from the federal government end, are not
 36 sufficient for the program to operate, or if the general assembly does not appropriate funds for the
 37 program.

38 13. Nothing in this section shall be construed as expanding MO HealthNet or fulfilling a
 39 mandate imposed by the federal government on the state.

40 208.790. 1. The applicant shall have or intend to have a fixed place of residence in Missouri,
 41 with the present intent of maintaining a permanent home in Missouri for the indefinite future. The

burden of establishing proof of residence within this state is on the applicant. The requirement also applies to persons residing in long-term care facilities located in the state of Missouri.

2. The department shall promulgate rules outlining standards for documenting proof of residence in Missouri. Documents used to show proof of residence shall include the applicant's name and address in the state of Missouri.

3. Applicant household income limits for eligibility shall be subject to appropriations, but in no event shall applicants have household income that is greater than one hundred eighty-five percent of the federal poverty level for the applicable family size for the applicable year as converted to the MAGI equivalent net income standard.

4. The department shall promulgate rules outlining standards for documenting proof of household income.

208.798. The provisions of sections 208.780 to 208.798 shall terminate on August 28, [2014] 2017."; and

Further amend said bill, Page 8, Section 208.952, Line 52, by inserting after all of said section and line the following:

"208.990. 1. Notwithstanding any other provisions of law to the contrary, to be eligible for MO HealthNet coverage individuals shall meet the eligibility criteria set forth in 42 CFR 435, including but not limited to the requirements that:

(1) The individual is a resident of the state of Missouri;

(2) The individual has a valid Social Security number;

(3) The individual is a citizen of the United States or a qualified alien as described in Section 431 of the Personal Responsibility and Work Opportunity Reconciliation Act of 1996, 8 U.S.C. Section 1641, who has provided satisfactory documentary evidence of qualified alien status which has been verified with the Department of Homeland Security under a declaration required by Section 1137(d) of the Personal Responsibility and Work Opportunity Reconciliation Act of 1996 that the applicant or beneficiary is an alien in a satisfactory immigration status; and

(4) An individual claiming eligibility as a pregnant woman shall verify pregnancy.

The department may contract with an administrative service organization to conduct the annual redeterminations if it is cost effective.

3. The department, or family support division, shall conduct electronic searches to redetermine eligibility on the basis of income, residency, citizenship, identity and other criteria as described in 42 CFR 435.916 upon availability of federal, state, and commercially available electronic data sources. The department, or family support division, may enter into a contract with a vendor to perform the electronic search of eligibility information not disclosed during the application process and obtain an applicable case management system. The department shall retain final authority over eligibility determinations made during the redetermination process.

4. Notwithstanding any other provisions of law to the contrary, applications for MO

HealthNet benefits shall be submitted in accordance with the requirements of 42 CFR 435.907 and other applicable federal law. The individual shall provide all required information and documentation necessary to make an eligibility determination, resolve discrepancies found during the redetermination process, or for a purpose directly connected to the administration of the medical assistance program.

5. Notwithstanding any other provisions of law to the contrary, to be eligible for MO HealthNet coverage under section 208.991, individuals shall meet the eligibility requirements set forth in subsection 1 of this section and all other eligibility criteria set forth in 42 CFR 435 and 457, including, but not limited to, the requirements that:

(1) The department of social services shall determine the individual's financial eligibility based on projected annual household income and family size for the remainder of the current calendar year;

(2) The department of social services shall determine household income for the purpose of determining the modified adjusted gross income by including all available cash support provided by the person claiming such individual as a dependent for tax purposes;

(3) The department of social services shall determine a pregnant woman's household size by counting the pregnant woman plus the number of children she is expected to deliver;

(4) CHIP-eligible children shall be uninsured, shall not have access to affordable insurance, and their parent shall pay the required premium;

(5) An individual claiming eligibility as an uninsured woman shall be uninsured.

6. The MO HealthNet program shall not provide MO HealthNet coverage under subsection 4 of section 208.991 to a parent or other caretaker relative living with a dependent child unless the child is receiving benefits as required by a court order, under the MO HealthNet program, the Children's Health Insurance Program (CHIP) under 42 CFR Chapter IV, Subchapter D, or otherwise is enrolled in minimum essential coverage as defined in 42 CFR 435.4.

7. (1) The provisions of subsections 2 and 8 of section 208.151, section 208.186, section 208.659, section 208.662, subsection 6 of this section, subdivisions (1) and (7) of subsection 1 of section 208.991, subsections 3 to 12, 14, and 15 of section 208.991, and sections 208.997, 208.998, 208.1000, and 208.1001 shall be null and void unless and until:

(a) Any necessary waivers or state plan amendments have been granted by the federal government to implement the provisions of subsections 6 and 7 of section 208.991 and subsection 11 of section 208.998;

(b) Eligibility of persons set out in subsection 4 of section 208.991 has been approved by the federal Department of Health and Human Services and notice has been provided by the director of the department of social services to the revisor of statutes;

(c) The federal Department of Health and Human Services grants the required waivers, state plan amendments, and enhanced federal funding rate for persons newly eligible under subsection 4 of section 208.991 whereby the federal government agrees to pay the percentages specified in Section 2001 of P.L. 111-148, as that section existed on March 23, 2010; and

(d) The federal Department of Health and Human Services grants the enhanced federal funding rate whereby the federal government agrees to pay the percentages specified in Section 2001

of P.L. 111-148, as that section existed on March 23, 2010, for the department to provide coverage for persons under subsection 9 of section 208.991.

(2) Upon receipt and approval of all necessary waivers and state plan amendments and the enhanced federal funding rate, the director of the department of social services shall notify the revisor of statutes.

(3) If the federal funds at the disposal of the state shall at any time become less than ninety percent of the funds necessary to cover the cost of benefits provided to MO HealthNet participants eligible for coverage under subsection 4 of section 208.991 or are not appropriated to pay the percentages specified in Section 2001 of P. L. 111-148, as that section existed on March 23, 2010, the provisions listed in subdivision (1) of this subsection shall be null and void. [(5)] (6) "MAGI equivalent net income standard", an income eligibility threshold based on modified adjusted gross income that is not less than the income eligibility levels that were in effect prior to the enactment of Public Law 111-148 and Public Law 111-152;

(a) Described in 42 CFR 438.50(d)(3);

- 1 **(b) With disabling mental disorders;**
- 2 **(c) With chronic substance use disorders;**
- 3 **(d) With serious and complex medical conditions;**
- 4 **(e) With a physical, intellectual, or developmental disability that significantly impairs their**
5 **ability to perform one or more activities of daily living; or**
- 6 **(f) With a disability determination based on Social Security criteria.**
- 7 2. (1) Effective January 1, 2014, notwithstanding any other provision of law to the contrary,

(b) Require personal responsibility in the payment of health care by establishing appropriate co-payments based on family income that shall discourage the use of emergency department visits for non-emergent health situations and promote responsible use of other health care services;

(c) Promote the adoption of healthier personal habits including limiting tobacco use or behaviors that lead to obesity;

(d) Allow recipients to receive an annual cash incentive if federal financial participation is obtained for such an incentive, or a cash equivalent if not, to promote responsible behavior and encourage efficient use of health care services;

19 eligible for MO HealthNet under subsections 2 and 4 of this section to enroll in employer-provided
20 health plans or other private health plans based on cost-effective principles determined by the
21 department.

22 9. Upon implementation of subsection 4 of this section, the department shall obtain health
23 care coverage for persons who have an income between one hundred percent and one hundred
24 thirty-three percent of the federal poverty level for the applicable family size, for the applicable year
25 as converted to the MAGI equivalent net income standard, who meet all other requirements of
26 subsection 4 of this section and have not been determined to be medically frail by the department,
27 through a health care exchange operating in this state, whether federally facilitated, state based, or
28 operated on a partnership basis, or an employer. The department shall ensure the participants receive
29 the minimum services required to ensure federal reimbursement at the percentages specified in
30 Section 2001 of Public Law 111-148. The department shall require cost sharing to the maximum
31 extent allowed by law.

32 10. Upon implementation of subsection 4 of this section, all persons who have an income up
33 to one hundred thirty-three percent of the federal poverty level for the applicable family size, for the
34 applicable year as converted to the MAGI equivalent net income standard, who are eligible for MO
35 HealthNet benefits under subsection 4 of this section who meet the definition of medically frail shall
36 receive all benefits they are eligible to receive under sections 208.152, 208.900, 208.903, 208.909,
37 and 208.930.

38 11. The department shall establish a screening process in conjunction with the department of
39 mental health and the department of health and senior services for determining whether an individual
40 is medically frail and shall enroll all eligible individuals who meet the definition of medically frail
41 and whose care management would benefit from being assigned a health home in the health home

1 program or other care coordination as established by the department. Any eligible individual may
 2 opt out of the health home program.

3 12. For individuals who meet the definition of medically frail, the department shall develop
 4 an incentive program to promote the adoption of healthier personal habits including limiting tobacco
 5 use or behaviors that lead to obesity and for those individuals who utilize the health home program in
 6 subsection 11 of this section.

7 13. The department or appropriate divisions of the department shall promulgate rules to
 8 implement the provisions of this section. Any rule or portion of a rule, as the term is defined in

 11 section 536.028. This section and chapter 536 are nonseverable and if any of the powers vested with
 12 the general assembly pursuant to chapter 536 to review, to delay the effective date or to disapprove
 13 and annul a rule are subsequently held unconstitutional, then the grant of rulemaking authority and
 14 any rule proposed or adopted after August 28, 2013, shall be invalid and void.

15 [4.] 14. The department shall submit such state plan amendments and waivers to the Centers
 16 for Medicare and Medicaid Services of the federal Department of Health and Human Services as the
 17 department determines are necessary to implement the provisions of this section. The department
 18 shall request of the federal government an enhanced federal funding rate for persons newly eligible
 19 under subsection 4 of this section whereby the federal government agrees to pay the percentages
 20 specified in Section 2001 of P.L. 111-148, as that section existed on March 23, 2010. The provisions
 21 of subsections 4 to 12 of this section shall not be implemented unless such waivers and enhanced
 22 federal funding rates are granted by the federal government.

23 15. If at any time the director receives notice that the federal funds at the disposal of the state
 24 for payments of money benefits to or on behalf of any persons under subsection 4 of this section
 25 shall at any time become less than ninety percent of the funds necessary to cover the cost of benefits
 26 provided to MO HealthNet participants eligible for coverage under subsections 4, 5, 8, 9, 10, and 12
 27 of this section or are not appropriated to pay the percentages specified in Section 2001 of Public Law
 28 111-148, as that section existed on March 23, 2010, subsections 4 to 12 of this section shall no longer
 29 be effective for the individuals whose benefits are no longer matchable at the specified percentages.
 30 The date benefits cease shall be stated in a notice sent to the affected individuals.

31 16. The department may seek and apply for grants to educate MO HealthNet recipients how
 32 to:

- 33 (1) Increase their overall health and well-being;
- 34 (2) Improve health outcomes; and
- 35 (3) Properly utilize health care providers and services.

36 208.997. 1. The MO HealthNet division shall develop and implement the "Health Care
 37 Homes Program" as a provider-directed care coordination program for MO HealthNet recipients who
 38 are not enrolled in a prepaid MO HealthNet benefits option and who are receiving services on a
 39 fee-for-service basis or are otherwise identified by the department. The health care homes program
 40 shall provide payment to primary care clinics, community mental health centers, and other
 41 appropriate providers for care coordination for individuals who are deemed medically frail. Clinics

1 shall meet certain criteria including, but not limited to, the following:

2 (1) The capacity to develop care plans;

3 (2) A dedicated care coordinator;

4 (3) An adequate number of clients, evaluation mechanisms, and quality improvement
5 processes to qualify for reimbursement; and

17 5. The department or appropriate divisions of the department may promulgate rules to

19 section 536.010, that is created under the authority delegated in this section shall become effective
20 only if it complies with and is subject to all of the provisions of chapter 536 and, if applicable,
21 section 536.028. This section and chapter 536 are nonseverable and if any of the powers vested with

25 6. Nothing in this section shall be construed to limit the department's ability to create health
26 care homes for participants in a managed care plan.

27 208.998. 1. Except for individuals who meet the definition of medically frail, individuals
28 who qualify for coverage under subsections 2 and 4 of section 208.991 shall receive covered services
29 through health plans offered by managed care entities which are authorized by the department.
30 Health plans authorized by the department:

31 (1) Shall resemble commercially available health plans while complying with federal
32 Medicaid requirements as authorized by federal law or through a federal waiver and may include
33 risk-bearing accountable care organizations which provide covered services to individuals who
34 qualify for coverage under subsection 4 of section 208.991 and managed care organizations paid on a
35 capitated basis which provide covered services to individuals who qualify for coverage under
36 subsections 2 and 4 of section 208.991;

37 (2) Shall promote, to the greatest extent possible, the opportunity for children and their
38 parents to be covered under the same plan;

39 (3) Shall offer plans statewide;

40 (4) Shall include cost sharing for outpatient services to the maximum extent allowed by
41 federal law;

1 (5) May include other co-payments and provide incentives that encourage and reward the
2 prudent use of the health benefit provided;

3 (6) Shall encourage access to care through provider rates that include pay-for-performance
4 and are comparable to commercial rates. The department of social services shall determine
5 pay-for-performance provisions that managed care organizations shall execute and shall provide
6 incentives for managed care organizations that perform well;

7 (7) Shall provide incentives, including shared risk and savings, to health plans and providers
8 to encourage cost-effective delivery of care;

9 (8) Shall provide incentive programs for participants to encourage healthy behaviors and
10 promote the adoption of healthier personal habits including limiting tobacco use or behaviors that
11 lead to obesity;

12 (9) May provide multiple plan options and reward participants for choosing a low-cost plan;

13 (10) Shall include the services of community mental health centers; and

14 (11) Shall include the services of health providers as defined in 42 U.S.C. Section
15 1396d(1)(1) and (2) and meet the payment requirements for such health providers as provided in 42
16 U.S.C. Sections 1396a(a)(15) and 1396a(bb).

17 2. The department may designate that certain health care services be excluded from such
18 health plans if it is determined cost effective by the department.

19 3. (1) The department may accept regional proposals as an additional option for
20 beneficiaries.

21 (2) The department shall advance the development of systems of care for medically complex
22 children who are recipients of MO HealthNet benefits by accepting cost-effective regional proposals
23 from and contracting with appropriate pediatric care networks, pediatric centers for excellence, and
24 medical homes for children to provide MO HealthNet benefits when the department determines it is
25 cost effective to do so.

26 (3) The provisions of subsection 1 of this section shall not apply to this subsection.

27 4. The department shall establish, in collaboration with plans and providers, uniform
28 utilization review protocols to be used by all authorized health plans.

29 5. Any managed care organization that enters into a contract with the state to provide
30 managed care plans shall be required to fulfill the terms of the contract and provide such plans for at

41 choose their plan. In the enrollment process participants shall be provided a list of all plans available

1 ranked by the relative actuarial value of each plan. Each participant shall be informed in the
2 enrollment process that he or she will be eligible to receive a portion of the amount saved by
3 Missouri taxpayers if he or she chooses a lower cost plan offered in his or her region. The portion
4 received by a participant shall be determined by the department according to the department's best

15 (2) Emergency services;

16 (3) Hospitalization;

17 (4) Maternity and newborn care;

18 (5) Mental health and substance abuse treatment, including behavioral health treatment;

19 (6) Prescription drugs;

20 (7) Rehabilitative and habilitative services and devices;

21 (8) Laboratory services;

22 (9) Preventive and wellness care, and chronic disease management;

23 (10) Pediatric services, including oral and vision care; and

24 (11) Any other services required by federal law.

25 9. No MO HealthNet plan or program shall provide coverage for an abortion unless a
26 physician certifies in writing to the MO HealthNet agency that, in the physician's professional
27 judgment, the life of the mother would be endangered if the fetus were carried to term.

28 10. The MO HealthNet program shall require managed care plans under this section to
29 provide a high deductible health plan option for uninsured adults nineteen years of age or older and
30 under sixty-five years of age with incomes of less than one hundred percent of the federal poverty
31 level as converted to the MAGI equivalent net income standard who are enrolled in managed care
32 plans under this section. The high deductible health plan shall include:

33 (1) A minimum deductible of one thousand dollars and upon meeting the deductible,
34 coverage for benefits as specified by rule of the department;

35 (2) An account, funded by the department, of at least one thousand dollars per adult to pay
36 medical costs for the initial deductible in the form of a prepaid card;

37 (3) Preventive care, as defined by the department by rule, that is not subject to the deductible
38 and does not require a payment of moneys from the account described in subdivision (2) of this

40 (4) A basic benefits package if annual medical costs exceed one thousand dollars;

41 (5) Primary care provider visits, as defined by the department by rule, that are not subject to

3 (6) As soon as practicable, the establishment and maintenance of a record-keeping system
 4 for each health care visit or service received by recipients under this subsection. The plan shall
 5 require that the recipient's prepaid card number be entered or electronic strip be swiped by the health
 6 care provider for purposes of maintaining a record of every health care visit or service received by
 7 the recipient from such provider, regardless of any balance on the recipient's card. Such information
 8 shall include only the date, provider name, and general description of the visit or service provided.
 9 The plan shall maintain a complete history of all health care visits and services for which the
 10 recipient's prepaid card is entered or swiped in accordance with this subdivision. If required under
 11 the federal Health Insurance Portability and Accountability Act (HIPAA) or other relevant state or
 12 federal law or regulation, a recipient shall, as a condition of participation in the prepaid card
 13 incentive, be required to provide a written waiver for disclosure of any information required under
 14 this subdivision;

15 (7) The determination of a proportion of the amount left in a participant's account described
 16 in subdivision (2) of this subsection at the end of the plan year, which shall be paid to the participant
 17 for saving taxpayer money. The amount and method of payment shall be determined by the

 20 of this subsection which shall be used to subsidize premiums to facilitate a participant's transition

23 11. The department shall require managed care plans under this section to offer an incentive
 24 program in which all MO HealthNet participants with chronic conditions, as specified by the

 26 obtain specified primary care and preventive services and who participate or refrain from
 27 participation in specified activities to improve the overall health of the recipient shall be eligible to

 16 provisions of chapter 536 and, if applicable, section 536.028. This section and chapter 536 are
 17 nonseverable and if any of the powers vested with the general assembly under chapter 536 to review,
 18 to delay the effective date, or to disapprove and annul a rule are subsequently held unconstitutional,

The department of social services shall develop regional care coordination models among networks of health care providers to meet the needs of and reduce the costs incurred by MO HealthNet beneficiaries who frequently or inefficiently utilize emergency department services. The objectives of such models shall include, but not be limited to:

- (1) Reducing emergency department utilization;
- (2) Reducing unnecessary utilization of diagnostic services, pharmacy costs, inpatient encounters, and admissions;
- (3) Increasing quality and coordination of care through leveraging community resources and care management;
- (4) Improving the patient experience and quality of care; and
- (5) Achieving net savings of ten to thirteen percent over a three-year period for MO HealthNet participants.

2. The regional care coordination models shall require the development of an algorithm that uses analytical approaches to identify prospective participants who have a history of presenting in an emergency department for care on at least ten occasions over a twelve-month period. Prospective participants also shall be screened based on claims and other available data to predict the likely value of intense care coordination to reduce costs and improve care. The regional care coordination models shall incorporate the following strategies:

- (1) Utilization of a multi-disciplinary, team-based approach that adapts health care and community resources to the participant's individual needs;
- (2) Utilization of resources and sharing of information among the care management team to develop a comprehensive care management program based on social, clinical, and behavioral assessments. The care management team shall include medical direction from a physician supported by additional health care professionals and community resources as necessary; and
- (3) Creation of a sustainable program in coordination with the regional networks of health care providers whereby the department measures and tracks baseline expenditures on a per-member, per-month basis for the target population. The department shall develop a shared savings funding model that may be adapted to a wider array of health payment models.

3. The department also shall develop additional innovative programs that seek to address the cost and quality of care for individuals who disproportionately utilize emergency departments for care. Health care providers participating in the regional care coordination models shall be encouraged to include uninsured individuals who frequently utilize the emergency department for care in this program to the greatest extent possible."; and
