1 AMEND House Committee Substitute for House Bill No. 1662, Page 3, Section 191.875, Line 80,
2 by inserting after all of said section and line the following:

4 "208.151. 1. Medical assistance on behalf of needy persons shall be known as "MO
5 HealthNet". For the purpose of paying MO HealthNet benefits and to comply with Title XIX, Public
6 Law 89-97, 1965 amendments to the federal Social Security Act (42 U.S.C. Section 301, et seq.) as
7 amended, the following needy persons shall be eligible to receive MO HealthNet benefits to the
8 extent and in the manner hereinafter provided, unless otherwise provided in subsection 2 of this
9 section:

10 (1) All participants receiving state supplemental payments for the aged, blind and disabled;

11 (2) All participants receiving aid to families with dependent children benefits, including all
12 persons under nineteen years of age who would be classified as dependent children except for the
13 requirements of subdivision (1) of subsection 1 of section 208.040. Participants eligible under this
14 subdivision who are participating in drug court, as defined in section 478.001, shall have their
15 eligibility automatically extended sixty days from the time their dependent child is removed from the
16 custody of the participant, subject to approval of the Centers for Medicare and Medicaid Services;

17 (3) All participants receiving blind pension benefits;

18 (4) All persons who would be determined to be eligible for old age assistance benefits,
19 permanent and total disability benefits, or aid to the blind benefits under the eligibility standards in
20 effect December 31, 1973, or less restrictive standards as established by rule of the family support
21 division, who are sixty-five years of age or over and are patients in state institutions for mental
22 diseases or tuberculosis;

23 (5) All persons under the age of twenty-one years who would be eligible for aid to families
24 with dependent children except for the requirements of subdivision (2) of subsection 1 of section
25 208.040, and who are residing in an intermediate care facility, or receiving active treatment as
26 inpatients in psychiatric facilities or programs, as defined in 42 U.S.C. 1396d, as amended;

27 (6) All persons under the age of twenty-one years who would be eligible for aid to families
28 with dependent children benefits except for the requirement of deprivation of parental support as
29 provided for in subdivision (2) of subsection 1 of section 208.040;

30 (7) All persons eligible to receive nursing care benefits;

31 (8) All participants receiving family foster home or nonprofit private child-care institution

1 care, subsidized adoption benefits and parental school care wherein state funds are used as partial or
2 full payment for such care;

3 (9) All persons who were participants receiving old age assistance benefits, aid to the
4 permanently and totally disabled, or aid to the blind benefits on December 31, 1973, and who
5 continue to meet the eligibility requirements, except income, for these assistance categories, but who
6 are no longer receiving such benefits because of the implementation of Title XVI of the federal
7 Social Security Act, as amended;

8 (10) Pregnant women who meet the requirements for aid to families with dependent
9 children, except for the existence of a dependent child in the home;

10 (11) Pregnant women who meet the requirements for aid to families with dependent
11 children, except for the existence of a dependent child who is deprived of parental support as
12 provided for in subdivision (2) of subsection 1 of section 208.040;

13 (12) Pregnant women or infants under one year of age, or both, whose family income does
14 not exceed an income eligibility standard equal to one hundred eighty-five percent of the federal
15 poverty level as established and amended by the federal Department of Health and Human Services,
16 or its successor agency;

17 (13) Children who have attained one year of age but have not attained six years of age who
18 are eligible for medical assistance under 6401 of P.L. 101-239 (Omnibus Budget Reconciliation Act
19 of 1989). The family support division shall use an income eligibility standard equal to one hundred
20 thirty-three percent of the federal poverty level established by the Department of Health and Human
21 Services, or its successor agency;

22 (14) Children who have attained six years of age but have not attained nineteen years of age.
23 For children who have attained six years of age but have not attained nineteen years of age, the
24 family support division shall use an income assessment methodology which provides for eligibility
25 when family income is equal to or less than equal to one hundred percent of the federal poverty level
26 established by the Department of Health and Human Services, or its successor agency. As necessary
27 to provide MO HealthNet coverage under this subdivision, the department of social services may
28 revise the state MO HealthNet plan to extend coverage under 42 U.S.C. 1396a (a)(10)(A)(i)(III) to
29 children who have attained six years of age but have not attained nineteen years of age as permitted
30 by paragraph (2) of subsection (n) of 42 U.S.C. 1396d using a more liberal income assessment
31 methodology as authorized by paragraph (2) of subsection (r) of 42 U.S.C. 1396a;

32 (15) The family support division shall not establish a resource eligibility standard in
33 assessing eligibility for persons under subdivision (12), (13) or (14) of this subsection. The MO
34 HealthNet division shall define the amount and scope of benefits which are available to individuals
35 eligible under each of the subdivisions (12), (13), and (14) of this subsection, in accordance with the
36 requirements of federal law and regulations promulgated thereunder;

37 (16) Notwithstanding any other provisions of law to the contrary, ambulatory prenatal care
38 shall be made available to pregnant women during a period of presumptive eligibility pursuant to 42
39 U.S.C. Section 1396r-1, as amended;

40 (17) A child born to a woman eligible for and receiving MO HealthNet benefits under this
41 section on the date of the child's birth shall be deemed to have applied for MO HealthNet benefits

1 and to have been found eligible for such assistance under such plan on the date of such birth and to
2 remain eligible for such assistance for a period of time determined in accordance with applicable
3 federal and state law and regulations so long as the child is a member of the woman's household and
4 either the woman remains eligible for such assistance or for children born on or after January 1,
5 1991, the woman would remain eligible for such assistance if she were still pregnant. Upon
6 notification of such child's birth, the family support division shall assign a MO HealthNet eligibility
7 identification number to the child so that claims may be submitted and paid under such child's
8 identification number;

9 (18) Pregnant women and children eligible for MO HealthNet benefits pursuant to
10 subdivision (12), (13) or (14) of this subsection shall not as a condition of eligibility for MO
11 HealthNet benefits be required to apply for aid to families with dependent children. The family
12 support division shall utilize an application for eligibility for such persons which eliminates
13 information requirements other than those necessary to apply for MO HealthNet benefits. The
14 division shall provide such application forms to applicants whose preliminary income information
15 indicates that they are ineligible for aid to families with dependent children. Applicants for MO
16 HealthNet benefits under subdivision (12), (13) or (14) of this subsection shall be informed of the aid
17 to families with dependent children program and that they are entitled to apply for such benefits.
18 Any forms utilized by the family support division for assessing eligibility under this chapter shall be
19 as simple as practicable;

20 (19) Subject to appropriations necessary to recruit and train such staff, the family support
21 division shall provide one or more full-time, permanent eligibility specialists to process applications
22 for MO HealthNet benefits at the site of a health care provider, if the health care provider requests
23 the placement of such eligibility specialists and reimburses the division for the expenses including
24 but not limited to salaries, benefits, travel, training, telephone, supplies, and equipment of such
25 eligibility specialists. The division may provide a health care provider with a part-time or temporary
26 eligibility specialist at the site of a health care provider if the health care provider requests the
27 placement of such an eligibility specialist and reimburses the division for the expenses, including but
28 not limited to the salary, benefits, travel, training, telephone, supplies, and equipment, of such an
29 eligibility specialist. The division may seek to employ such eligibility specialists who are otherwise
30 qualified for such positions and who are current or former welfare participants. The division may
31 consider training such current or former welfare participants as eligibility specialists for this
32 program;

33 (20) Pregnant women who are eligible for, have applied for and have received MO
34 HealthNet benefits under subdivision (2), (10), (11) or (12) of this subsection shall continue to be
35 considered eligible for all pregnancy-related and postpartum MO HealthNet benefits provided under
36 section 208.152 until the end of the sixty-day period beginning on the last day of their pregnancy;

37 (21) Case management services for pregnant women and young children at risk shall be a
38 covered service. To the greatest extent possible, and in compliance with federal law and regulations,
39 the department of health and senior services shall provide case management services to pregnant
40 women by contract or agreement with the department of social services through local health
41 departments organized under the provisions of chapter 192 or chapter 205 or a city health department

operated under a city charter or a combined city-county health department or other department of health and senior services designees. To the greatest extent possible the department of social services and the department of health and senior services shall mutually coordinate all services for pregnant women and children with the crippled children's program, the prevention of intellectual disability and developmental disability program and the prenatal care program administered by the department of health and senior services. The department of social services shall by regulation establish the methodology for reimbursement for case management services provided by the department of health and senior services. For purposes of this section, the term "case management" shall mean those activities of local public health personnel to identify prospective MO HealthNet-eligible high-risk mothers and enroll them in the state's MO HealthNet program, refer them to local physicians or local health departments who provide prenatal care under physician protocol and who participate in the MO HealthNet program for prenatal care and to ensure that said high-risk mothers receive support from all private and public programs for which they are eligible and shall not include involvement in any MO HealthNet prepaid, case-managed programs;

(22) By January 1, 1988, the department of social services and the department of health and senior services shall study all significant aspects of presumptive eligibility for pregnant women and submit a joint report on the subject, including projected costs and the time needed for implementation, to the general assembly. The department of social services, at the direction of the general assembly, may implement presumptive eligibility by regulation promulgated pursuant to chapter 207;

(23) All participants who would be eligible for aid to families with dependent children benefits except for the requirements of paragraph (d) of subdivision (1) of section 208.150;

(24) (a) All persons who would be determined to be eligible for old age assistance benefits under the eligibility standards in effect December 31, 1973, as authorized by 42 U.S.C. Section 1396a(f), or less restrictive methodologies as contained in the MO HealthNet state plan as of January 1, 2005; except that, on or after July 1, 2005, less restrictive income methodologies, as authorized in 42 U.S.C. Section 1396a(r)(2), may be used to change the income limit if authorized by annual appropriation;

(b) All persons who would be determined to be eligible for aid to the blind benefits under the eligibility standards in effect December 31, 1973, as authorized by 42 U.S.C. Section 1396a(f), or less restrictive methodologies as contained in the MO HealthNet state plan as of January 1, 2005, except that less restrictive income methodologies, as authorized in 42 U.S.C. Section 1396a(r)(2), shall be used to raise the income limit to one hundred percent of the federal poverty level;

(c) All persons who would be determined to be eligible for permanent and total disability benefits under the eligibility standards in effect December 31, 1973, as authorized by 42 U.S.C. 1396a(f); or less restrictive methodologies as contained in the MO HealthNet state plan as of January 1, 2005; except that, on or after July 1, 2005, less restrictive income methodologies, as authorized in 42 U.S.C. Section 1396a(r)(2), may be used to change the income limit if authorized by annual appropriations. Eligibility standards for permanent and total disability benefits shall not be limited by age;

(25) Persons who have been diagnosed with breast or cervical cancer and who are eligible

for coverage pursuant to 42 U.S.C. 1396a (a)(10)(A)(ii)(XVIII). Such persons shall be eligible during a period of presumptive eligibility in accordance with 42 U.S.C. 1396r-1;

(26) Effective August 28, 2013, persons who are in foster care under the responsibility of the state of Missouri on the date such persons attain the age of eighteen years, or at any time during the thirty-day period preceding their eighteenth birthday, without regard to income or assets, if such persons:

(a) Are under twenty-six years of age;

(b) Are not eligible for coverage under another mandatory coverage group; and

(c) Were covered by Medicaid while they were in foster care.

2. Beginning July 1, 2015, eligibility for MO HealthNet benefits shall be amended as follows:

(1) Persons eligible under subdivision (3) of subsection 1 of this section and section 208.146 with income up to and including one hundred thirty-three percent of the federal poverty level as converted to the MAGI equivalent net income standard shall be eligible for MO HealthNet benefits. Persons eligible under subdivision (3) of subsection 1 of this section with income greater than one hundred thirty-three percent of the federal poverty level as converted to the MAGI equivalent net income standard shall only be eligible for those MO HealthNet benefits they would otherwise be entitled to receive including personal care assistance services as defined in section 208.900 that are not available under a qualified health plan as the term is defined in 42 U.S.C. Section 18021(a)(1);

(2) The changes in eligibility under subdivision (1) of this subsection shall not take place unless and until there are health insurance premium tax credits under Section 36B of the Internal Revenue Code of 1986, as amended, available to persons through the purchase of a health insurance plan in a health care exchange, whether federally facilitated, state based, or operated on a partnership basis. The director of the department of revenue shall certify to the director of the department of social services that health insurance premium tax credits are available, and the director of the department of social services shall notify the revisor of statutes.

3. Rules and regulations to implement this section shall be promulgated in accordance with chapter 536. Any rule or portion of a rule, as that term is defined in section 536.010, that is created under the authority delegated in this section shall become effective only if it complies with and is subject to all of the provisions of chapter 536 and, if applicable, section 536.028. This section and chapter 536 are nonseverable and if any of the powers vested with the general assembly pursuant to chapter 536 to review, to delay the effective date or to disapprove and annul a rule are subsequently held unconstitutional, then the grant of rulemaking authority and any rule proposed or adopted after August 28, 2002, shall be invalid and void.

[3.] 4. After December 31, 1973, and before April 1, 1990, any family eligible for assistance pursuant to 42 U.S.C. 601, et seq., as amended, in at least three of the last six months immediately preceding the month in which such family became ineligible for such assistance because of increased income from employment shall, while a member of such family is employed, remain eligible for MO HealthNet benefits for four calendar months following the month in which such family would otherwise be determined to be ineligible for such assistance because of income and resource limitation. After April 1, 1990, any family receiving aid pursuant to 42 U.S.C. 601, et seq., as

1 amended, in at least three of the six months immediately preceding the month in which such family
 2 becomes ineligible for such aid, because of hours of employment or income from employment of the
 3 caretaker relative, shall remain eligible for MO HealthNet benefits for six calendar months following
 4 the month of such ineligibility as long as such family includes a child as provided in 42 U.S.C.

5 1396r-6. Each family which has received such medical assistance during the entire six-month period
 6 described in this section and which meets reporting requirements and income tests established by the
 7 division and continues to include a child as provided in 42 U.S.C. 1396r-6 shall receive MO
 8 HealthNet benefits without fee for an additional six months. The MO HealthNet division may
 9 provide by rule and as authorized by annual appropriation the scope of MO HealthNet coverage to be
 10 granted to such families.

11 [4.] 5. When any individual has been determined to be eligible for MO HealthNet benefits,
 12 such medical assistance will be made available to him or her for care and services furnished in or
 13 after the third month before the month in which he made application for such assistance if such
 14 individual was, or upon application would have been, eligible for such assistance at the time such
 15 care and services were furnished; provided, further, that such medical expenses remain unpaid.

16 [5.] 6. The department of social services may apply to the federal Department of Health and
 17 Human Services for a MO HealthNet waiver amendment to the Section 1115 demonstration waiver
 18 or for any additional MO HealthNet waivers necessary not to exceed one million dollars in additional
 19 costs to the state, unless subject to appropriation or directed by statute, but in no event shall such
 20 waiver applications or amendments seek to waive the services of a rural health clinic or a federally
 21 qualified health center as defined in 42 U.S.C. 1396d(l)(1) and (2) or the payment requirements for
 22 such clinics and centers as provided in 42 U.S.C. 1396a(a)(15) and 1396a(bb) unless such waiver
 23 application is approved by the oversight committee created in section 208.955. A request for such a
 24 waiver so submitted shall only become effective by executive order not sooner than ninety days after
 25 the final adjournment of the session of the general assembly to which it is submitted, unless it is
 26 disapproved within sixty days of its submission to a regular session by a senate or house resolution
 27 adopted by a majority vote of the respective elected members thereof, unless the request for such a
 28 waiver is made subject to appropriation or directed by statute.

29 [6.] 7. Notwithstanding any other provision of law to the contrary, in any given fiscal year,
 30 any persons made eligible for MO HealthNet benefits under subdivisions (1) to (22) of subsection 1
 31 of this section shall only be eligible if annual appropriations are made for such eligibility. This
 32 subsection shall not apply to classes of individuals listed in 42 U.S.C. Section 1396a(a)(10)(A)(i).";
 33 and

34 8. The department of social services shall notify any potential exchange-eligible participant
 35 who may be eligible for services due to spenddown that the participant may qualify for more
 36 cost-effective private insurance and premium tax credits under Section 36B of the Internal Revenue
 37 Code of 1986, as amended, available through the purchase of a health insurance plan in a health care
 38 exchange, whether federally facilitated, state based, or operated on a partnership basis and the
 39 benefits potentially covered under such insurance."; and

 41 Further amend said bill, Page 6, Section 208.166, Line 108, by inserting after all of said section and

line the following:

"208.186. 1. Any person participating in the MO HealthNet program who has pled guilty to or been found guilty of a crime or in a juvenile case admitted to allegations or had allegations found to be true involving alcohol or a controlled substance or any crime in which alcohol or substance abuse was, in the opinion of the court, a contributing factor to the person's commission of the crime shall be required to obtain an assessment by a treatment provider approved by the department of mental health to determine the need for services. Recommendations of the treatment provider may be used by the court in sentencing or rendering of a disposition.

2. Any person participating in the MO HealthNet program who is a parent or guardian of a child subject to proceedings in juvenile court under subsection 1 or 2 of section 211.031, whose misuse of controlled substances or alcohol is found to be a significant, contributing factor to the reason the child was adjudicated shall be required to obtain an assessment by a treatment provider approved by the department of mental health to determine the need for services. Recommendations of the treatment provider shall be included in the child's juvenile court record. The court may order the parent or guardian to successfully complete treatment before the child is reunified with the parent or guardian.

3. The MO HealthNet division shall certify a MO HealthNet participant's enrollment in MO HealthNet if requested by the court under this section. A letter signed by the director of the MO HealthNet division, his or her designee, or the family support division certifying that the individual is a participant in the MO HealthNet program shall be prima facie evidence of such participation and shall be admissible into evidence without further foundation for that purpose. The letter may specify additional information such as anticipated dates of coverage as may be deemed necessary by the department of social services.

208.189. 1. As used in this section, the following terms shall mean:

(1) "Health information exchange" or "HIE", the electronic movement of health-related information among organizations in accordance with nationally recognized standards, with the goal of facilitating access to and retrieval of clinical data to provide safe, timely, efficient, effective, equitable, patient-centered care;

(2) "HIPAA", the federal Health Insurance Portability and Accountability Act.

2. The MO HealthNet division shall contract for a system that shall:

(1) Support an interoperable data analytics platform for analyzing clinical data for defined populations, such as mothers at risk of premature birth, frequent utilizers of emergency departments, and those suffering from chronic pain conditions. The system shall be able to leverage cloud-based technology and be hosted remotely by the vendor of the application services system with interoperability capabilities to connect with disparate systems;

(2) Have the ability to interoperate using accepted industry standards, collect and aggregate data from disparate systems, and include, but not be limited to, clinical data, electronic medical records, claims and eligibility databases, state-managed registries, and health information exchanges;

(3) Provide a member portal to beneficiaries to view and manage their personal health information, wellness plans, and overall health, and a HIPAA-compliant provider portal that allows

1 providers access to patient information;

2 (4) Allow for real-time patient queries and present clinical information to providers for the
 3 purpose of avoiding duplicate tests and improving care coordination;

4 (5) Have the ability to create condition-specific registries for managing populations and
 5 provide predictive modeling or alerting functionality which alerts providers of at-risk patients and is
 6 able to communicate between various systems to provide electronic medical record (EMR) workflow
 7 integration or similar tools to communicate with a health care provider's workflow; and

8 (6) Operate on a statewide, regional, or community-wide basis.

9 3. All MO HealthNet providers providing services to MO HealthNet recipients shall be
 10 required to participate in the system described in this section for their MO HealthNet recipient
 11 patients.

12 208.631. 1. Notwithstanding any other provision of law to the contrary, the MO HealthNet
 13 division shall establish a program to pay for health care for uninsured children. Coverage pursuant
 14 to sections 208.631 to 208.659 is subject to appropriation. The provisions of sections 208.631 to
 15 208.659, health care for uninsured children, shall be void and of no effect if there are no funds of the
 16 United States appropriated by Congress to be provided to the state on the basis of a state plan
 17 approved by the federal government under the federal Social Security Act. If funds are appropriated
 18 by the United States Congress, the department of social services is authorized to manage the state
 19 children's health insurance program (SCHIP) allotment in order to ensure that the state receives
 20 maximum federal financial participation. Children in households with incomes up to one hundred
 21 fifty percent of the federal poverty level may meet all Title XIX program guidelines as required by
 22 the Centers for Medicare and Medicaid Services. Children in households with incomes of one
 23 hundred fifty percent to three hundred percent of the federal poverty level shall continue to be
 24 eligible as they were and receive services as they did on June 30, 2007, unless changed by the
 25 Missouri general assembly.

26 2. For the purposes of sections 208.631 to 208.659, "children" are persons up to nineteen
 27 years of age. "Uninsured children" are persons up to nineteen years of age who are emancipated and
 28 do not have access to affordable employer-subsidized health care insurance or other health care
 29 coverage or persons whose parent or guardian have not had access to affordable employer-subsidized
 30 health care insurance or other health care coverage for their children for six months prior to
 31 application, are residents of the state of Missouri, and have parents or guardians who meet the
 32 requirements in section 208.636. A child who is eligible for MO HealthNet benefits as authorized in
 33 section 208.151 is not uninsured for the purposes of sections 208.631 to 208.659.

34 3. Beginning October 1, 2020, a child eligible under sections 208.631 to 208.658 shall only
 35 remain eligible if, in addition to the other requirements, his or her parents do not have access to
 36 health insurance coverage for the child through their employment or through a health insurance plan
 37 in a health care exchange, whether federally facilitated, state based, or operated on a partnership
 38 basis because the parents are not eligible for a premium subsidy for the child or family through such
 39 exchange. This subsection shall not go into effect unless and until, for a six-month period preceding
 40 the additional requirements, there are health insurance premium tax credits available for children and
 41 family coverage under Section 36B of the Internal Revenue Code of 1986, as amended, available to

persons through the purchase of a health insurance plan in a health care exchange, whether federally facilitated, state based, or operated on a partnership basis and notice has been provided to the revisor of statutes.

4. The department of social services shall inform participants six months prior to coverage being discontinued under subsection 3 of this section as to the possibility of insurance coverage through the purchase of a subsidized health insurance plan available through a health care exchange.

208.640. 1. Parents and guardians of uninsured children with incomes of more than one hundred fifty but less than three hundred percent of the federal poverty level who do not have access to affordable employer-sponsored health care insurance or other affordable health care coverage may obtain coverage for their children under this section. Health insurance plans that do not cover an eligible child's preexisting condition shall not be considered affordable employer-sponsored health care insurance or other affordable health care coverage. For the purposes of sections 208.631 to 208.659, "affordable employer-sponsored health care insurance or other affordable health care coverage" refers to health insurance requiring a monthly premium of:

(1) Three percent of one hundred fifty percent of the federal poverty level for a family of three for families with a gross income of more than one hundred fifty and up to one hundred eighty-five percent of the federal poverty level for a family of three;

(2) Four percent of one hundred eighty-five percent of the federal poverty level for a family of three for a family with a gross income of more than one hundred eighty-five and up to two hundred twenty-five percent of the federal poverty level;

(3) Five percent of two hundred twenty-five percent of the federal poverty level for a family of three for a family with a gross income of more than two hundred twenty-five but less than three hundred percent of the federal poverty level.

The parents and guardians of eligible uninsured children pursuant to this section are responsible for a monthly premium as required by annual state appropriation; provided that the total aggregate cost sharing for a family covered by these sections shall not exceed five percent of such family's income for the years involved. No co-payments or other cost sharing is permitted with respect to benefits for well-baby and well-child care including age-appropriate immunizations. Cost-sharing provisions for their children under sections 208.631 to 208.659 shall not exceed the limits established by 42 U.S.C. Section 1397cc(e). If a child has exceeded the annual coverage limits for all health care services, the child is not considered insured and does not have access to affordable health insurance within the meaning of this section.

2. Beginning October 1, 2020, for the purposes of sections 208.631 to 208.659, "affordable employer-sponsored health care insurance or other affordable health care coverage" refers to health insurance requiring a premium percentage on a sliding scale based on the taxpayer's household income tier as follows:

(1) For individuals with household income up to one hundred thirty-three percent of the federal poverty level the initial premium percentage is two percent and the final premium percentage is two percent;

(2) For individuals with household income from one hundred thirty-three up to one hundred fifty percent of the federal poverty level the initial premium percentage is three percent and the final

1 premium percentage is four percent;

2 (3) For individuals with household income from one hundred fifty up to two hundred percent
 3 of the federal poverty level the initial premium percentage is four percent and the final premium
 4 percentage is six and three-tenths percent;

5 (4) For individuals with household income from two hundred up to two hundred fifty
 6 percent of the federal poverty level the initial premium percentage is six and three-tenths percent and
 7 the final premium percentage is eight and five hundredths percent;

8 (5) For individuals with household income from two hundred fifty up to three hundred
 9 percent of the federal poverty level the initial premium percentage is eight and five hundredths
 10 percent and the final premium percentage is nine and one-half percent;

11 (6) For individuals with household income from three hundred up to four hundred percent of
 12 the federal poverty level the initial premium percentage is nine and one-half percent and the final
 13 premium percentage is nine and one-half percent.

14 3. The department of social services shall study the expansion of a presumptive eligibility
 15 process for children for medical assistance benefits.

16 208.659. 1. The MO HealthNet division shall revise the eligibility requirements for the
 17 uninsured women's health program, as established in 13 CSR Section 70-4.090, to include women
 18 who are at least eighteen years of age and with a net family income of at or below one hundred
 19 eighty-five percent of the federal poverty level. In order to be eligible for such program, the
 20 applicant shall not have assets in excess of two hundred [and] fifty thousand dollars, nor shall the
 21 applicant have access to employer-sponsored health insurance. Such change in eligibility
 22 requirements shall not result in any change in services provided under the program.

38 2. For an unborn child to be enrolled in the show-me healthy babies program, his or her

4 through appropriations. In calculating family size as it relates to income eligibility, the family shall

6 3. Coverage for an unborn child enrolled in the show-me healthy babies program shall
7 include all prenatal care and pregnancy-related services that benefit the health of the unborn child
8 and that promote healthy labor, delivery, and birth. Coverage need not include services that are
9 solely for the benefit of the pregnant mother, that are unrelated to maintaining or promoting a
10 healthy pregnancy, or that provide no benefit to the unborn child. However, the department may
11 include pregnancy-related assistance as defined in 42 U.S.C. Section 1397II.

12 4. There shall be no waiting period before an unborn child may be enrolled in the show-me
13 healthy babies program. In accordance with the definition of child in 42 CFR 457.10, coverage shall
14 include the period from conception to birth. The department shall develop a presumptive eligibility
15 procedure for enrolling an unborn child, which shall include verification of the pregnancy.

16 5. Coverage for the child shall continue for up to one year after birth, unless otherwise
17 prohibited by law or limited by the general assembly through appropriations.

18 6. Pregnancy-related and postpartum coverage for the mother shall begin on the day the
19 pregnancy ends and extend through the last day of the month that includes the sixtieth day after the
20 pregnancy ends, unless otherwise prohibited by law or limited by the general assembly through
21 appropriations. The department may include pregnancy-related assistance as defined in 42 U.S.C.
22 1397II.

23 7. The department may provide coverage for an unborn child enrolled in the show-me
24 healthy babies program through:

25 (1) Direct coverage whereby the state pays health care providers directly, by contracting with
26 a managed care organization or with a group or individual health insurance provider;

27 (2) A premium assistance program whereby the state assists in payment of the premiums,
28 co-payments, coinsurance, or deductibles for a person who is eligible for health coverage through an

36 (a) Are lower program costs without sacrificing health care coverage for the unborn child or
37 the child up to one year after birth;

38 (b) Are greater covered services for the unborn child or the child up to one year after birth;

39 (c) Is also coverage for siblings or other family members, including the unborn child's
40 mother, such as by providing pregnancy-related assistance under 42 U.S.C. 1397II, relating to
41 coverage of targeted low-income pregnant women through the children's health insurance program

1 (CHIP); or

2 (d) Will be an ability for the child to transition more easily to non-government or less
 3 government-subsidized group or individual health insurance coverage after the child is no longer
 4 enrolled in the show-me healthy babies program.

5 8. The department shall provide information about the show-me healthy babies program to
 6 maternity homes as defined in section 135.600, pregnancy resource centers as defined in section
 7 135.630, and other similar agencies and programs in the state that assist unborn children and their
 8 mothers. The department shall consider allowing such agencies and programs to assist in the
 9 enrollment of unborn children in the program and in making determinations about presumptive
 10 eligibility and verification of the pregnancy.

11 9. Within sixty days after the effective date of this section, the department shall submit a
 12 state plan amendment or seek any necessary waivers from the federal Department of Health and
 13 Human Services requesting approval for the show-me healthy babies program.

14 10. At least annually, the department shall prepare and submit a report to the governor, the
 15 speaker of the house of representatives, and the president pro tempore of the senate analyzing and
 16 projecting the cost savings and benefits, if any, to the state, counties, local communities, school
 17 districts, law enforcement agencies, correctional centers, health care providers, employers, other
 18 public and private entities, and persons by enrolling unborn children in the show-me healthy babies
 19 program. The analysis and projection of cost savings and benefits, if any, may include, but need not
 20 be limited to:

 29 other barriers, and any resulting or projected decrease in health problems and other problems for
 30 unborn children and women throughout pregnancy; at labor, delivery, and birth; and during infancy
 31 and childhood;

32 (4) The change in healthy behaviors by pregnant women, such as the cessation of the use of
 33 tobacco, alcohol, illicit drugs, or other harmful practices, and any resulting or projected short-term
 34 and long-term decrease in birth defects; poor motor skills; vision, speech, and hearing problems;
 35 breathing and respiratory problems; feeding and digestive problems; and other physical, mental,
 36 educational, and behavioral problems; and

37 (5) The change in infant and maternal mortality, pre-term births and low birth weight babies,
 38 and any resulting or projected decrease in short-term and long-term medical and other interventions.

39 11. The show-me healthy babies program shall not be deemed an entitlement program, but
 40 instead shall be subject to a federal allotment or other federal appropriations and matching state
 41 appropriations.

12. Nothing in this section shall be construed as obligating the state to continue the show-me healthy babies program if the allotment or payments from the federal government end, are not sufficient for the program to operate, or if the general assembly does not appropriate funds for the program.

13. Nothing in this section shall be construed as expanding MO HealthNet or fulfilling a mandate imposed by the federal government on the state.

208.790. 1. The applicant shall have or intend to have a fixed place of residence in Missouri, with the present intent of maintaining a permanent home in Missouri for the indefinite future. The burden of establishing proof of residence within this state is on the applicant. The requirement also applies to persons residing in long-term care facilities located in the state of Missouri.

2. The department shall promulgate rules outlining standards for documenting proof of residence in Missouri. Documents used to show proof of residence shall include the applicant's name and address in the state of Missouri.

3. Applicant household income limits for eligibility shall be subject to appropriations, but in no event shall applicants have household income that is greater than one hundred eighty-five percent of the federal poverty level for the applicable family size for the applicable year as converted to the MAGI equivalent net income standard.

4. The department shall promulgate rules outlining standards for documenting proof of household income.

16 use or behaviors that lead to obesity and for those individuals who utilize the health home program in
17 subsection 11 of this section.

18 13. The department or appropriate divisions of the department shall promulgate rules to
19 implement the provisions of this section. Any rule or portion of a rule, as the term is defined in
20 section 536.010, that is created under the authority delegated in this section shall become effective
21 only if it complies with and is subject to all of the provisions of chapter 536 and, if applicable,
22 section 536.028. This section and chapter 536 are nonseverable and if any of the powers vested with
23 the general assembly pursuant to chapter 536 to review, to delay the effective date or to disapprove
24 and annul a rule are subsequently held unconstitutional, then the grant of rulemaking authority and

26 [4.] 14. The department shall submit such state plan amendments and waivers to the Centers
27 for Medicare and Medicaid Services of the federal Department of Health and Human Services as the

29 shall request of the federal government an enhanced federal funding rate for persons newly eligible
30 under subsection 4 of this section whereby the federal government agrees to pay the percentages

208.997. 1. The MO HealthNet division shall develop and implement the "Health Care Homes Program" as a provider-directed care coordination program for MO HealthNet recipients who are not enrolled in a prepaid MO HealthNet benefits option and who are receiving services on a fee-for-service basis or are otherwise identified by the department. The health care homes program shall provide payment to primary care clinics, community mental health centers, and other appropriate providers for care coordination for individuals who are deemed medically frail. Clinics shall meet certain criteria including, but not limited to, the following:

- (1) The capacity to develop care plans;
- (2) A dedicated care coordinator;
- (3) An adequate number of clients, evaluation mechanisms, and quality improvement processes to qualify for reimbursement; and
- (4) The capability to maintain and use a disease registry.

2. For purposes of this section, "primary care clinic" means a medical clinic designated as the patient's first point of contact for medical care, available twenty-four hours a day, seven days a week, that provides or arranges the patient's comprehensive health care needs and provides overall integration, coordination, and continuity over time and referrals for specialty care.

3. The department may designate that the health care homes program be administered through an organization with a statewide primary care presence, experience with Medicaid population health management, and an established health care homes outcomes monitoring and improvement system.

4. This section shall be implemented in such a way that it does not conflict with federal requirements for health care home participation by MO HealthNet participants.

5. The department or appropriate divisions of the department may promulgate rules to implement the provisions of this section. Any rule or portion of a rule, as that term is defined in section 536.010, that is created under the authority delegated in this section shall become effective only if it complies with and is subject to all of the provisions of chapter 536 and, if applicable, section 536.028. This section and chapter 536 are nonseverable and if any of the powers vested with the general assembly under chapter 536 to review, to delay the effective date, or to disapprove and annul a rule are subsequently held unconstitutional, then the grant of rulemaking authority and any rule proposed or adopted after August 28, 2014, shall be invalid and void.

6. Nothing in this section shall be construed to limit the department's ability to create health care homes for participants in a managed care plan.

208.998. 1. Except for individuals who meet the definition of medically frail, individuals who qualify for coverage under subsections 2 and 4 of section 208.991 shall receive covered services through health plans offered by managed care entities which are authorized by the department. Health plans authorized by the department:

1 (1) Shall resemble commercially available health plans while complying with federal
 2 Medicaid requirements as authorized by federal law or through a federal waiver and may include
 3 risk-bearing accountable care organizations which provide covered services to individuals who
 4 qualify for coverage under subsection 4 of section 208.991 and managed care organizations paid on a
 5 capitated basis which provide covered services to individuals who qualify for coverage under
 6 subsections 2 and 4 of section 208.991;

7 (2) Shall promote, to the greatest extent possible, the opportunity for children and their
 8 parents to be covered under the same plan;

9 (3) Shall offer plans statewide;

10 (4) Shall include cost sharing for outpatient services to the maximum extent allowed by
 11 federal law;

12 (5) May include other co-payments and provide incentives that encourage and reward the
 13 prudent use of the health benefit provided;

14 (6) Shall encourage access to care through provider rates that include pay-for-performance
 15 and are comparable to commercial rates. The department of social services shall determine
 16 pay-for-performance provisions that managed care organizations shall execute and shall provide
 17 incentives for managed care organizations that perform well;

18 (7) Shall provide incentives, including shared risk and savings, to health plans and providers
 19 to encourage cost-effective delivery of care;

20 (8) Shall provide incentive programs for participants to encourage healthy behaviors and

28 2. The department may designate that certain health care services be excluded from such

14 (6) As soon as practicable, the establishment and maintenance of a record-keeping system
15 for each health care visit or service received by recipients under this subsection. The plan shall
16 require that the recipient's prepaid card number be entered or electronic strip be swiped by the health
17 care provider for purposes of maintaining a record of every health care visit or service received by
18 the recipient from such provider, regardless of any balance on the recipient's card. Such information
19 shall include only the date, provider name, and general description of the visit or service provided.
20 The plan shall maintain a complete history of all health care visits and services for which the
21 recipient's prepaid card is entered or swiped in accordance with this subdivision. If required under
22 the federal Health Insurance Portability and Accountability Act (HIPAA) or other relevant state or
23 federal law or regulation, a recipient shall, as a condition of participation in the prepaid card
24 incentive, be required to provide a written waiver for disclosure of any information required under

26 (7) The determination of a proportion of the amount left in a participant's account described

28 for saving taxpayer money. The amount and method of payment shall be determined by the

The department of social services shall develop regional care coordination models among networks of health care providers to meet the needs of and reduce the costs incurred by MO HealthNet beneficiaries who frequently or inefficiently utilize emergency department services. The objectives of such models shall include, but not be limited to:

- (1) Reducing emergency department utilization;
- (2) Reducing unnecessary utilization of diagnostic services, pharmacy costs, inpatient encounters, and admissions;
- (3) Increasing quality and coordination of care through leveraging community resources and care management;
- (4) Improving the patient experience and quality of care; and
- (5) Achieving net savings of ten to thirteen percent over a three-year period for MO HealthNet participants.

2. The regional care coordination models shall require the development of an algorithm that uses analytical approaches to identify prospective participants who have a history of presenting in an emergency department for care on at least ten occasions over a twelve-month period. Prospective participants also shall be screened based on claims and other available data to predict the likely value of intense care coordination to reduce costs and improve care. The regional care coordination models shall incorporate the following strategies:

- (1) Utilization of a multi-disciplinary, team-based approach that adapts health care and community resources to the participant's individual needs;
- (2) Utilization of resources and sharing of information among the care management team to develop a comprehensive care management program based on social, clinical, and behavioral

1 assessments. The care management team shall include medical direction from a physician supported
2 by additional health care professionals and community resources as necessary; and

3 (3) Creation of a sustainable program in coordination with the regional networks of health
4 care providers whereby the department measures and tracks baseline expenditures on a per-member,
5 per-month basis for the target population. The department shall develop a shared savings funding
6 model that may be adapted to a wider array of health payment models.

7 3. The department also shall develop additional innovative programs that seek to address the
8 cost and quality of care for individuals who disproportionately utilize emergency departments for
9 care. Health care providers participating in the regional care coordination models shall be
10 encouraged to include uninsured individuals who frequently utilize the emergency department for
11 care in this program to the greatest extent possible."; and
