FISCAL ANALYSIS

ASSUMPTION

Officials from the **Office of the Secretary of State (SOS)** assume many bills considered by the General Assembly include provisions allowing or requiring agencies to submit rules and regulations to implement the act. The SOS is provided with core funding to handle a certain amount of normal activity resulting from each year's legislative session. The fiscal impact for this fiscal note to the Secretary of State's Office for Administrative Rules is less than \$2,500. The SOS recognizes that this is a small amount and does not expect that additional funding would be required to meet these costs. However, we also recognize that many such bills may be passed by the General Assembly in a given year and that collectively the costs may be in excess of what our office can sustain with our core budget. Therefore, we reserve the right to request funding for the cost of supporting administrative rules requirements should the need arise based on a review of the finally approved bills signed by the governor.

Officials from the **Joint Committee on Administrative Rules** assume this proposal would not have a fiscal impact to their organization in excess of existing resources.

Officials from the Office of Administration - Division of Personnel, the Department of Conservation, the Department of Labor and Industrial Relations, the Department of Transportation, Lincoln University, Linn State Technical College, Missouri Southern Sate University, Missouri State University, Missouri Western Sate University, Northwest Missouri State University, the University of Central Missouri, the City of Columbia, the City of Kansas City, and the Francis Howell School District assume the proposal would have no fiscal impact on their organizations.
