FISCAL ANALYSIS

ASSUMPTION

Officials from the **Office of the Secretary of State (SOS)** assume many bills considered by the General Assembly include provisions allowing or requiring agencies to submit rules and regulations to implement the act. The SOS is provided with core funding to handle a certain amount of normal activity resulting from each year's legislative session. The fiscal impact for this fiscal note to the Secretary of State's Office for Administrative Rules is less than \$2,500. The SOS recognizes that this is a small amount and does not expect that additional funding would be required to meet these costs. However, we also recognize that many such bills may be passed by the General Assembly in a given year and that collectively the costs may be in excess of what our office can sustain with our core budget. Therefore, we reserve the right to request funding for the cost of supporting administrative rules requirements should the need arise based on a review of the finally approved bills signed by the governor.

Officials from the **Joint Committee on Administrative Rules** assume this proposal would not have a fiscal impact to their organization in excess of existing resources.

Officials from the **Department of Labor and Industrial Relations (DOLIR)** assume this proposal would implement a complaint system that would be administered by DOLIR. Upon receipt of a complaint, DOLIR would be required to conduct an investigation and issue findings as a result of the investigation. In addition, DOLIR would be required to hold a hearing to determine if a violation has occurred if the situation so warrants. DOLIR officials assume the complaint procedure, investigation requirement, and hearing requirement could require many additional man hours, and in all probability, more personnel depending on the number of complaints filed.

DOLIR officials provided an estimate of fiscal impact of less than \$100,000 per year for this proposal.

Oversight has no information as to the number of complaints that might be received by DOLIR if this proposal is implemented nor the amount of time and other resources that would be required to investigate those complaints and conduct hearings if warranted. Oversight will include the DOLIR cost estimate in this fiscal note.
