#### FISCAL ANALYSIS

#### **ASSUMPTION**

§ 313.835 - Transfers from the Gaming Commission Fund:

Officials from the **Missouri Gaming Commission (GAM)** state there is no fiscal impact to the Gaming Commission or to the Gaming Fund (0286). The legislation does not affect the total dollar amounts transferred to Access Missouri, the Missouri Veterans Commission and the National Guard but does affect the timing or cash flow of transfers to these agencies.

Officials from the **Office of Administration - Division of Budget and Planning (BAP)** state the proposed legislation should not result in additional costs or savings to BAP.

BAP assumes this proposal will not affect Total State Revenue or the 18e calculation, but will modify the scheduling of the transfers made by the Gaming Commission Fund. BAP defers to the Department of Higher Education, the Adjutant General, and the Missouri Veterans' Commission for a specific estimate on the impact to their funds.

In response to similar legislation from 2014 (SB 505), officials from the **Missouri Veterans Commission (VET)** state this proposal could interfere with VET's ability to meet certain obligations, including the ability to meet payroll.

**Oversight** states the Veterans' Commission Capital Improvement Trust Fund (0304) is used solely, upon appropriation, by VET for the construction, maintenance, or renovation of veterans' homes and cemeteries within the state.

**Oversight** assumes fund balances within the Veterans' Commission Capital Improvement Trust Fund (VCCIT) are managed to compensate for cash flow concerns throughout the course of a fiscal year. The VCCIT ended FY13 with a fund balance of \$21,644,529, transfers into the VCCIT from the Gaming Fund totaled \$30,492,690 in FY13.

**Oversight** assumes the total amount transferred each fiscal year from the Gaming Commission Fund to the Access Missouri Fund, National Guard Trust Fund, and the VCCIT would <u>not</u> be impacted by this proposal.

**Oversight** assumes this proposal would only impact the timing and frequency of transfers from the Gaming Commission Fund within a fiscal year.

In response to similar legislation from 2014 (SB 505), officials from the **Department of Higher Education** and the **Department of Public Safety - Office of the Adjutant General** each assume the proposal would not fiscally impact their respective agencies.
