FISCAL ANALYSIS

ASSUMPTION

Officials from the **Department of Social Services - Family Support Division (FSD)** state:

Section 205.1000

The Food and Nutrition Act of 2008 defines eligible food as any food or food product for home consumption, which includes some energy drinks. Energy drinks that contain a manufacturer's product label considered a nutrition facts label by the Food and Drug Administration (FDA) are eligible foods and are an allowable Supplemental Nutrition Assistance Program (SNAP) benefits purchase.

Energy drinks that have a manufacturer's supplement facts label are classified by the FDA as supplements and are, therefore, not eligible for purchase with SNAP benefits.

States cannot restrict the purchase of food items if federal regulations and the Food and Nutrition Act of 2008 have those items listed as eligible food. The FSD would request a waiver from the U.S. Department of Agriculture (USDA) as required by this section. There is no cost associated with requesting a waiver. However, the FSD anticipates that such a waiver would not be approved by the USDA.
