#### FISCAL ANALYSIS

#### **ASSUMPTION**

For the purpose of this proposed legislation, and as a result of excessive caseloads, the **Office of State Public Defender (SPD)** cannot assume existing staff will provide competent, effective representation for any new cases where indigent persons are charged with the proposed new crime of publishing a booking photograph which violates the provisions of RSMo 578.800.

While the number of new cases may be too few or uncertain to request additional funding for this specific bill, the SPD will continue to request sufficient appropriations to provide competent and effective representation in all cases where the right to counsel attaches.

**Oversight** assumes the SPD can absorb the additional caseload that may result from this proposal.

Officials at the **Office of the State Courts Administrator (CTS)** assume this proposal would not be in excess of \$100,000.

**Oversight** assumes that any costs from CTS relating to this proposal could be absorbed within their current appropriation level.

Officials at the **Office of Prosecution Services** and the **Department of Public Safety - Missouri Highway Patrol** each assume no fiscal impact to their respective agencies from this proposal.

Officials at the **Columbia Police Department** and the **Springfield Police Department** each assume no fiscal impact to their respective organizations from this proposal.

Officials from the Boone County Sheriff Department, Buchanan County Sheriff's Department, Clark County Sheriff's Department, Cole County Sheriff Department, Independence Police Department, Jackson County Sheriff Department, Jefferson City Police Department, Platte County Sheriff's Department, St. Charles Police Department, St. Joseph Police Department, St. Louis County Police Department and the St. Louis Metropolitan Police Department did not respond to **Oversight's** request for fiscal impact.
