FISCAL ANALYSIS

ASSUMPTION

Officials at the **City of Columbia** assume they would have additional costs between \$2,000 and \$3,000 from this proposal. The City has a camera-enforced traffic program, with signs in advance of the enforced intersections. Although they would argue that their signs are already at the intersections, some might say that additional signs are needed at the intersections.

Oversight assumes that the City of Columbia already has the signs and no additional signs would be needed from this proposal. This proposal is permissive and the jurisdiction can choose to have cameras or not. The cost of the signs would be a one-time expense and Oversight assumes there would be no impact from this proposal.

Officials at the **Missouri Department of Transportation** assume no fiscal impact from this proposal.

Officials at the **City of Jefferson** and the **City of Kansas City** each assume no fiscal impact to their respective organizations from this proposal.
