ASSUMPTION

Officials from the **Department of Public Safety - State Emergency Management Agency (SEMA)** state there is potential that their agency could be requested to assist with costs. SEMA assumes the fiscal impact would be under \$100,000.

Officials from the **Department of Public Safety - Missouri Highway Patrol** assume the proposal would not fiscally impact their agency.

Oversight assumes SEMA will be able to absorb any additional duties or expenditures resulting from this proposal within current appropriations.

FISCAL DESCRIPTION


The proposed legislation appears to have no direct fiscal impact.
