#### FISCAL ANALYSIS

## ASSUMPTION

Officials from the **Department of Elementary and Secondary Education** assume no direct fiscal impact to their agency and defer to local school districts regarding fiscal impact of this proposed legislation.

Officials from the **Department of Social Services - Children's Division** assume this bill removes language in §160.261, starting at subsection 10 to subsection 22. These are provisions in current statute that prohibit the Children's Division from having jurisdiction to investigate reports of alleged child abuse arising out of or related to the use of reasonable force to protect persons or property when administered by personnel of a school district or any spanking administered in a reasonable manner by any certificated school personnel in the presence of a witness who is an employee of the school district as long as no allegation of sexual misconduct arises from the spanking or use of force.

From calendar years 2008 to 2012, the Children's Division averaged 71 reports a year in which the finding was entered as a result of an investigation by a school board. In 2013, the Children's Division received 78 reports in which the finding was entered as a result of an investigation by a school board. This bill would require the Children's Division to conduct at least 71 additional investigations per year. Investigators can do 12 hotlines a month and 144 per year. Although there would be a slight increase in investigations as a result of this legislation, the fiscal impact could be absorbed by current staff.

The Children's Division does not anticipate a fiscal or programmatic impact as a result of this bill.

Officials from the **Special School District of St. Louis County (SSD)** assume this proposed bill would likely have a slight positive impact on SSD as it appears to shift more responsibility for child abuse investigations back to the Children's Division of the Department of Social Services.

Officials from the Fulton School District assume no significant fiscal impact to their district.

Officials from the **Johnson County R-VII** assume a range of impact could be no impact to \$100,000 depending on the specific situation.

**Oversight** assumes impact would not be direct and for fiscal note purposes only, will assign no fiscal impact to local school districts.
