FISCAL ANALYSIS

ASSUMPTION

Officials from the **Department of Public Safety - Missouri Highway Patrol (MHP)** state this bill would require any person or company that rents or sells vessels to issue a temporary boating safety identification card to an individual in order to operate a rented vessel or vessel being considered for sale for a period up to seven days. The cost to purchase a permit is \$9.

It is unknown how many permits will be sold. For purposes of this fiscal note, the Patrol estimates that 1,800 permits will be issued throughout a year ($\$9 \times 1,800 = \$16,200$). Since the option for payment is by credit or debit card, the Patrol will have to pay \$1 to a collection service for every card transaction ($\$1 \times 1,800 = \$1,800$).

The MHP assumes a net annual fiscal impact to the Water Patrol Fund of \$14,400.

Oversight will assume that these 1,800 permitees would not have otherwise obtained a regular (non-temporary) boater certification card for \$15.00. Oversight will utilize MHP's estimates, but will assume 10 months of impact in FY 2015.

This proposal could increase Total State Revenues.

Currently, nonresidents can receive a one time temporary boating safety identification card to operate a rented vessel or a vessel being considered for sale. This proposal expands this opportunity for a temporary boating safety identification card to Missouri residents.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
