FISCAL ANALYSIS

ASSUMPTION

Officials from the **Department of Social Services (DSS) - Children's Division (CD)** state this substitute would not fiscally impact the CD. The changes in this substitute in sections 210.117.4 and 211.038.4 changed the fingerprint requirement from "shall" to "may in both sections and now allows the CD to obtain criminal history information by means other than fingerprinting; this change eliminated the fiscal impact for the CD.

Officials from the **DSS - Division of Legal Services** assume this proposal will not result in a fiscal impact to their organization.

Officials from the **Office of the Secretary of State (SOS)** state many bills considered by the General Assembly include provisions allowing or requiring agencies to submit rules and regulations to implement the act. The SOS is provided with core funding to handle a certain amount of normal activity resulting from each year's legislative session. The fiscal impact for this fiscal note to the SOS for Administrative Rules is less than \$2,500. The SOS recognizes that this is a small amount and does not expect that additional funding would be required to meet these costs. However, the SOS also recognizes that many such bills may be passed by the General Assembly in a given year and that collectively the costs may be in excess of what the office can sustain with the core budget. Therefore, the SOS reserves the right to request funding for the cost of supporting administrative rules requirements should the need arise based on a review of the finally approved bills signed by the governor.

Oversight assumes the SOS could absorb the costs of printing and distributing regulations related to this proposal. If multiple bills pass which require the printing and distribution of regulations at substantial costs, the SOS could request funding through the appropriation process.

Officials at the Joint Committee on Administrative Rules, the Department of Public Safety - Missouri Highway Patrol and Office of State Courts Administrator each assume there is no fiscal impact to their respective agencies from this proposal.
