ASSUMPTION

§§ 537.345, and 537.348 - Property Owner Liability:

Officials at the **Department of Natural Resources**, the **Office of the State Public Defender**, the **Office of Prosecution Services**, the **Department of Agriculture**, the **Office of the State Courts Administrator** and the **Department of Conservation** each assume no fiscal impact to their respective agencies from this proposal.

Officials at the **City of Columbia**, the **City of Jefferson**, **St. Louis County**, the **City of Kansas City** and the **St. Louis County Board of Election Commission** each assume no fiscal impact to their respective organizations from this proposal.

In response to similar legislation, HB 1209, officials at the **Office of the Attorney General** assumed that any potential costs arising from this proposal can be absorbed with existing resources.


FISCAL DESCRIPTION
