**AN ACT**

To appropriate money for purposes for the several departments and offices of state government; for planning and capital improvements including but not limited to major additions and renovations, new structures, and land improvements or acquisitions, from the funds herein designated for the fiscal period beginning July 1, 2014 and ending June 30, 2015.

---

*Be it enacted by the General Assembly of the state of Missouri, as follows:*

There is appropriated out of the State Treasury, for the agency, program, and purpose  
2 stated, chargeable to the fund designated for the period beginning July 1, 2014 and ending June  
3 30, 2015, as follows:

Section 21.005. To the Office of Administration

2 For the purchase of voting machines for county clerk operations  
3 From Surplus Revenue Fund. . . . . \$7,500,000

Section 21.015. To the Department of Elementary and Secondary Education

2 For construction of a recreation area at the Verelle Peniston State School  
3 for the Severely Disabled  
4 From General Revenue Fund. . . . . \$25,000

Section 21.020. To the University of Missouri

2 For planning, design, renovation, and construction of a Free Enterprise  
3 Center on the Kansas City campus, local matching funds must  
4 be provided on a 50/50 state/local match rate in order to be  
5 eligible for state funds pursuant to Section 173.480, RSMo  
6 From General Revenue Fund. . . . . \$7,400,000

## Section 21.025. To the University of Missouri

- 2 For planning, design, renovation, and construction of the College of  
3 Business Administration Building on the St. Louis campus, local  
4 matching funds must be provided on a 50/50 state/local match rate  
5 in order to be eligible for state funds pursuant to Section 173.480,  
6 RSMo  
7 From General Revenue Fund. . . . . \$10,000,000

## Section 21.035. To the University of Missouri

- 2 For planning, design, renovation, and construction of an experimental  
3 mines building on the Rolla campus, local matching funds must be  
4 provided on a 50/50 state/local match rate in order to be eligible  
5 for state funds pursuant to Section 173.480, RSMo  
6 From General Revenue Fund. . . . . \$1,200,000

## Section 21.040. To the University of Missouri

- 2 For planning, design, renovation, and construction of an applied learning  
3 center on the Columbia campus, local matching funds must be  
4 provided on a 50/50 state/local match rate in order to be eligible  
5 for state funds pursuant to Section 173.480, RSMo  
6 From General Revenue Fund. . . . . \$10,000,000

## Section 21.045. To the University of Missouri

- 2 For planning, design, renovation, and construction of fine and performing  
3 arts facilities on the Columbia campus, local matching funds must  
4 be provided on a 50/50 state/local match rate in order to be eligible  
5 for state funds pursuant to Section 173.480, RSMo  
6 From Higher Education Capital Fund. . . . . \$2,766,000

## Section 21.050. To the University of Missouri

- 2 For planning, design, renovation, and construction of a teaching and  
3 research winery addition on the Columbia campus, local matching  
4 funds must be provided on a 50/50 state/local match rate in order  
5 to be eligible for state funds pursuant to Section 173.480, RSMo  
6 From Higher Education Capital Fund. . . . . \$1,500,000

## Section 21.055. To Harris-Stowe State University

- 2 For planning, design, renovation, and construction of the Vashon Center,  
3 local matching funds must be provided on a 50/50 state/local  
4 match rate in order to be eligible for state funds pursuant to  
5 Section 173.480, RSMo  
6 From Higher Education Capital Fund. . . . . \$1,000,000

## Section 21.060. To Lincoln University

- 2 For planning, design, renovation, and construction of a campus recreation  
3 center, local matching funds must be provided on a 50/50  
4 state/local match rate in order to be eligible for state funds  
5 pursuant to Section 173.480, RSMo  
6 From Higher Education Capital Fund. . . . . \$2,800,000

## Section 21.062. To Missouri Southern State University

- 2 For planning, design, renovation, and construction of science laboratories  
3 in Reynold's Hall, local matching funds must be provided on a 50/50  
4 state/local match rate in order to be eligible for state funds pursuant  
5 to Section 173.480, RSMo  
6 From General Revenue Fund. . . . . \$1,500,000

## Section 21.065. To Missouri State University

- 2 For planning, design, renovation, and construction of an admissions  
3 center, local matching funds must be provided on a 50/50  
4 state/local match rate in order to be eligible for state funds  
5 pursuant to Section 173.480, RSMo  
6 From General Revenue Fund. . . . . \$2,250,000

## Section 21.070. To Northwest Missouri State University

- 2 For planning, design, renovation, and construction of an agriculture  
3 learning center, local matching funds must be provided on a 50/50  
4 state/local match rate in order to be eligible for state funds  
5 pursuant to Section 173.480, RSMo  
6 From General Revenue Fund. . . . . \$250,000

## Section 21.075. To Southeast Missouri State University

- 2 For planning, design, renovation, and construction at Memorial Hall, local  
 3 matching funds must be provided on a 50/50 state/local match rate  
 4 in order to be eligible for state funds pursuant to Section 173.480,  
 5 RSMo  
 6 From General Revenue Fund. . . . . \$2,000,000

## Section 21.085. To the Coordinating Board for Higher Education

- 2 For planning, design, renovation, and construction of student success  
 3 centers at Metropolitan Community College, local matching funds  
 4 must be provided on a 50/50 state/local match rate in order to be  
 5 eligible for state funds pursuant to Section 173.480, RSMo  
 6 From Higher Education Capital Fund. . . . . \$2,000,000

## Section 21.090. To the Coordinating Board for Higher Education

- 2 For planning, design, renovation, and construction of an automotive and  
 3 metal technology center at State Fair Community College, local  
 4 matching funds must be provided on a 50/50 state/local match rate  
 5 in order to be eligible for state funds pursuant to Section 173.480,  
 6 RSMo  
 7 From Higher Education Capital Fund. . . . . \$4,175,000

## Section 21.095. To the Coordinating Board for Higher Education

- 2 For planning, design, renovation, and construction of the corridors and  
 3 common space at the Cassville campus of Crowder College, local  
 4 matching funds must be provided on a 50/50 state/local match rate  
 5 in order to be eligible for state funds pursuant to Section 173.480,  
 6 RSMo  
 7 From Higher Education Capital Fund. . . . . \$375,000

## Section 21.097. To the Coordinating Board for Higher Education

- 2 For planning, design, renovation, and construction of the Hickey building  
 3 on the Webb City campus of Crowder College, local matching  
 4 funds must be provided on a 50/50 state/local match rate in order  
 5 to be eligible for state funds pursuant to Section 173.480, RSMo  
 6 From General Revenue Fund. . . . . \$375,000

## Section 21.100. To the Coordinating Board for Higher Education

- 2 For planning, design, renovation, and construction of an eastern campus  
 3 for Three Rivers Community College, local matching funds must  
 4 be provided on a 50/50 state/local match rate in order to be eligible  
 5 for state funds pursuant to Section 173.480, RSMo  
 6 From Higher Education Capital Fund. . . . . \$5,666,046

## Section 21.105. To the Coordinating Board for Higher Education

- 2 For planning, design, renovation, and construction of Geyer Hall at North  
 3 Central Missouri College, local matching funds must be provided  
 4 on a 50/50 state/local match rate in order to be eligible for state  
 5 funds pursuant to Section 173.480, RSMo  
 6 From General Revenue Fund. . . . . \$1,400,000

Section 21.110. Funds are to be transferred out of the State Treasury,  
 2 chargeable to the Surplus Revenue Fund, to the Higher Education  
 3 Capital Fund

- 4 From Surplus Revenue Fund. . . . . \$20,282,046

## Section 21.115. To the Office of Administration

- 2 For the Division of Accounting  
 3 For payment of principal, interest, bond issuance costs, and reserve  
 4 fund requirements of Board of Public Buildings Bonds  
 5 From General Revenue Fund . . . . . \$10,110,000

## Section 21.120. To the Department of Transportation

- 2 For planning, design, and construction of a passenger rail station in  
 3 proximity to a business incubator in St. Louis  
 4 From Board of Public Buildings Bond Proceeds Fund . . . . . \$11,000,000

## Section 21.125. To the University of Missouri

- 2 For planning, design, and construction of a business incubator in St.  
 3 Louis  
 4 From Board of Public Buildings Bond Proceeds Fund . . . . . \$8,000,000

## Section 21.130. To the University of Missouri

- 2 For planning, design, and construction of strategic renovations and
- 3 additions to Lafferre Hall
- 4 From Board of Public Buildings Bond Proceeds Fund . . . . . \$38,500,000

## Section 21.135. To the University of Missouri

- 2 For planning, design, and construction of the State Historical Society
- 3 Building and Museum
- 4 From Board of Public Buildings Bond Proceeds Fund . . . . . \$25,000,000

## Section 21.140. To the University of Missouri

- 2 For planning, design, and construction of a new medical school on the
- 3 Kansas City campus
- 4 From Board of Public Buildings Bond Proceeds Fund . . . . . \$19,000,000

## Section 21.145. To Missouri State University

- 2 For planning, design, and construction of the Ozarks Health and Life
- 3 Science Center
- 4 From Board of Public Buildings Bond Proceeds Fund . . . . . \$40,000,000

## Section 21.150. To the Office of Administration

- 2 For the State Highway Patrol
- 3 For replacement of the Troop F garage
- 4 From General Revenue Fund. . . . . \$390,000
- 5 From Gaming Commission Fund.. . . . 405,000
- 6 From State Highways and Transportation Department Fund. . . . . 3,735,000
- 7 Total. . . . . \$4,530,000

## Section 21.155. To the Department of Natural Resources

- 2 For surface water improvements and construction of a water reservoir
- 3 in a county of the third classification with a township form of
- 4 government and with more than nine thousand but fewer than
- 5 ten thousand inhabitants and with a city of the fourth
- 6 classification with more than three hundred but fewer than four
- 7 hundred inhabitants as the county seat
- 8 From General Revenue Fund. . . . . \$200,000
